Mr. William Vargo spoke on the general obligation bonds and questioned where the balance of the yearly payment be acquired. He requested that we only spend \$3 million.

Ms. Jennifer Ray spoke against the general obligation bonds stating she did not vote for them. She said the bonds are not necessary and that Putnam County should be conservative with its funds.

6. Authorization for Chairman to sign the Resolution to issue General Obligation Bonds (item from April 5, 2024 Agenda)

County Attorney Nelson stated that the resolution certifies the results of the election. It does not make any decision about money amounts; it only certifies that the bonds can be validated in superior court.

Commissioner Hersey questioned the purpose for tonight's meeting since the item in question was presented at the April 5 meeting and motions were made and defeated. He also questioned the wording in the referendum versus the wording in the resolution. Commissioner Hersey also voiced concern about paying the debt, stating he had not seen anything in writing.

Commissioner Brown made a request to end the discussion.

Chairman Sharp said the resolution is meant to ratify what the voters have said, and that Commissioner Hersey's comments are not relevant to the matter at hand and stated that he could not allow Commissioner Hersey to continue speaking and recognized Commissioner Brown to allow him to make a motion to end the debate.
