NOVEMBER 12, 2024

Administrative

- Need to transfer funds from People's account to a new account at Farmer's & Merchants Bank and set up CD with 50% of funds available.
- Audit process is beginning for BOE, County and PDA and information is being requested for the report.
- Will provide updated report for members who need to update their required training for the DCA.

Business & Industry Company Contacts

- Business Retention & Expansion (BREP) Survey:
 - Trying to wrap this up sooner rather than later.
- Business Expansion:
 - Local company will be expanding and plan to be up and running with new line by mid-year 2025.
 Expansion will consist of 50 net new hires and a \$3.5MM investment in new equipment and improvements to the existing facility.

Workforce Development

- Putnam College & Career Academy:
 - Career Academy has received their certification from the state of Georgia.
- MGEA:
 - Attended monthly meeting on November 8 to discuss the newly created Middle Georgia Innovation Corridor
 presentation by Dr. Joe Richardson. Middle Georgia has received funding from the USDOL through Georgia Tech
 to set up this initiative. Program is designed to enhance AI and robotics opportunities within the region.



Marketing & Branding

- Office:
 - Working on finalizing sign to be set on the exterior of the building.
 - Getting community maps updated to be mounted inside that show locations of the community in reference to Atlanta, Savannah, etc.

Project Status

Project Activity:

- Working with attorneys to finalize PSA with ER Snell for 10 acres at SIP site.
- Should have final update from chemical company by the end of the month/early next month on test runs at Asian facility for them to commit to expansion at SIP site. From what I've been told, everything is going according to plan.

Rock Eagle Technology Park

- Miscellaneous:
 - Interest has been shown in purchasing land at the Tech Park. Working through representatives with our partners on the land.

South Industrial Park

Property Overview:

- When the road was constructed at the SIP site, the road was never presented to City Council to be turned over, so the road is still a PDA owned and maintained road. Based on discussions with council from ER Snell, we need some resolution on how we move forward with this issue.
- Additionally, the road needs to be presented to Planning & Zoning to formalize the road name, currently the road has been designated as South Industrial Road (we have the ability to change that if the board so desires).
