Dear Honorable Putnam County Board of Commissioners:

During 2023, Environmental Health approached the Board of Health with a plan to revise all our fees gradually over a three-year period. Last year, the BOC approved a revision of our food service fees. This was generally well received, and we are appreciative of the support we received from each of you.

We have spent the last several months reviewing our Land Use and Individual Water Well fees and presented a proposed revision at the Board of Health meeting on June 5th, 2024, at 1:00 P.M. The BOH vote passed the changes in Land Use Fees and Water Well Program pending a favorable Public Comment Meeting. On June 25th, we held a Public Comment Meeting at 12:00 p.m. here at the Health Dept. With one attendee and no unfavorable comments, we bring it to you for approval and implementation.


I have enclosed a copy of the power-point presentation, a comparison of the actual cost to provide each service with the current fee and proposed fee for those services. In addition, a comparison of the revenue collected for last six months of services in calendar year 2023 vs. what would be collected with the new proposed fees for those same services.


