He advised that Putnam County has experienced two challenging years in a row and distributed an Employee Benefits Renewal booklet. He reviewed the booklet, including Claim History, Claims Performance, Loss Ratio, Claims Utilization, Cost Drivers, Renewal History, Renewal Offers, HRA Options, Other County Paid Benefits (Dental, Life, Long-Term Disability), and Voluntary Employee Paid Benefits. Mr. Shaw's recommendation was to move back to Anthem with an HRA Strategy and Wellness Plan.
