- 4. Discounted annual payment of \$ 5040.00 due May 31, 2024.

Please note that our hourly rate under the maintenance agreement for all covered services will be \$ 225 per hour, effective July 1, 2024. Should you decide not to participate in the support agreement, all maintenance and support will be billed at the prevailing hourly rate for all services rendered including travel time. The prevailing rate as of July 1, 2024 is \$ 265 per hour, subject to change without notice. You will also be responsible for all parts required for your system in the event of hardware or software failure. In addition, you will be billed for all out-of-pocket expenses that we incur in connection with your system. These costs will include, but not be limited to, supplies purchased on your behalf (with your approval), telephone support (minimum charge - 15 minutes.), and mileage expense (based on the IRS current standard rate).

Just as a reminder, all invoices are due and payable upon receipt. Finance charges of 2% per month will be applicable for all invoices unpaid at 30 days unless prior arrangements have been made.

Please remember that this agreement is in addition to any agreement that you may have currently with AccuFund, Inc. While a limited support agreement (including maintenance and enhancements) with AccuFund, Inc. is optional, please be aware that it does entitle Mountaineer Computer Systems, Inc. to receive technical support from AccuFund, Inc. on your behalf. CITY OF PETAL **ORDINANCE BOOK 4**

ORDINANCE NUMBER 2007 (3-3)

AN ORDINANCE AMENDING CERTAIN SECTIONS OF ORDINANCE 2007 (3) OF THE SUBDIVISION REGULATIONS FOR THE CITY OF PETAL, MISSISSIPPI.

BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY

OF PETAL, MISSISSIPPI:

SECTION 1: The following articles of Ordinance 2007 (3) be amended as follows:

SECTION 510.00 MINIMUM DESIGN STANDARDS FOR SANITARY SEWER

SYSTEMS

ADDITION

510.13 If the sewer system is in an area of the city not serviced by the City of Petal for water, a sewer cutoff valve approved by the City Engineer shall be installed by the developer at each individual service connection at the developer's expense.

SECTION 2. Except as hereby expressly changed and amended, the aforesaid Subdivision Regulations Ordinance No. 2007 (3), Ordinance 2007 (3-1) and Ordinance 2007 (3-2) of the City of Petal, Mississippi, shall be and remain in full force.

SECTION 3. That this Ordinance shall take effect and be in full force within thirty (30) days from and after its passage as provided by law. The foregoing Ordinance having been reduced to writing, the same was introduced and read, and a vote was taken thereon, first section by section and then upon the Ordinance as a whole with the following results:

AN ORDINANCE AMENDING CHAPTER 34, SECTION 87 OF THE CITY OF PETAL, MISSISSIPPI, CODE OF ORDINANCES ADDING THE REQUIREMENT FOR A SEWER CUTOFF VALVE ON SEWER TAPS NOT SERVICED BY CITY OF PETAL WATER

BE IT ORDAINED by the Mayor and Board of Aldermen of the City of Petal,

Mississippi:

Chapter 34, Section 87 as originally adopted on December 30, 2016 is hereby amended to read as follows.

To-wit:

Sec. 34-87:

(c) If the location of a sewer tap is an area city not serviced by the City of Petal for water; a sewer cutoff valve approved by the City Engineer shall be installed by the requester or developer at their expense.

SECTION 2. All Ordinances in conflict herewith, be, and are hereby repealed.

SECTION 3. That this ordinance shall take effect and be in force (30) days from and after its passage.
