## Proclamation

## National Police Week 2024

To recognize National Police Week 2024 and to honor the service and sacrifice of those law enforcement officers killed in the line of duty while protecting our communities and safeguarding our democracy.

WHEREAS, there are more than 800,000 law enforcement officers serving in communities across the United States, including the dedicated members of the Petal Police Department;

WHEREAS, since the first recorded death in 1786, more than 24,067 law enforcement officers in the United States have made the ultimate sacrifice and been killed in the line of duty;

WHEREAS, the names of these dedicated public servants are engraved on the walls of the National Law Enforcement Officers Memorial in Washington, DC;

WHEREAS, 282 new names of fallen heroes are being added to the National Law Enforcement Officers Memorial this spring, including 118 officers killed in 2023 and 164 officers killed in previous years;

WHEREAS, the service and sacrifice of all officers killed in the line of duty will be honored during the National Law Enforcement Officers Memorial Fund's 36th Candlelight Vigil, on the evening of May 13, 2024;

WHEREAS, the Candlelight Vigil is part of National Police Week, which will be observed this year May 10-16, 2024;

WHEREAS, May 15 is designated as Peace Officers Memorial Day, in honor of all fallen officers and their families and U.S. flags should be flown at half-staff;

THEREFORE, BE IT RESOLVED that the City of Petal will observe May 10-16, 2024, as National Police Week in Petal, and publicly salutes the service of law enforcement officers in our community and in communities across the nation.

#### ORDINANCE NUMBER 2014 (132-A10)

AN ORDINANCE AMENDING CHAPTER 34, SECTION 96(d) OF THE CITY OF PETAL, MISSISSIPPI, CODE OF ORDINANCES ADDING A FEE FOR DISCONNECTING SEWER SERVICES WITHIN THE CITY OF PETAL, MISSISSIPPI,

BE IT ORDAINED by the Mayor and Board of Aldermen of the City of Petal,

Mississippi:

Chapter 34, Section 96 as originally adopted on December 30, 2016 is hereby amended to read as follows.

To-wit:

Sec. 34-96:

(d) If a sewer/waste account serves a location in which the City of Petal does not provide city water services remains delinquent for more than sixty (60) days, then the location's sewer connection will be physically removed from the City of Petal's Sewer System by the addition of a sewer disconnect valve; and a fee of \$300.00, if work is completed by the city's Public Works Department in addition to outstanding charges will be charged to have the sewer services reconnected. If the disconnection requires an outside contractor, the fee will be the actual cost of the contractor plus 20%. Sewer services disconnected for non-payment will be reconnected after payment is made in full on the next business day pending any City, County, State or National emergencies impacting the City of Petal.

SECTION 2. All Ordinances in conflict herewith, be, and are hereby repealed.

SECTION 3. That this ordinance shall take effect and be in force (30) days from and after its passage.
