ORDINANCE 2022 (145- A1)

AN ORDINANCE AMENDING ORDINANCE 2022 (145) PROHIBITING BORING, DIGGING, EXCAVATING AND TRENCHING WITHIN THE CITY OF PETAL, MISSISSIPPI, WITHOUT OBTAINING A PERMIT

WHEREAS, it is in the best interest of the City of Petal and its citizens' health, safety and welfare that the City of Petal Code of Ordinances provide restrictions governing boring, digging, excavating and trenching within the city's rights-of-way.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF PETAL, MISSISSIPPI, AS FOLLOWS:

SECTION 1: ADOPTION OF ORDINANCE AMENDMENT

For the purpose of adopting uniform regulations governing boring, digging, excavating and trenching within the City of Petal, Mississippi's rights-of-way, the following regulations shall take effect immediately upon adoption:

Ordinance 2022 (145) is hereby amended, by adding (5) and (6) to the aforementioned ordinance:

- (5) Issued permits shall be valid for a maximum of (60) days from the date of issuance. Applicants/permittees may reapply for a permit after the expiration date at no additional
- charge.

 (6) There shall be no active boring, digging excavating or trenching activity on Fridays, Saturdays, Sundays or approved city holidays.

SECTION 2:

This Ordinance shall take effect and be in full effect and force immediately upon adoption on this day, the $4^{\rm th}$ of April 2023.

NOW THEREFORE, be it ordained by the Mayor and Board of Aldermen of the City of Petal, Mississippi, that this ordinance be adopted to preserve the general public health, safety, and welfare of the people of the City of Petal, Mississippi as stated above.

The above and foregoing Ordinance having been reduced to writing, the same was introduced and read, and a vote was taken thereon, first section by section, and then upon the ordinance as a whole with the following results:
