14. Unfinished Business

A. Ordinance #2023-15: An Ordinance Adjusting the FY 2024 Budget for Known Changes - Third and Final Reading

If approved in three readings, Ordinance #2023-15 will 1) assign \$50,199 of Homeland Security grant revenue accepted by the Assembly on November 6, 2023 to the FY24 budget for School District Radios; 2) authorize additional funds of \$86,876 from the E911 fund to cover the cost of an upgrade to the Police Department access control system; 3) increase the budgeted amounts to cover actual costs for purchase of a new pump to replace the leaking leisure pool filtration pump (\$10,398) and replacement of two benches at the South Harbor viewing platform that were damaged (\$3.629); 4) transfer \$880,000 from the Electric Department reserves to the Blind Slough Hydro fund to finish out the project; 5) increase the FY24 budget amount for work on the EMD 16 generator that had been budgeted for in FY23 but not invoiced until now (\$5,850); 6) increase the Diesel Plant Maintenance line item to cover unanticipated work on the Caterpillar 398 generator rebuild (\$20,981); 7) increase the Motor Pool O&M budget by \$20,056 to cover unanticipated repairs on the line trucks; 8) increase the Electric Travel and Training budget by \$13,000 to cover online training of staff on the Eaton Yukon AMI program: 9) transfer Wastewater reserves in the amount of \$144,000 to the Pump Station 4 project to award a professional services contract for pump station control panels and control programming; and 10) increase the Electric Department payroll budget by \$132,366 for FY24 to cover the cost of ratifying the new IBEW Collective Bargaining Agreement. Ordinance #2023-15 was unanimously approved in its first and second readings.

By unanimous roll call vote, Ordinance #2023-15 was approved in its third and final reading.

Top Petersburg Borough Projects FY 2024

Approved, and prioritized in a public meeting January 2, 2024, by the Petersburg Assembly

1. New Petersburg Medical Center Project

HRSA Grant (received): \$8 million
Treasury Grant (received): \$20 million
Borough In-Kind Land Contribution \$1.3 million
Total Received to Date: \$29 million

Phase 4 – Main Hospital Building Shell and Core \$37M Phase 5 – Main Building Interior/Furniture/Fixtures \$30M

Balance needed to complete project = \$67 million

Phase 4 – Main Hospital Building and Shell

This includes foundations, building envelope, roofing, plus associated soft costs. Due to SE Alaska weather, it is imperative that the building be enclosed as soon as possible. This will lead to overall savings and improve overall quality control. During Phase 4 it will also be important to procure certain long lead time items needed for Phase 5. In today's market, many mechanical and electrical equipment items have extremely long procurement times.

- 2. Scow Bay Generator #2 This project will add additional standby generation capacity to account for the increase in electrical demand during the winter and to fully restore Petersburg's power in the event of a hydropower outage. Beneficial electrification, the addition of electric heat pumps, conversion from oil heat to electric, and growth in the local economy have increased the electrical demand equal to the capacity of existing standby power assets. The Borough has \$2.5 million on hand and will need an additional \$2.1 million to complete the project.
- 3. Scow Bay Boat Haul out and wash down facility Development of a small vessel haul out and work yard for use by commercial fishing, sport/tour/charter, and private recreational vessels. Improvements include replacement of a deteriorated and inadequate ramp for hauling boats in and out of the water, vessel washdown pad, and water, sewer and electrical service-related improvements are also needed. Engineering is 35% complete, with a total estimated cost of approximately \$8.9M.

Additional Critical Borough Projects

Marine Transportation Access Improvements for the Borough – As an island community, transportation for people, goods and services is heavily reliant on water transportation. The Petersburg Borough Assembly has prioritized several marine access improvement projects to facilitate growth in our local economy and support for the residents.

- a. Expansion and improvements for the Banana Point Boat facilities that improves transportation of goods and passengers between Petersburg and other communities in Southeast Alaska. \$2.0M
- b. Dock, ramp, and floats for Papke's Landing Facility to improve transportation for off island residents and hunting and fishing lodges in the area. \$9.22M

Addition of ADA ramps for the South Harbor to help facilitate easier access to the main Petersburg commercial district for visitors and residents, \$3.0M.

Aquatic Center and Community Gym Refurbishment – This project will update the mechanical, control systems and HVAC systems in the aquatic center and community gym facilities to improve energy efficiency and reliability. In addition, the aquatic center needs to have peeling paint in the pool area removed and redone to avoid the paint dropping into the pool. The approximate cost for these repairs is \$3M.
