- Only a few Dive-In Movie nights left in the season, seems like they just started... Great opportunity to have some good warm family fun!
- ❖ Stephanie has begun teaching adult swim lessons again, if you know of anyone who would like to join, have them contact me. Scott will be organizing youth swim lessons soon.
- ❖ If your crew needs American Red Cross First Aid/CPR/AED certification, please get in touch with me to get one scheduled. Already have Glo and Liz crews on the list.
- The first apartment to be renovated in Elderly Housing is nearing the end of the demolition phase and vendors have been contacted regarding supplies necessary to outfit the unit.
- ❖ Annual apartment inspections are being scheduled in Elderly Housing in preparation for our upcoming REAC inspection.
- ❖ Preliminary work is underway for the repair of flooring in the Elderly Housing commercial kitchen cooler/freezer area.
- The Harbor Department reminds their permanent stall holders to return their updated stall contracts that were sent out at the end of the year.
- Reminder to boat owners the annual drive-down permits are available.

- ❖ The Harbor has posted the dock roof project adjacent to the Harbor Office in the Pilot and bid documents are available on the Borough's website or at the Harbor Office. The Harbor encourages interested parties to reach out if there are questions.
- PMPL's new digger derrick was received, inspected and placed in service.
- ❖ There was a fire at a home adjacent to the Public Works yard and close to our Motor Pool fueling station, but fortunately it did not spread to our site. Thanks to PVFD for their quick response to this incident!
- ❖ The Pump Station 4 project is officially underway. Contractor Rock-N-Road has been issued a Notice to Proceed and has indicated that construction should begin in March or early April. Pumps for the project have been ordered by the Borough through Alaska Pump and Supply.
- Still figuring out if our various grants and loans will be affected by the most recent Presidential Executive Order that paused Federal funding and then cancelled the Executive Order. It appears to be good news.
- ❖ PMPL is working through requests from FERC to perform additional seismic hazard analysis on the Crystal Lake Dam. This is stemming from a footnote on the 2018 Part 12D safety inspection, and we can't seem to get to a conclusion that satisfies FERC. The next steps include a more detailed type of seismic hazard analysis, while PMPL is still waiting for FERC comments on a dam stability analysis that was submitted to the agency in the summer of 2023.
- The first single digit temperatures of the winter are forecasted for the first weekend of February. The department is coordinating Wrangell Light and Power and SEAPA to ensure that if SEAPA generation cannot meet the system loads, diesel support will be provided during periods of peak power usage.

MEETING NOTES:

- APEI provided the 5-year Workman's comp summary of the claim count by injury type. As discussed at the last safety meeting, the Safety Committee recommends some additional training for back and lifting safety for employees. Becky has contacted Cole at APEI and will let the committee and department directors know what training is available.
- OSHA update Top 10 most frequently cited OSHA violations and upcoming OSHA regulations for 2025 information was handed out to the committee. A new PPE fit rule: One size does not fit all. Smaller sizes of PPE need to be available if needed. A proposed rule for heat-related injury and illness prevention is being considered by OSHA.
- Becky reminded everyone of the subscription available to all departments with JJ Keller for accessing Safety Data Sheets.
- Ice grippers purchased with the APEI safety grant are available to all departments. Additional large and extra-large sizes will be ordered.
- Confined Spaces training. ARWA (Alaska Rural Water Association) did not receive the grant funding to come to Petersburg to do the confined spaces training. APEI will let us know what training they may be able to provide.
 Becky also contacted the local government specialist with the State of Alaska to inquire about possible training options.
- Department Communications Each member reported on activities in their departments and discussion ensued.

New OSHA regulations for 2025 as of 1.16.2025 (www.osha.gov)

- Injury and Illness Reporting Requirements: Establishments in high-hazard industries with 100 or more employees must now electronically submit detailed data about workplace incidents. This includes information from OSHA Forms 300 and 301, covering the date, location, severity, and employee details of each recordable injury and illness. The deadline for submission is March 2nd each year¹.
- 2. Heat Injury and Illness Prevention: A <u>proposed</u> rule aims to protect workers from heat-related injuries and illnesses in both outdoor and indoor work settings. Employers would be required to create a plan to evaluate and control heat hazards. This rule is currently under review and open for public comments².
- 3. **Personal Protective Equipment (PPE) for Construction Workers**: A final rule has been issued requiring construction employers to provide PPE that properly fits their employees. This update addresses the needs of smaller construction workers, particularly women, ensuring that PPE is available and fits correctly².



Petersburg Assembly Members,

I am happy to present to you Petersburg Volunteer Fire Department's 2024 year end report. At the beginning of 2024, we changed some of the data collection we were gathering to get a better picture of our response statistics throughout the year. We aim to use this data to strengthen our response to the varied emergencies we get called out to face.

2024 gave us a few hurdles to overcome with the resignation of our EMS Coordinator, changes within the officer corps, new regulations and aging equipment. Thankfully, with new leadership and staff in place, new recruits, and with help from the Title 3 USFS receipts we are looking like we are in a little better shape going into 2025. Overall, we have gained in membership 4 additional Firefighters, 14 Ambulance Drivers (with 11 slated to become EMT -1's after they test) and SAR membership held about even throughout the year. Please see my notes at the end of this report.

Responses for Fire, EMS, and Search and Rescue are down from 2023, but within normal fluctuations based on previous trends. Response times remain on average with the exception of the summer months where coverage remained spotty. We hope with our new recruits to be able to fill the gaps. We also foresee future challenges in obtaining supporting grants from the State of Alaska and FEMA and appreciate the opportunity to work with the Assembly going into the future to overcome regulatory and financial challenges that affect our mission of protecting life and property in Petersburg.





Stations and other locations

Station 1 – Fire Hall, 1200 Haugen Drive

- Paid Staff offices located here
- 2 bedrooms for responders on call.
- Primary meeting place for meetings and drills
- Houses both Ambulances, Engines 2,4 and 8, the "Squad-1" Mini pumper, SAR truck and Admin SUV
- Fire Radio repeaters, Ham Radio, and back up Dispatch equipment and Siren controls are housed here.





Station 2 – Scow Bay Fire Station, 290 Mitkof Hwy

- Located in the Scow Bay turnaround, across from DOT
- Unmanned station, currently protects the far edges of SA1 from 2 mile out and beyond SA1.
- Houses Engine 6 and the Water Tender, also the 3 antique vehicles.
- Also stores additional training props and equipment inside the station.
- Behind the station is the Burn Tower and Container Prop.
- Ideally located away from residential areas when training with live burns.
- Responders who respond here typically work or live out here, or someone drives from intown to this station.

<u>Harbor Sheds – North, South and Middle Harbors</u>

- Each Harbor has a fire shed with one ATV and at least one trailer with portable pumps and hoses ready to deploy for boat fires.
- Middle Harbor also stores equipment for off island response.
- Harbors also have standpipes for water supplied from responding engines.





EOC Building – 16 N 12th St.

- The Emergency Communications Trailer and shelter supplies are stored here
- Contains 105 Cots, 158 Blankets, 150
 Pillows, 275 hygiene kits, FM/AM radios,
 First Aid Kits, Misc MRE type food (7,800 servings).

 - Second due for all fire calls, carries additional sets of tools for different types of response.
- Engine 6 1994 Pierce Saber Pumper 15,178 mi / 1,391 hrs

 - First Due for the Scow Bay area and out past the hydrant system. Alternatively, if a team
 is unable to assemble at Scow Bay, Engine 6 will stand in for an engine that travels out

- Carries one radio repeater, repeater antenna, 4 VHF radios, one CB radio, 3,000w inverter and Onan 5kw generator.

- o Paid for mostly by grants in 2008 that also paid for the SAR Truck
- Used to extend communications in areas where radio reception is poor
- Also used as a command post for SAR missions on island.
- Repeater marginally repaired in 2024
- 3,000w inverter replaced in 2023 with grant funding.

- Director's note, I don't have a lot of history on these other than that they exist. I am still







numbers due to our revamped ambulance driver program.

This chart breaks down individual member involvement in the 3 branches of the fire department. Very few can offer to do more than one branch due to the time commitment of training and response.

Regardless of how many branches a volunteer is involved in, I remain grateful for their efforts.

Notes on membership:

While roster numbers are up, the majority (63%) of the department is made up of members who have been in the department 5 years or less (56 members, 27 of these are new this year). Another 11

members (12.5%) have been in 10 years or less. The First Responder services in general continue to exhibit a high attrition rate. Petersburg is no exception. Though I am excited for our recent new members, the likelihood is less than half will still be involved within a few years. PVFD officers and staff remain committed to try and bolster our retention rate and will be calling on the Borough to aid in those efforts through a request for volunteer stipends, continued support in acquiring needed equipment and letters of support when applying for grants, writing to the state and feds to support rural fire departments and attracting younger members to the community to be able to recruit.

Additional details and considerations:

It is worth noting that there are 8,760 hours in a single calendar year. With the volunteers donated hours pooled together, it would equate to a member of the department spending 47.5% of the calendar year responding, training to respond, or participating in a community event.

In 2022's report, I outlined that PVFD would need 12 paid staff to cover the majority of the incidents the current members respond to. In that report, I used \$25/ hr as yard stick to estimate how much the borough would need to pay in order to field that many staff (Using Info from the National Volunteer Fire council), The total number including the cost of benefits was \$94,900/employee or \$1,138,800 for 12 employees. For large events, the 12 staff would still need to be supported by volunteers.

To put a direct value to PVFD's contributions, aside from the value of the paid staff they replace and revenue from ambulance fees, if the volunteers had been paid \$25/hr, their combined time would be worth a donated cost of \$104,075.

With extreme gratitude for our volunteers, I submit this 2024 report detailing their efforts.

- There has been a lot of traffic through the harbor office looking at the Scow Bay Plans and the American Cruise Line proposal. Thanks to Kirsten Meira from ACL who joined us at the Town Hall Meeting.
- ❖ We had a good turnout for USCG Dockside Exams last week. Thank you to the safety inspectors that annually come to town prior to the tanner opening to perform them and our very own Desi Burrell, who as part of the local CG Auxiliary, has trained to be an examiner.
- All Departments are working on Budget preparation for next years budget. Very challenging.
- The line crew continues to be busy with service installs, tree trimming and a pole move.
- ❖ We still have not received word on when the Section 243 grant, Tribal Grid Resiliency grant and Scow Bay funding will be released to the Borough or if they will be retained by the Administration.

AN ORDINANCE AMENDING THE OFFICIAL ZONING MAP FOR SERVICE AREA 1 OF THE PETERSBURG BOROUGH TO REZONE LOT 13B, PLAT #2008-15, (PARCEL #01-014-700 LOCATED AT 1020 SANDY BEACH ROAD) FROM RURAL RESIDENTIAL (R-R) TO SINGLE-FAMILY RESIDENTIAL (S-F)

WHEREAS, the Petersburg Borough owns the parcel of land described as follows:

Lot 13B, Plat 2008-15, Petersburg Recording District, State of Alaska (physical address: 1020 Sandy Beach Road) (hereinafter "the parcel") ;and

WHEREAS, the parcel is currently zoned Rural Residential (R-R); and

WHEREAS, the R-R district requires a minimum of 1-acre lots and is intended for one single-family home per acre. However, conditional uses in the R-R district include mobile homes and mobile home parks; and

WHEREAS, the parcel is located across from an area zoned Single-Family Residential (S-F), a well-developed residential area with some institutional uses (churches, park, playground), and with road access and municipal power, water, and sewer located nearby; and

WHEREAS, rezoning from R-R to S-F would allow single-family or duplex as a primary use and reduce the minimum lot size from 1-acre to 8,000 sq.ft. Mobile homes and mobile home parks are not allowable uses in S-F; and

WHEREAS, R-R zoning has primarily been used for areas of Service Area 1 without access to municipal water and sewer. The large minimum lot size of 1-acre in the R-R zone is intended to ensure sufficient acreage for on-site septic systems and create a more rural, lower density area; and

WHEREAS, after receipt of an application to purchase the parcel, the Planning Commission recommended that the Borough Assembly initiate, prior to disposal, a zoning amendment for the parcel, from R-R to S-F, and the Assembly did so by motion on November 4, 2024; and

WHEREAS, the Planning Commission conducted a duly noticed public hearing on the proposed rezone on December 10, 2024, and considered and reviewed applicant materials, public comments and testimony, and staff report. The Commission recommended the Borough Assembly rezone the property by a vote of 4-0, citing that a rezone responds to market demand for developable residential property, is consistent with the Comprehensive Plan by providing residential land for development at appropriate densities, is appropriate to zone for higher residential density due to its location on the road system and utility service area, and no significant expansion of municipal roads or utilities would be required to develop the property; and

WHEREAS, Chapter 19.84 of the Petersburg Municipal Code (Service Area 1) provides for zoning amendments whenever the public necessity, convenience or general welfare requires; and

WHEREAS, Borough Charter Section 3.01(K) and Section 1.12.010(G) of the Municipal Code require amendments to the official zoning map be enacted by Ordinance.

THEREFORE, THE PETERSBURG BOROUGH ORDAINS as follows:

<u>Section 1. Classification</u>. This Ordinance is of a general and permanent nature but will not be codified in the Municipal Code.

<u>Section 2. Purpose</u>. The purpose of this Ordinance is to amend the Official Zoning Map for Service Area 1 of the Petersburg Borough.

Section 3. Substantive Provisions.

A. The Official Zoning Map for Service Area 1 of the Petersburg Borough, codified and referenced in Section 19.08.020 in the Municipal Code, is hereby amended for the following described property from Rural Residential (R-R) to Single-Family Residential (S-F): Lot 13B, Plat #2008-15, Petersburg Recording District, State of Alaska.

<u>Section 4. Where Record to be Maintained.</u> This non-Code ordinance, and the enactment of the zoning amendment referenced under Section 3 of this ordinance, shall be maintained with the zoning records of the Borough.

- The immediate surrounding area is zoned SF or public use and is a well-developed residential area with some
 institutional uses (churches, park, playground) with road access and municipal power, water, and sewer located
 nearby.
- f. Rezoning from RR to SF would allow single-family or duplex as a primary use and reduce the minimum lot size from 1 acre to 8,000 sf. The maximum number of dwellings per lot is 2 with single family, two-family (duplex), and detached accessory dwellings allowed use. Mobile homes and mobile home parks are not allowable uses in SF.
- g. Rural residential zoning has primarily been used for areas of Service Area 1 without access to municipal water and sewer. The larger minimum lot size of 1 acre is intended to ensure sufficient acreage for on-site septic systems and create a more rural, lower density area.
- h. Although the Sandy Beach Rd neighborhood is zoned single-family, lot sizes vary significantly from large multi-acre parcels to lots of 9,000/10,000-sf. The area is generally less dense than other neighborhoods apart from certain stretches of the waterfront.

- 4. No significant expansion of municipal roads or utilities is required to develop the property.



Dear Mr. Sexauer:

The Petersburg Borough is requesting a general investigations study or assistance from the USACE from another applicable program to look at developing a harbor basin and breakwater along Borough owned property in Scow Bay.

Harbors are vital for the Petersburg economy and our three harbor system is at full capacity with a waiting list for seasonal and permanent moorage. This impacts our ability to attract and retain new businesses, as well as provide increased support for the US Coast Guard. The protected nature of the harbors coupled with the centralized location of Petersburg has long been a factor in a consistent customer base. Future growth will depend upon moorage availability.

The Borough's downtown waterfront has been fully utilized with no available area for future development therefore Scow Bay has been identified as a logical choice for harbor facility expansion. Phase one of the development plan for Scow Bay, a haul out and boat yard, is now fully funded and we anticipate construction beginning in the next year. With phase one funded, we are ready to begin working with the Corps to plan for the next phase – a harbor facility.

On behalf of the Petersburg Borough, I request the Alaska district initiate a study to construct a harbor basin, breakwater and all navigation features needed for a future harbor for Petersburg.

The Alaska Department of Natural Resources, Division of Forestry and Fire Protection (DOF), gives formal notice per AS 38.05.945 that the Division proposes to adopt a site-specific Forest Land Use Plan (FLUP) under AS 38.05.112 and the administrative standards of AS 41.17.060 for the commercial timber sale: Edna Bay Parlay Three Timber Sale (SSE-1342-3).

This timber sale is located on Kosciusko Island, centered approximately two miles west of the City of Edna Bay. The legal description of the sale area is within Sections 1 and 2 of Township 69 South, Range 76 East, all in Copper River Meridian. Access to the sale area is by a log transfer facility in Section 34 and from existing road systems.

The harvest units total approximately 114 acres and contain approximately 2,800 MBF of timber. This volume will be sold under the provisions of AS 38.05.120, in the form of one or multiple sales.

The FLUP is intended to provide the best available information regarding the proposed timber harvest on 114 acres and the management of other non-timber uses in compliance with AS 38.05.112 and AS 41.17.060, and must be adopted by the DOF before the proposed activity can occur. This FLUP does not determine whether or not to access and sell timber within the timber sale area, nor the method of sale. Those decisions have been made previously in the March 9, 2017 Best Interest Finding and are not appealable under this FLUP.

The public is invited to comment on the FLUP. Comments can be submitted by mail or by email using the contact information listed below. Comments must be received at the Division of Forestry office no later than **March 7**, **2025**, in order to be considered in the adopted FLUP. To be eligible to appeal the adopted FLUP a person must have provided written comment by **March 7**, **2025**.

Comments about American Cruise Lines Dock

I am Casey Knight, Harbor Board member, but I represent myself and expressing my own viewpoints. I am conflicted about this issue — whether to be in favor of a dock for American Cruise Lines — and I want to explain the nature of my conflict, because I suspect that a lot of other people are similarly conflicted.

There are three perspectives that I take on this issue, and for each of them I wear a different hat. Each hat corresponds to a different way of thinking about it, so I'm going to try on three different "thinking hats" in my testimony.

The **first, and most worn, thinking hat** represents my own *personal feelings* about an increase in tourism in Petersburg, as a fisherman, family-man, and resident. How do I feel about the possibility of an increase in tourist activity? This is an easy question to answer, because I merely have to consult my own inner feelings.

I personally would prefer not to have any increase in tourism during the summer. Indeed, I would rather it be reduced. In the summer, when I am in town trying to get stuff done in between fishing trips, during my busiest time of year, I'd rather not have the added distraction of wandering groups of tourists (whether they are from ships, lodges, or otherwise). In addition, to a certain extent, I feel a bit like a monkey in a cage at a zoo (alternatively: a lion on an African game range) with my habits on display for visitors. I would prefer not to feel this way in my normal day-to-day life.

These are just my own personal feelings, and I suspect that a lot of community members feel the same way. But there are two other hats that I sometimes wear, and which are also relevant to this issue.

The **second thinking hat** represents what my preferences about this issue *should be*, as someone with personal financial interests, who is aware that my quality of life depends on my finances. Should I be in favor of increased tourism in general, and the American Cruise Lines project in particular? This is obviously a harder question to answer, because I have to take into consideration information concerning whether I plan to continue as a fisherman for the foreseeable future, whether I should instead be a tour guide (or something), and so on.

But I do think I can answer this question: I should be more-or-less indifferent about it, from a financial point of view. On the one hand, as noted above, I would prefer there to be less tourism in Petersburg, but — and this is very important — *more tourism might be coming whether I want it to or not.* I might be able to benefit financially from such an increase in tourism, but I presently do not plan to take advantage of it. I am busy enough as it is during the summer months, and I am happy fishing. I cannot currently see any way to effectively change my own fishing endeavors to take advantage of this increase in tourism. I make plenty of money to support my family's lifestyle, and, until I have some obvious reason to find some other occupation, I'll keep doing what I'm doing, since I'm happy doing it. I suspect that plenty of the community feels this way about taking financial advantage of tourism.

(I note in passing that several members of the Assembly *are* financially invested in tourism. I am not saying this to call anyone out. Instead, it is directly relevant to the question of whether the expansion of the tourism industry is inevitable. It is much easier to see increased tourism as a boon to the community if you will benefit from it. I am just trying to be realistic about how those members are likely to vote on this issue. I don't hold this against any of them, and I don't think anyone should.)

The other night in the sauna I heard a fisherman say "Give it five years and Petersburg will be just another trashy tourist town like Juneau and Ketchikan". Growing the tourism industry without selling the soul of our town is a challenge, and it won't happen without imagination, focus, and teamwork. But I believe there are great possibilities in sharing this place with visitors.

Here is a way forward as I see it:

Give ourselves permission to dream big and imagine a future for our community that we're actually excited about. This will create the energy and vision to reach those goals. Everyone will have different ideas but there will be common ground somewhere and that's what we should focus on. And remember the values we need to protect like clean water, healthy ecosystems, and a strong community.

I imagine a new Viking ship that's actually seaworthy, Norwegian-style floating saunas for rent, and more beautiful public art that tells the story of this place. A bigger space for the Claussen Museum would be great too, this town has so much history and knowledge to share, particularly around fish and fishing. Find a way to attract talented chefs and share more of our abundance of fresh seafood with visitors.

Find or create attractions in the off season to spread out tourism activities. I have friends who just took a fantastic midwinter vacation in Banff- the Canadians know how to make winter awesome.

More trails and other amenities on the mainland could create big opportunities for local eco-tourism businesses while leaving fish and game resources for local use. My wife and I are building a farm at Point Agassiz, and we want to offer visitors the experience of amazing farmstays complete with a wood-fired sauna and excellent fresh meals, permaculture workshops, healing retreats and more. I know that our business will be much more viable if it's part of a whole ecosystem of attractions in the Thomas Bay-Point Agassiz area. I imagine kayaking, hiking, river rafting and mountaineering excursions, all creating awesome visitor experiences without taking away any fish or game from locals. There is great potential for cooperation between different tour and lodging operators. All of us are selling the brand of Petersburg, Alaska.

I think it's a good idea to invest in another small cruise ship dock and maintain majority ownership locally. Design it to be multifunctional as much as possible so other industries could use it. More docks are a good thing around here.

I think small cruise ship visits are a great way to introduce Petersburg to a larger audience, but the real objective should be attracting independent travelers who stay for days or weeks at a time. This creates a lot more opportunities for local businesses than ship passengers with only a few hours to spend. There

I had a couple concerns about what I heard at the meeting. The following is a letter to the editor that I just sent to Orin:

My wife and I attended the Council meeting Tuesday regarding the proposed new dock that would be partially paid for by American Cruise Lines, which comes with a 60 year commitment to their priority and continued use. Taking money from large corporations always comes with strings attached, many of which aren't fully realized until it is far too late. That being said though, I believe that all my feelings were more clearly expressed by all the other speakers. In fact, I am no more opposed than anyone else in the room. I would encourage everyone to listen to the full recording available on the KFSK website.

There were two things that kept me up last night, that weren't said, that I feel need to be said. The word "inevitable" was frequently used. Words are powerful, and this one in particular abdicates our inherent power. The flawed reasoning was that if the council does not accept this offer, then ACL will negotiate a less-satisfactory agreement with a private property owner and the outcome will be worse for everybody. The representative from ACL did not offer any commitment to not do such a slippery thing, remaining silent as that was discussed. I do not feel that entering into a negotiation with that tacit threat in place is an honest negotiation.

I propose that our first step *prior* to entering into this negotiation, would be to pass an ordinance, or zoning change that would completely take that threat off the table. I would like this to happen even if this offer were withdrawn. Only the Council should be able to make those agreements on behalf of the whole community.

No individual property owner should be able to dock ships of that size that burden our public utilities, public infrastructure, public employees, and all-volunteer emergency services for their own personal gain, ever.

Second, the sentence "they are offering us a seat at the table" was spoken nonchalantly by one of our council members. I felt a little sick. The ACL representative again did not disagree with that, while she was sitting in a chair our city owned, in front of our council, in our fine Assembly Chamber, after years of docking their profitable cruise line at our publicly owned harbor. The best harbor in the world, in fact. She was literally sitting at our table. I would like to never again hear that kind of language from a Council member. Words are powerful, and we are an authentic and powerful community. Let's talk like it.
