Call to order 7:00 PM

Mayor Cockerham called the meeting to order at 7:00 PM. Commissioner Kiger led the Pledge of Allegiance.

Adoption of Agenda

Commissioner Atkins made a motion to adopt the agenda as presented and it was unanimous.

Public Hearings

Comprehensive Plan

Mayor Cockerham opened the public hearing. No comments. Mayor Cockerham closed the public hearing.

UDO Text Amendment

Mayor Cockerham opened the public hearing. No comments. Mayor Cockerham closed the public hearing.

Public Comment

Gary Marshall, 521 E Main St, was present to address the Board. He stated that the back of his property had been used as a landfill for quite some time. The code enforcement officer is aware of it and he has left multiple messages with him. Mr. Marshall showed the Board members pictures that he had on his phone. He told Board members that they were welcome to come to his house and look at any time.

Consent Agenda

Commissioner Kiger made a motion to adopt the consent agenda and was unanimous.

Board & Committee Reports

Chairman Pell provided the following sales numbers from the ABC Store:

Comprehensive Plan Adoption

Commissioner Needham made a motion to adopt the Comprehensive Plan and it was unanimous.

UDO Text Amendment

Mr. Boaz explained that this text amendment would amend the permitted use table to allow tattoo parlors in the GB as well as HB as currently allowed. Commissioner Atkins made a motion to approve the UDO text amendment and it was unanimous.

Acceptance of WWTP Funds

Mr. Boaz explained that both the State Water Infrastructure Authority and the LGC had approved the conversion of no interest loan money that we were set to receive to all grant funding. This will be a 2.444 million dollar grant. Commissioner Collins made a motion to adopt Resolution 2022-08, Authorizing Town Acceptance of WWTP Rehabilitation Loan Funds and it was unanimous.

New Business

Division of Water Infrastructure Application

Mr. Boaz explained that these resolution would allow us to apply for money to do a sewer infrastructure project that would include additional line rehab, electrical work at pump stations and some other minor repairs at pump stations. It would also allow us to apply for a water planning grant which we would use to do a study on the water system to help identify areas that might be right for rehab in the future. Commissioner Needham made a motion to adopt the following resolutions and it was unanimous; Resolution 2022-05, Authorizing Submittal Of Application To NC DEQ-Division Of Water Infrastructure and Resolution 2022-06 Authorizing Submittal Of Application To NC DEQ-Division Of Water Infrastructure.

Update to Capital Improvement Plan

Commissioner Atkins made a motion to adopt Resolution 2022-07 Adopting Amended Capital Improvement Plan and it was unanimous.

Street Resurfacing Project Budget Amendment

Commissioner Needham made a motion to approve the budget amendment and it was unanimous.

FY 2022 Budget Amendment 2

Mr. Boaz explained that we have two capital projects that we are closing out and it would take those funds and transfer them back to the general fund which provided start-up capital. It would also appropriate from the Capital Reserve fund to the water/sewer fund. Commissioner Collins made a motion to approve Budget Amendment 2 and it was unanimous.

Social Districts

Mr. Boaz stated that with the most recent legislative session, the NC General Assembly adopted legislation that would allow local governments to create social districts. He explained that a social district would allow off-premise consumption of alcoholic beverages in the designated district. The town Board would have to pass an ordinance, create a maintenance plan and then partner with licensed vendors in the district. Discussion ensued about the pros and cons of a social district. It was the consensus of the Board to authorize staff to conduct further study and report back to the Board.

Financial Policies Adoption

Mr. Boaz presented financial policies that are recommended by the LGC. They include preparing the annual budget, handling debt and investments and procedures regarding cash management. Commissioner Atkins made a motion to approve the financial policies as presented and it was unanimous.

Administrative Reports Town Manager & Staff Reports

- NC DOT has completed paving Butler, Blalock, Westridge, Old Barn Circle, Lynchburg and Saddle Drive. They plan to pave Heatherly Creek Drive this week and they will have to pull out and do some of their own work.
- They have met with WithersRavenel and Duke Energy regarding options to the power lines on Main Street. The original estimate to move the power lines completely off of Main Street was \$2.3 million dollars. Duke has presented an option to install 40-60 foot black poles to replace the existing poles at a cost of no more than \$1.9 million. WithersRavenel is looking at this option to see if additional pedestrian lighting would be needed.
- The Annual Comprehensive Financial Report is included in the packed. The Board needs to set a meeting so the auditor can formally present it.
- In response to concerns in public comments regarding 521 E Main Street, Code Enforcement has been out to that location and it is technically on town property. There is nothing to be concerned about. There is no junk located on the property.

Mayor and Commissioners Comments

Commissioner Atkins: Thanked Commissioner Collins and Commissioner Needham for their comments at the Surry County Board of Commissioners meeting regarding PART. He asked about pets at events since most towns allow leashed pets at some events. Mr. Boaz stated that pets are allowed at town sponsored events but non-town sponsored events, it is up to the organizer.

Commissioner Kiger: No comments

Commissioner Needham: He really enjoyed the Vintage Market and there were a lot of people out. He thanked Jenny and her associates for helping out with that. He asked that if any citizens would like would like to speak with their county commissioners about the way they feel with the PART system, he invited them to do so. As it stands right now, the PART bus will no longer be coming to Pilot Mountain starting June 30th and they are trying all they can to get that to continue.

Commissioner Collins: She encouraged everyone that is interested to contact their county commissioners and let them know that they would like the PART program to stay.

Mayor Cockerham: Thanked Commissioner Collins and Commissioner Needham for their leadership on the PART service. He hopes that we are successful in keeping PART in Surry County. Transportation is an essential service and it is important that people are able to get to work and their appointments in Winston-Salem. He mentioned that Commissioner Needham and himself had met with Representative Stevens today and talked about projects that are going on in town. He noted that at the previous Board meeting that there were comments made about the Police Department and he just wanted to say that they do an excellent job. We live in a very safe community and that comes from investing in a police department that is functional, equipped and able to do their jobs and do them well.

WHEREAS, the North Carolina Department of Environmental Quality has offered a Viable Utility Reserve Grant in the amount of \$1,117,500, for the purpose of constructing improvements to the Town's water distribution system, and;

RE: May 2022 Manager's Report

- I apologize that the financial report for this month is not ready for the agenda packets. I did not have time this week to get that report ready. I will have it for you all at the meeting on Monday.
- We have a budget workshop scheduled for May 19.
- We got our quarterly profit distribution from the ABC store this month. The profit for the 3rd quarter was \$67,000.
- We have submitted three grant applications to the Rural Transformation Grant program from the Department of Commerce. One for the ACC, one for capacity building for Main Street team, and one for rehab of the Town Hall parking area.

PROJECT UPDATES

- 1. Depot Street Stream Restoration Project: Design is underway and should be completed by August. We anticipate construction to begin in the fall.
- 2. Street Paving Project: Project is on hold until NC DOT can come back and complete paving work.
- 3. Water Treatment Upgrade: The project is nearing completion. Smith-Rowe is waiting on 2000 feet of pipe and some other equipment. We hope that all work will be completed in less than 60 days.
- 4. Streetscape Project: Duke Energy has provided the details on Option B. WR is continuing to evaluate that option.
- 5. WWTP & Pump Station Project: The Notice to Proceed has been issued to the contractor. There will not be a lot of progress on this project for some time as there is significant lead time on the equipment.
