1. Public comment-none

- 4. Planning/Zoning Board Report (Andy Jackson)

The Planning/Zoning Board met on March 8. Of particular interest is a request to subdivide 51 Eglantine Ave, a single property that currently has two houses. No Vote was taken.

Also at that meeting, the Master Plan Re-examination Report was approved to send to Borough Council for Review.

- 5. Pennington Arboretum (Joann Held)
 - The Ad Hoc Arboretum committee met recently. The next step is to plan for and install fencing around one of the proposed exclosure areas. The Open Space Committee also had a brief discussion of the fencing at their last meeting.
- 6. Carbon Neutral Workgroup: No report. Planning to meet in the next 2 weeks.
- 7. Green Team and Sustainable Jersey Update (Joann Held)

The Green Team has decided to focus on Composting of Organic Waste this year. The first effort will be to promote composting in two ways: Do-It-Yourself & local subscription services. The next step would be to support a pilot program (perhaps a drop off location) to assess community interest. If successful, this could lead to Municipally sponsored collection of organic waste. Dan Rubenstein reported that state grants might be available for some of these actions. He will share notes from a recent ANJEC program on the topic.

8. Pennington Day: The Environmental Commission plans to participate in Pennington Day, with a focus on 4 topics. Four EC members offered to take the lead on the individual topics. Joann Held is looking into having a new banner in time for the event.
