

**Pennington Borough Council
Regular Meeting – December 29, 2022**

Mayor Davy called the Regular Meeting of the Borough Council to order at 3:00 pm. The meeting was held via Zoom due to the COVID19 pandemic. Borough Clerk Betty Sterling called the roll with Council Members Angarone, Chandler, Gnatt and Marciante in attendance. Mr. Gross and Ms. Stern were both absent.

Also present were Public Works Superintendent Rick Smith, Chief Doug Pinelli and Borough Attorney Walter Bliss.

Mayor Davy announced that notice of this meeting has been given to the Hopewell Valley News, Trenton Times and was posted on the door at Borough Hall and on the Borough web-site according to the regulations of the Open Public Meetings Act.

Open to the Public

Mayor Davy read the following statement.

The meeting is now open to the public for comments. In an effort to provide everyone interested an opportunity to address his or her comments to the Governing Body, a public comment time limit has been instituted for each speaker. **Please raise your hand and when the Borough Administrator acknowledges you state your name and address for the record. Please limit comments to the Governing Body to a maximum of 2 minutes.**

There were no comments from the public.

Mayor's Business

Recreation and Open Space Inventory (ROSI) – Mayor Davy explained that the ROSI is a document that is required by Green Acres in order to be reimbursed for projects. Mayor Davy stated that we are currently seeking reimbursement for two projects from Green Acres, the Arboretum and the Schragger property. Mayor Davy stated that there is a property adjacent to the African Cemetery that Green Acres is requested be included on the ROSI. Mayor Davy stated that he brought this to Council at the last meeting and since that time he has met with Open Space, the Planning Board Chair and the Borough Planner to discuss the implications of including this property on the ROSI. Mayor Davy explained that once a property is listed on the ROSI, it is very difficult to get it removed. Mayor Davy stated that no one had any objections to including this property on the ROSI, so Council has a copy of the report that will be filed with Green Acres after the meeting today.

Proposed Council Assignments – Mayor Davy stated that he included a list of proposed Council assignments for 2023 that will be on the agenda for the January meeting. Mayor Davy stated that Ms. Stern expressed interest in limiting the number of Council Members to two instead of three and though Ms. Stern is not here he said he would bring it up. There was no support for reducing the number of members per committee. There were no objections to the proposed assignments.

Pennington Borough Landfill Results of Environmental Investigation / Affordable Housing Element of the Master Plan – Request for Special Meeting on Tuesday, January 17, 2023 at 7:00 pm – Mayor Davy stated that Excel Environmental has completed their investigation and they are ready to review the results with the full Council and so he would like to have this presentation at a Special Meeting. Mayor Davy stated that along with that the Borough Planner has completed his draft of the Affordable Housing Element of the Master Plan and there are some things that he would like Council to be aware of. Mayor Davy stated that there will be documents for review prior to the meeting. Mayor Davy asked the Borough Clerk to follow up with Excel to get a document that can be distributed prior to the meeting. Mr. Marciante asked when the barrels will be removed from the property. Mrs. Sterling stated that she would ask about the barrels when she follows up on the report for distribution.

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF PENNINGTON that the Borough Salary Ordinance (Ordinance 2022-3) is hereby amended at Section Ic to provide for payment of Crossing Guards at special events at the rate of \$40.00 per hour:

SECTION II: Employee/Personnel Manual.

The terms and conditions of employment as set forth in the Borough Employee or Personnel Manual, as the same may exist and change from time to time, are hereby incorporated herein by reference. The Personnel Manual does not create a contract of employment and except for employees who are tenured; no contract of employment other than “at will” has been expressed or implied. The policies, rules and benefits described in the Manual are subject to change at the sole discretion of the Borough Council at any time.

SECTION III:

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed.

SECTION IV:

Terms and Conditions of employment for Police and Public Works employees are specified in the respective labor agreements.

SECTION V:

This ordinance shall take effect upon final adoption and publication according to law, but the salaries herein provided for shall be retroactive to January 1, 2022 if appropriate.

Council Member Marciante made a motion to open the Public Hearing on Ordinance 2022-14, second by Council Member Chandler. There were no comments from the public. Council Member Marciante made a motion to close the Public Hearing, second by Council Member Angarone with all members present voting in favor. Council Member Gnatt made a motion to adopt Ordinance 2022-14, second by Council Member Chandler with all members present voting in favor.

COUNCIL DISCUSSION

Noise/Lighting Ordinance Amended – Mayor Davy stated that he worked with the internal ad-hoc group and they came to a couple of conclusions. Mayor Davy stated that NJ DEP regulations on noise ordinances require a decibel measuring approach and the group concluded that the Borough does not have the equipment or manpower to support a noise ordinance. Mayor Davy stated that the group was trying to craft a nuisance ordinance that would control the hours for use of leaf blowing equipment and that also became difficult to craft. Mayor Davy stated that the outcome was to leave the nuisance ordinance alone for now. Mayor Davy stated that with regard to the lighting ordinance, the group took a nuisance approach as well and the proposed changes will require that homeowners deflect outdoor lighting and require that lights be shut off after a certain time. Mrs. Chandler stated that she would like to be sure that lighting is shielded, directed downward and turned off at a certain time. Mayor Davy stated that the lighting ordinance will be on for introduction at the January 4th meeting.

120 Water Proposal – Mayor Davy asked Rick Smith to report on this. Mr. Smith stated that 120 Water came to one of the Public Works meetings and made a presentation. Mr. Smith stated that 120 Water has provided a proposal for developing a plan to guide the Borough through the regulations that will kick in once the Lead Line Service Inventory is complete. Mr. Smith stated that 120 Water has worked with other municipalities to help with the lead and copper regulations. Mrs. Chandler asked how many households we are talking about. Mr. Smith stated that the inventory is not yet complete. Mrs. Chandler asked when this plan needs to be done. Mr. Smith stated that the plan can’t begin until the inventory is complete. Mrs. Chandler asked how they could provide a quote if the inventory is not complete. Mr. Smith stated that 120

Water will also help identify funding sources in the plan. Mr. Smith stated that there many layers to the regulations. Mayor Davy stated that this will be on for approval at the January 4th meeting. Mrs. Chandler stated that she is not sure what she is paying for and she would like to see a proper proposal identifying what we will be paying for. Mr. Smith stated that it is hard to identify until we have a better understanding of the regulations and once the inventory is done, 120 Water can assist with formulating a plan for Pennington. Mr. Smith stated that he has a list of other municipalities that 120 Water has worked with. Mr. Bliss stated that he will need more than the proposal that was included in the packet in order to do a resolution. Mrs. Sterling asked if there was any urgency to doing this at the January meeting. Mr. Smith stated that there is no urgency as he is still completing the inventory and it might be worth having Liz Johns from 120 Water come to a meeting and explain what they are proposing.

WHEREAS, the purpose of the Modified/Light Duty Policy is to establish authority and procedures for granting temporary modified-duty assignments to eligible employees when such assignments advance a legitimate departmental goal;

WHEREAS, the proposed Modified/Light Duty Policy would permit assignment of employees of the Department to temporary modified-duty when injury, illness or disability, **including pregnancy**, causes them to be temporarily unavailable to perform their regular assignments but they are capable of performing alternate duty assignments;

WHEREAS, the Modified/Light Duty Policy would create opportunities for employees in these situations to remain productive while serving the best interests of the Department;

WHEREAS, this Modified/Light Duty Policy defines eligible personnel, prescribes rules for its use, and includes explicit provisions for pregnant officers to ensure equal treatment in accordance with applicable law;

WHEREAS, a copy of the proposed Modified/Light Duty Policy is attached to this Resolution;

NOW, THEREFORE, BE IT RESOLVED, by Borough Council of the Borough of Pennington, that the attached Modified/Light Duty Policy is hereby approved and the Chief of Police and Borough Clerk are hereby authorized to take such steps as necessary to implement this Policy beginning with its incorporation in the policies and procedures of the Police Department.

WHEREAS, the Borough of Pennington is a member of the Mid Jersey Municipal JIF which secures insurance protection through the New Jersey Municipal Excess Liability Joint Insurance Fund (NJ MEL); and

WHEREAS, through its membership in the Mid Jersey Municipal JIF, the Borough of Pennington enjoys cyber liability insurance coverage to protect the Borough of Pennington from the potential devastating costs associated with a cyber related claim; and

WHEREAS, in an attempt to prevent as many cyber related claims as possible, the NJ MEL developed and released to its members the NJ MEL Cyber Risk Management Plan; and

WHEREAS, the NJ MEL Cyber Risk Management Plan outlines a set of best practices and standards broken out into Tier 1, Tier 2, and Tier 3 standards that if adopted and followed will reduce many of the risks associated with the use of technology by the Borough of Pennington; and

WHEREAS, in addition to the reduction of potential claims, implementing the following best practices and standards will enable the Borough of Pennington to claim a reimbursement of a paid insurance deductible in the event the member files a claim against the Borough of Pennington’s cyber insurance policy, administered through the Mid Jersey Municipal JIF and the Municipal Excess Liability Joint Insurance Fund;

NOW, THEREFORE BE IT RESOLVED that the Borough of Pennington does hereby adopt the following best practices and standards, a copy of which is attached hereto and incorporated herein by reference, in accordance with Tier 3 of the NJ MEL Cyber Risk Management Plan; and

WHEREAS, the price proposed by Montgomery Township for this extension is \$13,348.91 for the three months combined, with all other terms of the existing contract to remain the same;

WHEREAS, the Borough administration is in the process of securing with Hopewell Township a three-year shared services agreement for health services intended to be effective, upon approval by the respective governing bodies, on April 1, 2023;

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Pennington, that the Mayor, with the attestation of the Borough Clerk, is hereby authorized to enter into the aforesaid three-month extension of contract with Montgomery Township, for the price of \$13, 348.91 for the three months combined, with all other terms of the existing health services contract to remain the same, subject to execution of a written document effecting the extension approved by the Borough Attorney.

INSTALL AN ALL-PEDESTRIAN SIGNAL PHASE AT THE INTERSECTION OF ROUTE 31 AND
WEST DELAWARE AVENUE**

WHEREAS, all Pennington students must cross Route 31 to walk to Hopewell Valley Regional School District’s middle school and high school; and

WHEREAS, late school busing was eliminated requiring more students to walk home from school following afterschool activities when a crossing guard is not present; and

WHEREAS, more students are walking due to the increase in the cost of courtesy busing along with the elimination of a cap on the cost of busing for a family; and

WHEREAS, Pennington Borough and Hopewell Township officials have long advocated for a more protected crossing for students and residents at the intersection of Route 31 and West Delaware Avenue; and

WHEREAS, traffic crashes in New Jersey resulted in 697 fatalities in 2021, a 20% increase from 2019; and

WHEREAS, 35% of these fatalities were pedestrians and bicyclists; and

WHEREAS, Pennington has adopted a Vision Zero resolution which focuses on a safe systems approach to transportation planning and the principle that human life and health should be prioritized in all transportation systems; and

WHEREAS, NJDOT and Pennington have Complete Street policies which call for designing roads with the safety of all users in mind; and

WHEREAS, an all-pedestrian signal phase enables pedestrians to have their own phase, with no traffic movements, which reduces any conflict between pedestrians and motorists, therefore decreasing the likelihood of drivers crashing into pedestrians; and

WHEREAS, there are no pedestrians during the auto phases, which increases the throughput of the turning movements of cars.

NOW THEREFORE BE IT RESOLVED that the Mayor and Council of Pennington Borough request that the New Jersey Department of Transportation install all-pedestrian signals at the intersection of Route 31 and West Delaware Avenue.

BE IT FURTHER RESOLVED that a copy of this resolution be sent to the New Jersey Department of Transportation.
