## **New Business**

#### **Applications**

There are no new applications for review.

#### **Hopewell Valley Heritage Week**

Jack discussed Heritage week. The kick-off is May 22. There is an event at the Pennington African American Cemetery. This commission has been asked to host a table at the event and/or a house/walking tour. It has been discussed that Eric will cover the architecture and Jack will cover the history part of a walking tour. Timing and the schedule were discussed. Jack will follow-up with details. The theme this year is colonial trades and crafts and it would be great if some of this could be incorporated into the tour. It might be a good idea to do a table at Pennington Day.

#### **241 South Main Street**

This location has a new owner. The owner has been notified about the historic nature of his home and the rules of the historic area. His email has been shared with Eric and he has been given the link to the historic commission ordinance. Limited knowledge of the owner and situation seems to indicate that the owner does not have interest in historic preservation, the interest lies in flipping the house. Eric will reach out to the owner to offer information.

## **Review of Ordinance**

Bob and Eric will review the ordinance and add comments based on recommendations/suggestions from the State office. One suggestion is to tighten some definitions, for example, the definition of "replaced in kind." Any changes in the ordinance will need to be approved by Council.

#### **Open Discussion**

Natalie had a question about new siding going on a house in the historic district. Eric will reach out with some information so they are aware of the details in the ordinance regarding replacement.

Regarding notes in seller's deeds; Katrina researched seller's disclosures and there is question on the standard disclosure regarding disclosing whether or not the home is in a historic district. Kait mentioned that in Haddonfield, NJ a note in the deed of historic homes is required and the seller must provide a copy of the ordinance to the buyer. Having this might help to inform new owners and assist in preserving the historic area.

Jack asked about the home in back of the bank. Construction seems to have halted and it may be because the owners are struggling to find a contractor.
