PENNINGTON BOROUGH RESOLUTION 2023-1.1

RESOLUTION APPOINTING HODULIK AND MORRISON, A DIVISION OF PKF O'CONNOR DAVIES AS BOROUGH AUDITOR FOR THE YEAR 2023

WHEREAS, the Borough of Pennington has a need to appoint a Borough Auditor and to contract for related professional auditing services in the year 2023, including conduct of audits for 2022;

WHEREAS, Hodulik and Morrison, P.A. a Division of PKF O'Connor Davies, has served as Borough Auditor and is prepared to continue to serve in this capacity in accordance with a mutually acceptable contract for professional services;

WHEREAS, the Borough Clerk has determined and has certified in writing that the anticipated value of such contract for professional services, having a term of one (1) year, would exceed \$17,500;

WHEREAS, approval of such contract would comply comply with the Local Pay-To-Play Law, N.J.S.A. 19:44A-20.5, effective January 1, 2006, which except in prescribed circumstances prohibits the award of contracts with a value in excess of \$17,500 to any person or business entity which makes reportable contributions to local political or candidate committees representing members of the governing body;

WHEREAS, the appointee has made no such political contribution and shall make no such contribution during the term of the contract;

WHEREAS, approval of such contract would also comply with Chapter 15, Article I of the Code of the Borough of Pennington which prohibits certain political contributions by professional business entities regardless of the value of the contract;

WHEREAS, Hodulik and Morrison, a Division of PKF O'Connor Davies, has completed and submitted a sworn Business Entity Disclosure Certification which certifies that the firm has made and shall make no political contribution prohibited by the relevant provisions of either the statute or the Borough Code concerning pay-to-play;

WHEREAS, this contract is being awarded as a professional services contract in compliance with the Local Public Contracts Law, <u>N.J.S.A.</u> 40A:11-1, <u>et seq.</u>, without advertising for proposals or competitive bidding, because the services contracted for are of such a qualitative nature as will not reasonably permit the drawing of specifications or the receipt of competitive bids;

WHEREAS, Hodulik and Morrison, P.A. a Division of PKF O'Connor Davies, proposes to continue to serve as Borough Auditor for fees not to exceed in the aggregate \$39,850.00 for the following services: annual audit of the Borough (\$24,500.00); preparation of annual financial statement (\$6,500.00); preparation of annual debt statement (\$1,350.00); audit of the Pennington Library (\$5,500.00) and Municipal Budget (ADS) \$2,000.00;

WHEREAS, Hodulik and Morrison, a Division of PKF O'Connor Davies, shall perform such additional professional services as may be requested from time to time by the Borough at the following hourly rates: Principal - \$190.00; Manager - \$175.00; Senior Associates - \$140.00; Associate - \$115.00 - \$130.00, and as further set forth in the attached letter of engagement dated December 12, 2022 provided aggregate fees under this contract, including expenses, shall not exceed \$39,850.00 without the prior written approval of Borough Council;

WHEREAS, Hodulik & Morrison, a Division of PKF O'Connor Davies, shall comply with requirement for Anti-Discrimination and Affirmative Action as set forth in the annexed Schedule A:

WHEREAS, the Chief Financial Officer of the Borough has certified that funds are available for the purpose of this contract under Finance, Library and in the Water/Sewer Utility budget;

PENNINGTON BOROUGH RESOLUTION NO. 2023 - 1.3

RESOLUTION APPOINTING WALTER R. BLISS, JR. AS BOROUGH ATTORNEY FOR THE YEAR 2023

- **WHEREAS**, the Borough of Pennington has a need to appoint a Borough Attorney and to contract for related professional legal services in the year 2023;
- **WHEREAS**, the Borough Clerk has determined and has certified in writing that the anticipated value of this contract for professional services, having a term of one (1) year, will exceed \$17,500;
- **WHEREAS**, approval of this contract complies with the Local Pay-To-Play Law, N.J.S.A. 19:44A-20.5, effective January 1, 2006, which except in prescribed circumstances prohibits the award of contracts with a value in excess of \$17,500 to any person or business entity which makes reportable contributions to local political or candidate committees representing members of the governing body;
- **WHEREAS**, such political contributions are permitted by the statute only if the municipality has elected to award the contract through a competitive process involving a publicly advertised request for proposals and a review process based on written procedures and criteria prescribed in advance by the governing body or as otherwise provided by law;
- **WHEREAS**, the appointee has made no such political contribution and shall make no such contribution during the term of the contract;
- **WHEREAS**, approval of this contract also complies with Chapter 15, Article I of the Code of the Borough of Pennington which prohibits certain political contributions by professional business entities regardless of the value of the contract;
- **WHEREAS**, this contract is being awarded as a professional services contract in compliance with the Local Public Contracts Law, <u>N.J.S.A.</u> 40A:11-1, <u>et seq.</u>, without advertising for proposals or competitive bidding, because the services contracted for are of such a qualitative nature as will not reasonably permit the drawing of specifications or the receipt of competitive bids;
- **WHEREAS**, Walter R. Bliss, Jr. has served as Borough Attorney and proposes to continue to serve in this capacity in both litigation and non-litigation matters at the billing rate of \$125 per hour, plus reimbursement for reasonable out-of-pocket expenses;

- **WHEREAS**, Mr. Bliss has completed and submitted a sworn Business Entity Disclosure Certification which certifies that neither he nor his firm has made nor shall make any political contribution prohibited by the relevant provisions of either the statute or the Borough Code concerning pay-to-play;
- **WHEREAS**, Mr. Bliss shall comply with requirements for Anti-Discrimination and Affirmative Action as set forth in the annexed Schedule A;
- **WHEREAS**, the Chief Financial Officer of the Borough has certified that funds are available for the purpose of this contract in budget line #: 3-01-20-155-000-261;
- **WHEREAS**, the Local Public Contracts Law requires that a resolution authorizing an award of contract for professional services without competitive bid be publicly advertised following adoption;

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Pennington that Walter R. Bliss, Jr. be appointed as Borough Attorney of the Borough of Pennington for a period of one year in compliance with applicable law;

PROFESSIONAL SERVICES AGREEMENT

AGREEMENT, made as of the day of January, 2023, by WALTER R. BLISS, JR., ESQ., 310 West State Street, Trenton, New Jersey 08618 (hereafter referred to as "Attorney") and the BOROUGH OF PENNINGTON, 30 North Main Street, Pennington, New Jersey 08534 (hereafter referred to as the "Borough");

WHEREAS, the Borough and Attorney desire to enter into an agreement for the performance by Attorney of professional services on behalf of the Borough, in the capacity of Borough Attorney, for the period of one year;

NOW, THEREFORE, in consideration of the obligations hereafter set forth, the parties hereto agree as follows:

- 1. **STATEMENT OF WORK.** Attorney shall serve as Borough Attorney and perform such professional legal services for the Borough as directed by Mayor and Council, the Borough Clerk and the Borough Administrator. Under this Agreement, Attorney shall at all times act as an independent professional contractor and not as an employee of the Borough and shall have no authority to act as an agent or representative of the Borough or to enter into any financial or other contractual commitment on behalf of the Borough without the prior written approval of same granted in accordance with law.
- 2. **TERM.** This Agreement shall be effective as of **January 1**, **2023** through **December 31**, **2023** unless sooner terminated as provided hereafter.

3. **PAYMENT.**

- (a) *Fee Paid.* For services performed hereunder during the term of this Agreement, the Borough shall pay Attorney a fee of \$125 per hour for his services and for the services of any legal counsel associated with the Law Offices of Walter R. Bliss Jr., if needed. There shall be reimbursement for approved travel @ \$.57.5/mile, transcription fees and other out-of-pocket costs relating to litigation, photocopying expenses and the costs of postage and express delivery services. The foregoing fees and reimbursements shall constitute the sole and exclusive compensation due Attorney under this Agreement.
- (b) *Rendition of Invoices*. Payment of fees and reimbursements will be made upon submission of invoices and vouchers, to the Borough Administrator, in the form prescribed by the Borough, promptly following the month covered by the invoice. These invoices shall specify in detail the periods for which fees are claimed and the services performed.
- (c) Budget Cap. Total fees payable to Walter R. Bliss, Jr. and the Law Offices of Walter R. Bliss, Jr. in 2023 shall not exceed \$55,000 without the prior written

approval of Borough Council except pursuant to a separate contract addressed to a specific matter.

- 4. **TERMINATION.** This Agreement shall be effective for the period provided above, although it may be sooner terminated with or without cause, for any reason whatsoever, at any time, by either party giving seven (7) days written notice to the other.
- 5. **CONFLICTS OF INTEREST.** Attorney represents that neither he nor his firm is now performing nor will perform during the period of effectiveness of this Agreement any legal or other services for any person, firm or corporation which results or might result in a conflict of interest between Attorney and the Borough, directly or indirectly. Attorney agrees to disclose promptly any and all such conflicts of interest in writing to the Borough, giving full particulars.
 - 6. TITLE TO PROPERTY PRODUCED BY ATTORNEY. Attorney agrees that

title to and all rights and other legal interests in all correspondence, memoranda, records, data, analyses, graphs, reports, physical property and other subject matter prepared, procured or produced in the rendition of services hereunder shall vest and remain jointly with the Borough and Attorney, and Attorney shall not have the right to sell, disclose or make same available to third parties without the prior written consent of the Borough.

- 7. **CONFIDENTIALITY.** Attorney agrees to treat and maintain as confidential and not disclose to any third party or to use for his own benefit, reproduce or have reproduced, any information or other such document or data obtained, learned or produced as a result of the services rendered hereunder (except to the extent required by law) without the prior written consent of the Borough, which consent shall not be refused unreasonably.
- 8. **COMPLIANCE WITH PAY-TO-PLAY LAWS.** This contract has been awarded to Attorney based on the ability of Attorney to provide the services as described herein following public advertisement for competitive proposals. The undersigned does nonetheless hereby attest that Attorney, its subsidiaries, assigns or principals controlling in excess of 10% of the company has neither made a contribution that is reportable to the Election Law Enforcement Commission pursuant to N.J.S.A. 19:44A-8 or 19:44A-16 in the one (1) year period preceding the award of the contract that would, pursuant to P.L. 2004, c.19, affect his or its eligibility to perform this contract, nor will he or it make a reportable contribution during the term of the contract to any political party committee in the Borough of Pennington if a member of that political party is serving in an elective public office of the Borough when the contract is awarded, or to any candidate committee of any person serving in an elective public office of the Borough of Pennington when the contract is awarded.
- 9. **COMPLIANCE WITH OTHER LAWS.** This Agreement is entered into in accordance with and subject to compliance with the Local Public Contracts Law of New Jersey, and the specific provision of N.J.S.A. 40A:11-5(a) thereof pertaining to professional services.

AGREEMENT BETWEEN BOROUGH AND VAN NOTE-HARVEY ASSOCIATES, PC FOR PROFESSIONAL SERVICES TO PENNINGTON BOROUGH

THIS AGREEMENT is made this day of January, 2023, by and between the BOROUGH OF PENNINGTON, 30 North Main Street, Pennington, New Jersey 08534 ("BOROUGH") and VAN NOTE-HARVEY ASSOCIATES, PC, a New Jersey professional corporation having its principal office at 103 College Road, 3rd Floor, Princeton, New Jersey 08540 ("VNHA"), whose designated representative is **Brandon Fetzer**, P.E., hereinafter referred to as "ENGINEER."

WHEREAS, the BOROUGH seeks to retain VNHA to provide consulting engineering services to the Borough of Pennington through ENGINEER and such other of VNHA's professional and technical staff as may be required to perform the work;

 - 4. Applicable fees and related procedures shall be as follows:
- A. The services of ENGINEER (Brandon Fetzer) will be billed to the BOROUGH at a rate of \$ per hour.
- B. The services of the engineering and other professional and technical staff of VNHA, unless otherwise agreed in connection with a specific project, will be billed according to the "Fee Schedule" attached hereto.
- C. Prior to the start of any project, VNHA will provide the BOROUGH with a proposal that outlines the scope of engineering and related services required for the project, time frames for the performance of such engineering and related services, and the estimated costs of same. If services by VNHA in connection with a particular project are to be performed on a fixed fee basis, BOROUGH will make payment of such fixed fee in proportion to work completed.
- D. No work shall begin in connection with any project until the BOROUGH has issued and delivered to VNHA or the ENGINEER a purchase order for the work. The BOROUGH shall not pay for work done without a purchase order or prior to the receipt of a purchase order. The BOROUGH also shall not pay charges in excess of the purchase order amount.
- E. Reimbursable expenses shall be billed to the BOROUGH in accordance with the attached Fee Schedule.

F. Total annual fees for services pursuant to this agreement, including expenses, shall not exceed \$71,750 without the prior written approval of Borough Council.

- 5. Because of the professional relationship herein established, the parties agree that either party may terminate this agreement, with or without cause, upon thirty (30) days written notice to the other party.

The undersigned does hereby attest that ENGINEER and VNHA, its subsidiaries, assigns or principals controlling in excess of 10% of the company has neither made a contribution that is reportable to the Election Law Enforcement Commission pursuant to N.J.S.A. 19:44A-8 or 19:44A-16 in the one (1) year period preceding the award of the contract that would, pursuant to P.L. 2004, c.19, affect his or its eligibility to perform this contract, nor will he or it make a reportable contribution during the term of the contract to any political party committee in the Borough of Pennington if a member of that political party is serving in an elective public office of the Borough when the contract is awarded, or to any candidate committee of any person serving in an elective public office of the Borough of Pennington when the contract is awarded.
- 7. This Agreement is entered into in accordance with and subject to compliance with the Local Public Contracts Law of New Jersey, and the specific provision of N.J.S.A. 40A:11-5(a) thereof pertaining to professional services. - 3. The chairpersons and members of the above committees and the above liaisons shall be appointed by the Mayor with the advice and consent of Council.

RESOLUTION RE-ESTABLISHING THE HOPEWELL VALLEY GREEN TEAM

WHEREAS, the governing bodies of Hopewell Borough, Hopewell Township and Pennington Borough recognize a need to develop "green" initiatives to create a plan for a healthy economy, environment and society in Hopewell Valley; and

WHEREAS, the governing bodies of Hopewell Borough, Hopewell Township and Pennington Borough desire to identify and support green, sustainable practices which benefit our residents and business partners that are easy to replicate and affordable to implement; and

WHEREAS, the Borough of Hopewell, the Township of Hopewell and the Borough of Pennington have each resolved to participate in SUSTAINABLE JERSEYTM, a certification program for municipalities in New Jersey that want to go green, control costs and save money, and take steps to sustain their quality of life over the long term; and

RESOLUTION FIXING THE RATE OF INTEREST AND YEAR-END PENALTY FOR DELINQUENT REAL ESTATE TAX PAYMENTS AND FURTHER AUTHORIZING THE TAX COLLECTOR TO EXTEND THE GRACE PERIOD FOR THE 3RD QUARTER TAX PAYMENTS FOR 2023 IF NECESSARY

WHEREAS, R.S. 54:4-67 permits the governing body of each municipality to fix the rate of interest to be charged for nonpayment of taxes or assessments on or before the date when they would become delinquent, subject to maximum rates provided by law;

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Pennington, County of Mercer, State of New Jersey, that property taxes shall be due and payable quarterly on February 1st, May 1st, August 1st, and November 1st of each year with a ten-day grace period, after which such taxes, if remaining unpaid, shall become delinquent and interest shall be charged thereon from the date the tax was first payable to the date of actual payment, at the following rates: eight percent (8%) per annum on the first \$1,500 of the delinquency and eighteen percent (18%) per annum on any amount in excess of \$1,500.; and

BE IT FURTHER RESOLVED, that payments on delinquent accounts shall be credited first to the first \$1,500 of the delinquency and then to the balance of the delinquency, and once the first \$1,500 of the delinquency has been paid, the interest rate shall be eighteen percent (18%) on the balance of the delinquency regardless of the amount of such balance; and

BE IT FURTHER RESOLVED, that a year-end penalty of six percent (6%) shall be assessed on the last day of the fiscal year on the full amount of delinquent accounts with delinquencies in excess of \$10,000.; and

BE IT FURTHER RESOLVED, that the Pennington Borough Council hereby authorizes the Tax Collector to extend the grace period for third quarter 2023 tax payments; and

BE IT FURTHER RESOLVED that the Tax Collector shall determine the extension period upon receipt of the 2023 Final Tax Bills and said period shall not exceed 30 days beyond the mailing date of the bills to taxpayers.

BE IT FINALLY RESOLVED that a certified copy of this resolution be forwarded to the Tax Collector and Borough Auditor.
