Gary - purchased the sanitary control easement. Will be working on the well beginning sometime after Thanksgiving.

Fire Chief James Longbrake - events with the schools and daycares, sent a guy overseas to help. He is working to get acquainted with everything.

Assistant Fire Chief Andrew Economedes- EMS is now 75% of their run volume now. Still considering the ESD for EMS and Fire. Ambulance is coming and depending on funding, they may start staffing part time within 2 years. MUDs could help speed this up.

Kelly Goudeau- new carpet and it is gorgeous. Wants to get the entryway painted and get a drop box.

7. Discussion with Mark Allen regarding the Rockwood Municipal Utility District.

Mark Allen regarding the Rockwood MUD - Introduced himself. Developer and live and work out of Ft. Worth. Do buisness in lots of municipalities. Prior to 6 months ago, they just planned to purchase the property in the ETJ only and not work with the Town. Lately they have had conversations with the Mayor and the Engineers regarding working with the Town. He provided an outline of what will be in the agreement. See below.

Town will consent to the MUD creation.

Town may annex once all of debt is paid off (20-30 years)

Water/Wastewater - MUD will be essentially paying for themselves, will provide their own water within their MUD with fire protection, pay for it all and then donate it to the Town and sell water back to the residents of the district. Sewer would drain all of the sewer into the Town's existing sewer plant and pay for any upgrades necessary for this at 100% cost of the MUD. Infrastructure would be donated to the Town once it is completed.

Permitting stage - \$2000 connection fee to Ponder.

Preferred if they can actually participate in bring UTRWD water or another source of surface water to the Town.

Sewer Plan B is to construct an on-site sewer treatment plant to be self-sufficient and paid for entirely by the MUD

Development of Property - Property is to be developed per the Ponder subdivision ordinance with a few exceptions. Plants and construction plans will be reviewed and approved by the Town and the Town's Engineer.

Homebuilding permits are to be obtained through the Town.

Proposing an ILA stating that all of the sales tax dollars, 1/2 will go to the Town. Said that he plans to start talks back up with the PVFD.

Mike Anderson - One of the things that he is trying to do is to come up with things that are mutually beneficial. One thing that they are trying to do is to make improvements for all of the MUDS to sort out the sewer and have a meeting set up with Thomas KH to discuss this. Meeting with the City of Denton to purchase water from them (sorting this out now). Improvements at Robinson rd pump station and the well and what can these folks do to help up with a solution for everyone. Should hear back from Denton and have the option of getting water from UTRWD. Will try to bring a plan to the Council that works for the Town. The great new about these projects is that they fall in line with improvements that can be done fairly easily ased on their placement.
