MINUTES

REGULAR SESSION AGENDA

CALL TO ORDER

Mayor Pool called the meeting to order at 6:00 pm.

ROLL CALL

He reported that the PD is also working to get a multi department training going,

that will include PISD, Justin, Krum and Ponder PD and FD for active shooter training and will meeting quarterly.

Gary Morris reported that the Ferti crossing is beginning and the back up generators should be arriving soon.

Matthew Poole reported that he has been in meetings with BNSF and are making good progress toward moving the passing tracks north of Town to avoid the crossings being blocked. He also reported that Sonic is back on.
