Commented on an agenda item regarding conference attendance, noting that \$2,000 per person was being allocated. Stated that in 2024 the stipend for board members attending conferences was \$800, later increased to \$1,000, then \$1,500, and now \$2,000. Requested a discussion and justification for the increase.

Corporate property tax decreased from \$299,407 to \$295,694 based on the Boone County 2024 tax evaluation.

State video gaming tax increased from \$130,000 to \$135,000 based on prior year activity.

State replacement tax decreased from \$10,665 to \$7,000 due to a prior year error corrected by the Illinois Department of Revenue.

Municipal utility tax (electricity) decreased from \$135,000 to \$120,000 based on prior year activity.

Local Roads and Rebuild Illinois funding increased from \$90,000 to \$120,000.

CIP Local Grant revenue decreased from \$10,000 to \$0 as it is recorded in the General Obligation Fund.
