#### **ORDINANCE NO. 2023-05**

### AN ORDINANCE ADOPTING A CAPITAL ASSET POLICY FOR THE VILLAGE OF POPLAR GROVE, ILLINOIS AND AMENDING TITLE I ADMINISTRATION, CHAPTER 6 VILLAGE OFFICERS AND EMPLOYEES, ARTICLE B VILLAGE TREASURER

WHEREAS, the Village of Poplar Grove ("Village") wishes to adopt a Capital Asset Policy ("Policy") governing treatment of capital assets owned by the Village; and,

WHEREAS, the Village Treasurer has proposed a Policy for the Village attached to this Ordinance as Exhibit A, and incorporated herein; and,

WHEREAS, the Village wishes to adopt the Policy proposed by the Village Treasurer; and,

WHEREAS, the Village has enacted Code of Ordinances ("Code"); and,

WHEREAS, Title I, Chapter 6, Article B of the Code sets forth the duties of the Village Treasurer; and,

WHEREAS, the Village wishes to amend Title I, Chapter 6, Article B of the Code to reflect the adoption of the Policy.

NOW THEREFORE, be it ordained by the President and Board of Trustees for the Village of Poplar Grove, Illinois, as follows:

- 1. The above recitals are incorporated herein and made a part hereof.
- 2. The Capital Asset Policy attached to this Ordinance is hereby approved.
- 3. Title I, Administration, Chapter 6, Village Officers and Employees, Article B, Village Treasurer, of the Code of Ordinances for the Village of Poplar Grove, shall and hereby is amended to add a new Section 1-6B-7 entitled "Capital Asset Policy" and which new section shall read as follows:

#### Sec. 1-6B-7- Capital Asset Policy

The Village shall have in place a Capital Asset Policy setting forth rules governing the treatment of capital assets owned by the Village. The Capital Asset Policy shall be amended from time to time as is necessary. The Capital Asset Policy shall be available in the office of the Village Treasurer.

4. All other provisions of Article B of the Village Code of ordinances shall remain in effect unchanged and unamended by this Ordinance.

# **Exhibit A—Capital Asset Policy**

# VILLAGE OF POPLAR GROVE ORDINANCE NO. 2023-06

AN ORDINANCE TRANSFERRING APPROPRIATED FUND BALANCE TO ESTABLISHED CORPORATE OBJECTS AND PURPOSES (CAPITAL IMPROVEMENT FUND) FOR THE VILLAGE OF POPLAR GROVE, ILLINOIS FOR THE FISCAL YEAR BEGINNING MAY 1, 2022 AND ENDING APRIL 30, 2023 (FY 2023)

WHEREAS, the Village of Poplar Grove, Illinois ("Village") is an Illinois municipal corporation;

WHEREAS, in anticipation that there could be reduced revenues to the Village in fiscal year 2022, the Village appropriated revenues conservatively for 2022; and

WHEREAS, revenues for fiscal year 2022 did not come in as low as anticipated which has resulted in an unappropriated fund balance of approximately \$600,000.00 in the Village's General Fund; and

WHEREAS, Village desires to transfer up to \$500,000.00 of unappropriated fund balance from the General Fund to its Capital Improvement Fund for future use on capital improvement projects; and

WHEREAS, the Village has determined that such transfer is in the best interest of the Village and its citizens.

NOW, THEREFORE, BE IT ORDAINED by the Village President and Board of Trustees of the Village of Poplar Grove, Illinois:

<u>Section 1:</u> That the fiscal year for the Village of Poplar Grove for the purpose of this ordinance transferring fund balance amounts to established objects and purposes shall begin on the 1st day of May, 2021 and end on the 30<sup>th</sup> day of April, 2022 (FY 2022).

<u>Section 2:</u> That the transfer specified in EXHIBIT A, attached hereto and made a part hereof, from unappropriated fund balance in the General Fund to an established object or purpose is hereby made for the year defined in Section 1. Such amounts transferred shall remain unappropriated amounts until such time as appropriated by the Village.

<u>Section 3.</u> In addition to the transfers made in Section 2, the Village Treasurer is hereby authorized and directed to make the transfers deemed necessary to accommodate the recording of expenditures on the modified accrual basis of accounting as required by generally accepted accounting principles. Any transfers made based upon the authority granted in this section are to be submitted to the Village Board for approval before the audited financial statements of the Village of Poplar Grove are issued for the year defined in Section 1.

<u>Section 4.</u> That in the event any general or specific item, or portion thereof, of this Budget Transfer Ordinance is, for any reason, held invalid, such invalidity shall not affect the validity of the remaining portion or portions of this Ordinance.

<u>Section 5.</u> That this Ordinance shall be effective immediately upon its due publication in pamphlet form as required by law.

# A SUPPLEMENTAL APPROPRIATION ORDINANCE OF THE VILLAGE OF POPLAR GROVE, ILLINOIS FOR THE FISCAL YEAR BEGINNING MAY 1, 2022 AND ENDING APRIL 30, 2023

**WHEREAS,** the Village Board of the Village of Poplar Grove, Illinois ("Village Board"), caused to be adopted an Annual Appropriation Ordinance for fiscal year beginning May 1, 2022 and ending on April 30, 2023; and

**WHEREAS,** Illinois statutes (65 ILCS 5/8-2-9) provides that the Village Board may adopt a supplemental appropriation when additional revenues were received or where sufficient fund balances are available that were not originally appropriated; and

**WHEREAS**, the Village has received additional monies which it did not anticipate receiving in this fiscal year beginning May 1, 2022 and ending April 30, 2023 and now desires to appropriate these additional monies as a part of this fiscal year beginning May 1, 2022 and ending April 30, 2023; and

**WHEREAS,** the additional monies to be appropriated as a part of this fiscal year beginning May 1, 2022 and ending April 30, 2023 are set forth in Exhibit A, attached hereto and incorporated herein.

NOW THEREFORE, be it ordained by the President and Village Board of Trustees of the Village of Poplar Grove, Illinois as follows:

- Section 1: The above recitals are incorporated herein and made a part hereof.
- Section 2: That the additional amounts set forth in <u>Exhibit A</u> hereto, or so much thereof as may be authorized by law and as may be needed, are hereby appropriated for the corporate purposes of the Village of Poplar Grove, Illinois to defray all necessary expenses of said Village, for the fiscal year beginning May 1, 2022 and ending April 30, 2023. Additional expenses to be budgeted for the fiscal year beginning May 1, 2022 and ending April 30, 2023 are also denoted on <u>Exhibit A</u>.
- Section 3: That by a vote of two-thirds of the President and Village Board, this Supplemental Appropriation Ordinance may be revised by deleting, adding to, changing, or creating new objects or purposes for which appropriations have been or may be made. No revision of this ordinance shall be made by adding to the total amount appropriated unless additional funds have been made available during the fiscal year in the amount of the total appropriation so increased.
- Section 4: This Ordinance and the associated powers designated herein shall become effective immediately upon passage by the Corporate Authorities of the Village of Poplar Grove.
