STIPULATION

WHEREAS, the aforementioned corporation (hereinafter “Corporation”) has been charged pursuant to Village Ordinance with a violation of Village of Poplar Grove Code of Ordinances Section 2-10-18 as specified in the Notice of Hearing dated May 19, 2025; and

WHEREAS, on May 19, 2025, the Village Board provided notice to Donald L. Shriver, Registered Agent, and Angela Daniels, President, on behalf of said Corporation of a hearing to be held by the Village Board on June 25, 2025; and

NOW THEREFORE, the undersigned, being the authorized representative of J & D, Inc., d/b/a J & D Countryside Marathon, Poplar Grove, Illinois, hereby agrees to the following stipulation regarding the above-captioned matter:

1. That on May 15, 2025, a violation of Village of Poplar Grove Code of Ordinances Section 2-10-18 took place at J & D, Inc., d/b/a J & D Countryside Marathon, 13615 IL 76, Poplar Grove, Illinois (“Corporation”).
2. That a Notice of Hearing of the violation of Village of Poplar Grove Code of Ordinances Section 2-10-18 was sent to the Registered Agent and to the President of the Corporation on May 19, 2025, setting the hearing for June 25, 2025.
3. That the Corporation chose not to challenge or deny a violation of Village of Poplar Grove Code of Ordinances Section 2-10-18 as specified in the Notice of Hearing.
4. That the Corporation agrees to pay fines in the amount of \$400.00 for its second violation within a twenty-four (24) month period of Village of Poplar Grove Code of Ordinances Section 2-10-18 as authorized by Section 2-10-19 of the Ordinances of the Village of Poplar Grove.

5. That the Corporation also acknowledges that it stipulated to a violation of Village of Poplar Grove Code of Ordinances Section 2-10-18 on April 10, 2025, and agrees that if another violation of Village of Poplar Grove Code of Ordinances Section 2-10-18 occurs within the twenty-four (24) month period from April 10, 2024, the Corporation will be subject further fines and possible suspension or revocation of its tobacco license as set forth in Sections 2-10-18 and 2-10-19 of the Ordinances of the Village of Poplar Grove. If no further violation occurs prior to April 10, 2026, a twenty-four (24) month period for calculating a second violation shall begin on June 25, 2025.
6. That the fines and costs set forth in Paragraph 2 shall be due and payable within 30 days.
7. That in consideration for the terms of this stipulation presented by the Village, the Licensee and/or corporation, on behalf of its owners, agents, assigns or successors in interest, agrees that it shall not appeal the suspension or fines, costs and attorneys' fees imposed herein to any administrative or judicial authority.
8. That any failure to comply with the terms of this stipulation by the license holder and/or corporation, on behalf of its owners, agents, assigns or successors in interest shall invalidate the terms of this stipulation, and the Village shall have the right to immediately impose all penalties, including suspensions, upon the license holder and shall have the right to impose such further penalties as are permitted under Village ordinances and state statute.



STIPULATION

WHEREAS, Poplar Grove Pacemaker, LLC Countryside Markets, Cuppa Joe (hereinafter “Licensee”) has been charged pursuant to Village Ordinance with a violation of Village of Poplar Grove Code of Ordinances, Section 2-10-18 as specified in the Notice of Hearing dated May 23, 2025, and served upon Anthony J. Dal Pra, agent of Licensee; and

WHEREAS, on May 23, 2025, the Village Board provided notice to Anthony J. Dal Pra, Registered Agent, on behalf of said Licensee, of a hearing to be held by the Village Board on June 25, 2025; and

NOW THEREFORE, the undersigned, being the authorized representative of Licensee hereby agrees to the following stipulation regarding the above-captioned matter:

- 1. That the Licensee chose not to challenge or deny the violation of Village of Poplar Grove Code of Ordinances Section 2-10-18 as specified in the May 23, 2025, Notice of Hearing.

- 2. That the Licensee agrees to pay fines in the amount of \$200.00 for the violation of the Village of Poplar Grove Code of Ordinances Section 2-10-18 as authorized by Section 2-10-19 Ordinances of the Village of Poplar Grove. The Licensee also agrees that if another violation of the ordinances occurs within a twenty-four (24) month period from the violation date of May 15, 2025, the Licensee will be subject to suspension or revocation of its tobacco license.

- 3. That the fines and costs as set forth in Paragraph 2 shall be due and payable to the Village within 30 days from the date of this Agreement.

- 4. That in consideration for the terms of this stipulation presented by the Village, the Licensee, on behalf of its owners, agents, assigns or successors in interest, agrees that it shall not appeal the fines, costs and/or attorneys’ fees imposed herein to any administrative or judicial authority.

5. That any failure to comply with the terms of this stipulation by the Licensee shall invalidate the terms of this stipulation, and the Village shall have the right to immediately impose all penalties, including license suspension/revocation, upon the Licensee and shall have the right to impose such further penalties as are permitted under Village ordinances and state statute.


