### **CALL TO ORDER**

Vice Chairwoman Olga Szela called the meeting to order at 12:05 p.m. and presided.

#### 1. General discussion and hear statements from citizens.

Michael Sanchez, local artist, was in attendance and presented an updated draft to the paintings he is working on for Lighthouse Beach bathrooms next to the mural recently completed. The board received the updated draft drawings and discussed. Board member Dina Smith suggested excluding the words boy or girl from the drawing. The board agreed that the symbols illustrating girl/boy on the drawing were sufficient.

Vice Chairwoman, Olga Szela also announced that the next Recreation and Parks Board Meeting would be Wednesday, November 15, 2023 at 12:00 p.m.

## 2. Approve minutes from the regular meeting held September 20, 2023.

## 3. Receive Parks & Recreation Operations and Maintenance report from Director of Public Works.

Public Works Director Wayne Shaffer was absent. Parks Superintendent Edward reported that the park's crew has been continuing regular maintenance at all the parks. He stated that the park's crews finalized the updates to the volleyball court at the City Park and at the swing set at George Adams Park. Tyler also added that due to the rain they were behind on mowing but were working diligently to catch up.

### 4. Receive Monthly Inspections Report from Public Works Department.

The board reviewed and discussed the playground inspections report.

No additional comments were made.

## 5. Receive update on park assignments from park board members.

Board Member Kevin Kuntschik's Park assignments are Claret Crossing. He reported that the park needs mowing but overall the park look good.

Board Member Dina Smith's Park assignment is Lighthouse Beach. Smith stated the park overall looks good. She mentioned that there were car stops missing by the boat ramp. Tyler informed the board that the car stops were ordered and would be installed within the next weeks. She also mentioned that the tree stump on site eight had a lot of sucks from root. Tyler told her that they constantly grow even when cleaned up.

Board Member Nicholas Lowry's Park assignment is Butterfly Park. Lowry stated the park overall looks very good.

Board Member Mark Howell's Park assignment is George Adams Park. Howell stated the park overall looks very good. He added that the new playground equipment looks good and the bathrooms were clean.

Vice Chairwoman Olga Szela's Park assignment is City Park. She stated that the volleyball court looks great.

### 6. Receive financial status report on the Parks Recreation Department

The financial status were reviewed and discussed.

Interim City Manager Jody Weaver stated that October 1<sup>st</sup> starts a new budget year for the City of Port Lavaca. Weaver gave a brief explanation on how the budget process for the city parks works.

### 7. Receive and discuss Brookhollow Estates Pocket Park (Butterfly Park) survey results.

Interim City Manager presented and discussed the survey results for the Brookhollow Estates Park.

# 8. Receive report on the project submitted for funding from the Matagorda Bay Mitigation Trust Fund to contribute to the Downtown Waterfront Masterplan.

Interim City Manager Jody Weaver informed the board that the project submitted for funding from the Matagorda Bay Mitigation Trust Fund would construct bulkhead for 3 public transient boat slips and a public dock (deck) for fishing and crabbing. Weaver added that City Council has penciled in funding for improvements to the parking area behind Nautical Landings. She added that the idea behind the transient boat spaces would be so that people can safely park their boat while they get out to get bait, or take a break and walk along the walkway at Bayfront Park or Downtown or attend one of our Park events or enjoy a refreshing drink at Tipsy Bean, etc. She ended with stating that in the near future, Poor Boy Bait may be moving about 50 ft to the north, so additional transient slips can be provided later depending of the popularity of the current slips.
