I also received a call from the Corps of Engineers that they changed their minds, and they will NOT require us to plant any Spartina grass. Matt Glaze and I are working to submit the proper documentation to TCEQ to close this project out.

# b) <u>CRG Limited Phase II Environmental Site Assessment of Harbor of Refuge Tracts 16, 17, and 17A - Presenter Jody Weaver</u>

• Interim City Manager Weaver advised Commissioners; there is no new information to report except that the CRG invoice of \$27,704.00 for the additional work has been paid. This was slightly under their proposal amount, as they didn't need all the analytical time that had been budgeted. We now await TCEQ's response.
