## City Council Meeting Brief July 11, 2023

#### **Consent Agenda**

1. Regular Meeting Brief 6-27-2023

# Councilor Howard made a motion to approve consent agenda as presented. Motion seconded. No discussion on motion. Motion carried.

#### Visitors, Appearances and Requests

No one came forward.

#### **Council Presentations**

2. EDCO Presentation – Kelsey Lucas

Ms. Lucas went through a power point presentation that highlighted projects by community, the types of industry they are, and total pending projects in Crook County. There are projects in advanced manufacturing, building products, high-tech, aviation/aerospace, renewable energy, agriculture, and food processing.

Annual average wages have risen as well reaching just under \$75,000 per year. Crook County has the third highest annual average wage in the state of Oregon.

Ms. Lucas continued her presentation by noting the top ten employers in Crook County.

The EDCO Fall Mixer has been scheduled for September 14, 2023.

Ms. Lucas went through the results of the Center on Rural Innovation (CORI) analysis noting Crook County's worker chained dollars exceeded rural comparators and Deschutes County. Also highlighted was the share of employment for top industries, employment by sector, and entrepreneurship is increasing in Crook County. 12.3% of workers in Crook County work in companies that are less than five years old.

The presentation continued with information on where people are moving from to Prineville and where people are moving to from Prineville which is considerably less than moving in.

We received good feedback and comments regarding how well we are doing.

There were no questions.

#### **Council Business**

3. Consideration of a Proclamation – July Parks & Recreation Month – Councilor Uffelman

Councilor Uffelman talked about how important it is and said Parks & Recreation should be a bigger part of who we are and feels the proclamation stands on its own merit.

# Councilor Uffelman made a motion to approve the proclamation. Motion seconded. No discussion on motion. All in favor, motion carried.

4. Council Vacancy Decision – Steve Forrester / Lisa Morgan

Lisa Morgan, City Recorder/Risk Manager explained the interviews for the three candidates were held prior to the last meeting and now they have two options 1). To make a motion to nominate one of the candidates and a vote would take place or 2). Re-advertise to get another pool of candidates.

Councilor Uffelman feels Dr. Greenberg is a strong candidate, but feels Marv Sumner would be prepared to step right in.

Mayor Beebe agrees with Councilor Uffelman but would like to nominate Dr. Greenberg, but she doesn't live in city limits.

Jered Reid, City Attorney went through the qualifications for a Council position.

Councilor Smith feels Dr. Greenberg would be a great asset to the city but doesn't want to open a can of worms regarding living in city limits.

Councilor Merritt agreed.

Councilor Uffelman made a motion to nominate Marv Sumner to fill the Council vacancy. Motion seconded. No discussion on motion. All in favor, motion carried.

#### 5. City Manager's Mid-Year Review Process

Mayor Beebe explained that he would like to put out a new process for mid-year reviews and not go through such an extensive review as the year end.

Mr. Forrester said that this is typical of what we do with staff and the mid-year is more or less just a check in to make sure we stay on track.

Council Merritt said she has felt it doesn't need to be as extensive as the year-end process for some time.

Councilor Uffelman would like to see a list of categories and a summary of what was discussed at the year-end to review.

The Council is in consensus to make the mid-year review to just review the year-end review.

There will be an executive session at the next meeting and Mayor Beebe will have everything out to everyone.

#### **Staff Reports and Requests:**

6. City Manager's Report-Steve Forrester

Steve Forrester, City Manager presented his report highlighting recent activities in all departments.

Mr. Forrester added that our water system is doing very well and we have not had to turn on the big pumps yet.

There were discussions regarding the Ochoco Irrigation District (OID) main pump project on Laughlin and that this has been being worked on with Deschutes River Conservancy (DRC) on the McKay switch because McKay has been identified as an area fish spawn.

#### **Committee Reports**

Councilor Uffelman attended the Railroad Committee meeting and stated that Jerry Evans had resigned to move away. Bill Anderson participated in the meeting and the committee is recommending that Mr. Anderson be appointed to the committee. The committee talked about

looking into the future financial strength of the railroad and that we are out of warehouse space with new businesses interested.

There were no other reports.

#### **Ordinances:**

7. Ordinance No. 1286 – Amending the City's Zoning Map Designation from Limited Residential – (SECOND PRESENTATION) – Josh Smith

Josh Smith, Planning Director explained that this is the second presentation, we did not receive any comments, Nothing has changed since the first presentation except the date at the bottom of the ordinance.

There were no questions.

Councilor Merritt made a motion to approve Ordinance No. 1286 for its second presentation. Motion seconded. No discussion on motion. All in favor, motion carried.

#### **Resolutions**

8. Resolution No. 1569 – Approving a Rate Increase for Solid Waste Franchise Services – Solid Waste Advisory Committee (SWAC) Chair Mayor Beebe

Mayor Beebe explained that we discussed this at the last meeting with the public hearing. The committee and Republic Services settled on a 10% increase which is mostly caused by the County's landfill increase of 20%.

The first motion was implied by the recommendation of the SWAC. Motion seconded. Discussion on motion that it was a prudent decision on part of the committee to recommend a lesser rate of 10% as opposed to the 13%. The committee looked at a lot of information that was given to them. Of course we try not to have those big jumps like we have had in the past, but they are kind of pressured this year. No further discussion. All in favor, motion carried.

9. Resolution No. 1570 – Authorizing Amendment to the Development Agreement Between City of Prineville and Vitesse, LLC– Casey Kaiser

Casey Kaiser, Public Works Director explained that the next two resolution are related to a combined project and has been worked on for the last couple of years. We have discussed this several times over the years.

Mr. Kaiser thanked the Council and City Manager for support to get to this point over the last couple of years for such a significant project.

Discussions continued regarding this project allowing us to inject virtually double the amount we are now into the aquifer and the County's participation in this for allowing us to drill all the test wells.

There were no further questions.

Councilor Uffelman made a motion to approve Resolution No. 1570. Motion seconded. No discussion on motion. All in favor, motion carried.

# 10. Resolution No. 1571 – Authorizing Development Agreement Between City of Prineville and Apple, Inc. – Casey Kaiser

Mr. Kaiser explained that this is the counterpart to Resolution No. 1570. This one is much simpler and participation is just in the water line part of the project.

There were no questions.

Councilor Smith made a motion to approve Resolution No. 1570. Motion seconded. No discussion on motion. All in favor, motion carried.

### **City Manager Update to Council**

#### July 25, 2023

#### Public Safety / Dispatch

The Police Department is closing in on a final offer for a lateral and will be looking at going for another round of recruitments. PD had over 400 calls for service during the races and Oregon State Police were present for traffic stops. There was good team work across the board which resulted in a big event with no injuries.

Dispatch has started the 911 system upgrade and an announcement went out for recruiting another dispatcher.

#### **Public Works**

Public Works & Planning has been working with the Downtown Association to finalize design plans for a downtown sidewalk project that will replace the sidewalks, add our new decorative lighting, and add street trees along Main Street between 3<sup>rd</sup> and 4<sup>th</sup>. Also worked with Republic Services to get new trash receptacles that will match our decorative street lights for our downtown area.

Public Works will have a new Public Works Superintendent starting on August 1<sup>st</sup> and are excited to welcome Rich Evans to the team.

The water system including the ASR system is performing very well this year and we are seeing lower water demands than last year due to not having the temperatures over 100 degrees yet like we have had in the previous few years.

Out annual street paving project are scheduled for August and the annual crack sealing projects have been completed.

Undersized and aging waterlines are being replaced in the NW 7th Street & Fairmont area.

The Wendel's donated some trees that were planted near the pollinator gardens at the wetlands this week. They will add some much needed shade to that area of the wetlands.

#### **Rail Road**

The Railroad has their request for proposals (RFP) out to begin their improvement projects.

#### **Meadow Lakes Golf**

Meadow Lakes has been busy with a couple of tournaments and has the championships coming up. Their 30<sup>th</sup> anniversary is coming up in August and the anniversary tournament is already full. They have a Special Olympic tournament coming up. They are moving forward on getting the parking lot pavement project going.

#### Airport

The Airport has remained busy and has a couple of new land leases adding to the activity up there.

#### Planning

Planning has had a big focus on completing the master plans and has started a flood assessment that is being completed by Anderson Perry. Planning is waiting on the design for the EV station to get that project going and is working on an easement with DSL for water on the other side of the airport.

Human Resources - Nothing to report.

#### **Information Technology**

IT is working on a new site development out at Stevenson Mountain that will help fill out communications gaps at the north end better. They have been working with the 911 system upgrades and will be interviewing a couple of candidates to fill a vacancy they have.

#### Finance

The interim audit has been completed and came back good. The annual audit is scheduled already for October.

EDCO remains busy with new commercial development inquiries and expansions.

#### **Public Relations**

ShanRae is putting together the summer newsletter. ShanRae also handles public relations for the irrigation districts and reports that Central Oregon Irrigation has already had to curtail irrigation water. A recent Railroad post to the city's Facebook page is doing really well and anything on the Railroad always gets a lot of engagement and shared pictures.

Monthly meetings have been established to get ahead of when the exemptions start rolling off and with Parks & Recreation to help prepare everyone get aligned on this as well.

#### **ORDINANCE NO. 1287**

#### AN ORDINANCE AMENDING ORDINANCE 1244 AND EXTENDING ZAYO GROUP, LLC'S FRANCHISE THROUGH AUGUST 30, 2028

#### RECITALS

A. City Ordinance No. 1244 grants Zayo Group, LLC a nonexclusive franchise to provide and operate a telecommunications business within the City of Prineville, and to place, erect, lay, maintain and operate in, upon, over, and under the public streets, alleys, avenues, thoroughfares, highways, places, and grounds within the City of Prineville, poles, wires, optical fiber cable, and other appliances and conductors for all telecommunication purposes.

B. Ordinance 1244 expires on August 30, 2023.

C. The parties desire to extend the franchise through August 30, 2028.

BASED UPON the above Recitals, the people of the City of Prineville ordain as follows:

1. Ordinance 1244 granting to Zayo Group, LLC the right and franchise to provide an operate a telecommunications business within the City is hereby extended to August 30, 2028, subject to the terms and conditions contained in Ordinance 1244.

2. Zayo Group, LLC, must accept the terms and conditions of this Ordinance and deliver such acceptance to City on or before August 30, 2023.
