# City Council Meeting Brief September 14, 2021

Mayor Beebe asked that the audience please stay standing after the Flag Salute and stated that he preferred to use the outdoor flags at the Fairground which includes a memorial display for the Flag Salute.

Councilor Law read a statement into the record regarding this last Saturday marking the 20<sup>th</sup> year of remembrance for the September 11<sup>th</sup> attacks. Councilor Law said he also wanted to remember the eleven (11) Marines, one (1) Soldier, and one (1) Navy Corpsman lost due to the attacks in Kabul, Afghanistan. Councilor Law stated he would like to read the names of the individuals and requested a moment of silence afterwards. Sgt. Johanny Rosario Pichardo, Sgt. Nicole Gee, Staff Sgt. Darin Hoover, Cpl. Hunter Lopez, Cpl. Daegan Page, Cpl. Humberto Sanchez, Lance Cpl. David Espinoza, Lance Cpl. Jared Schmitz, Lance Cpl. Rylee McCollum, Lance Cpl. Dylan Merola, Lance Cpl. Kareem Nikoui, Navy Corpsman Maxton Soviak, and Staff Sgt. Ryan Knauss.

There was a moment of silence.

# Additions to the Agenda

Crabby's Bar & Grill liquor license added to the consent agenda and copies were distributed to council prior to the meeting.

Mayor Beebe respectfully requested people to please don't go to the Health Department and Schools and they are just trying to do their jobs and trying to follow the regulations. It is not their fault. It is however fine and our duty to ask questions. There have been a lot of questions

being asked by everyone and St. Charles along with the Health Department will be holding a virtual town hall on October 4<sup>th</sup>. They will be taking questions between now and then to answer them during the virtual town hall.

Councilor Papke added that one of the beautiful things about our country is being able to express ourselves. Having different opinions is what makes us better. He is concerned that we have got to a point in our city and elsewhere where we have lost opportunities, understanding, cannot have a civil conversation and ultimately get to a spot to agree to disagree and still walk away friends. He sees where it is tearing us apart and feels its times like this that should draw us back together. He remembers 9/11 vividly and remembers how on 9/12 the country pulled together and wishes we could get back to that point. We are never going to agree on everything and that's okay, but how do we come together and get through this together? Instead of being ridiculed, harassed for different opinions, try to come together.

Tory Kurtz, a Crook County resident thanked council for considering the resolution.

Mandy Pucket, a Crook County resident thanked council for considering the resolution and encourages passage.

Tanisha Valenzuela a Crook County resident explained she too feels the same way about remembering exactly where she was on 9/11 and remembering the importance of what being an American means. She also would like a 9/12. Commented on what it means to be an American. I don't have to agree with you and you don't have to agree with me. Masks & mandates are not right. We have a right to wear what we want. Being an American is an honor not a privilege and we need to honor those who have fallen to protect.

Robin Ulceman, Crook County resident. She understands desire for everyone to get along and agree to disagree but knows people that are trying to decide whether or not to get the shot and keep their job or lose job. They are being coerced into getting the shot. She appreciates the council's service and knows they are in a difficult position.

Jack Ravenburg. Thanked Councilor Law and Councilor Papke for their words and took them as encouragement. Mr. Ravenburg read the definition of authoritarianism from the Oxford dictionary. He talked about getting COVID and surviving and will attend every meeting until

5. Ordinance No. 1269 – Amending Chapter Four of the City Comprehensive Plan (SECOND PRESENTATION) – Casey Kaiser

Councilor Hutchison made a motion to approve Ordinance No 1269 for its second presentation. Motion seconded. No discussion on motion. All in favor, motion carried.

6. Ordinance No. 1270 – Granting a Franchise to Lightspeed Networks to Operate and Maintain a Telecommunications System (SECOND PRESENTATION) – Jered Reid

Jered Reid, City Attorney stated that this is the second presentation and it is a renewal that will extend the franchise for another 10 years. The city has not had any problems with this franchise.

# **Resolutions:**

7. Resolution No. 1504 – Authorizing the City of Prineville to Enter Into an IGA with Crook County for GIS Support – Jered Reid

Jered Reid, City Attorney provided the background information on the resolution.

There were no questions.

Councilor Jungmann made a motion to approve Resolution No. 1504. Motion seconded. No discussion on motion. All in favor, motion carried.

8. Resolution No. 1505 – Adopting Title VI Plan for the City of Prineville – Jered Reid

Mr. Reid stated that this plan is updated every three (3) years to make sure it is updated with federal law. The updates this time are mostly demographic.

There were no questions.

Councilor Jungmann made a motion to approve Resolution No. 1505. Motion seconded. No discussion on motion. All in favor, motion carried.

9. Resolution No. 1506 – Urging Oregon Legislature and Governor to Take Actions to Protect Oregonians' Right to Make Their Own Health & Medical Decisions – Mayor Beebe

Mayor Beebe provided the background information for this resolution.

Councilor Law made motion to approve Resolution No 1506. Motion seconded. Discussions on motion regarding this resolution not actually over riding the state but urging the state to allow people to make their own decision; whether it applies to all vaccinations; people already having the right to choose so why is it needed; the mandates from the federal and state and not having a choice; the employment decision not health care decision; any employer having hiring requirements and rules; having a choice and how their choice could affect your employment choice; accepting terms of employment and not changing them after the fact; and the Supreme Court. People carrying out consent and this being a mute issue really. Medical scenarios such as an arm being cut off or dying; forcing people to take the vaccine when it could kill some. There are no long term studies and finds it hard to believe that we support anything that forces someone to get a shot that could harm them. Just because it is legal doesn't make it right. It really doesn't change anything, it is about support. The resolution reinforces everything. Salem and mandates

and how we are getting separated over it. Belief in choice and supporting resolution. No further discussion on motion. Motion carried.

# **Visitors Appearances and Requests:**

Tenisha Valenzuela talked about reclaiming our rights. Ask yourself in your head and ask how bad do things have to do before you decide to act. Where do you draw your line? When do you finally say NO? She stated she will not comply. You give them an inch they will take a mile. Why is congress exempt and I am not? What makes them more American? She provided a definition for identity.

Jerald Jackman, talked about the choices resolution. He complimented the discussion of council. There is no meat behind this. Disagrees that we protected anyone's right by this and doesn't know why we did it.

Mayor Beebe explained that It doesn't protect anyone's rights, it is to make a statement. We passed this resolution because our citizen's asked us to and our citizen's wanted it.

Mike Ervin a Crook County resident thanked Council for passing the resolution because it does make a statement and understands that it really doesn't change anything with the Governor because she doesn't care. You should have freedom of choice without a penalty and we don't and that is wrong.

Cody Valenzuela a Crook County resident is a Middle School coach. Every day he goes to school and tries to teach kids right from wrong, on and off the field, in our community. How to be a leader. They show up every day and put their hard work in every day. It's not about the vaccine, it is about the freedom of choice. We know all the way up to the President, he doesn't care. The Governor is looking for her future and what she does next and doesn't care about the rest of us. What are going to do when it comes to the day are we going to stand up and say no? He is not against vaccines, and gets the flu shot every year. The mask didn't work the first time around and it isn't going to this time. Doesn't like the fact he is being forced to do it or doesn't get to coach any more. Something he loves to do and has been doing it for years. It's not right.

Mandy Puckett, a Crook County resident talked about being a researcher and investigator. There is so much conflicting information on this. She wanted to show support of this, because she has been vaccinated, it isn't about being vaccinated or not getting vaccinated. It is about the right to choose. She has been told herself so much conflicting information herself from having COVID. No one is on the same page when it comes to information. Talked about doctors losing their licenses or people losing their jobs if they don't get vaccinated. We are in a political war.

Nicole McKada, a Crook County resident and was at the last meeting with these ladies and agree with everything the previous speakers brought up. She said she realizes that the resolution is flawed, however prior to this resolution there was no position being taken and we didn't hear anything from our leaders. It is still up to every citizen to have a choice. This is far reaching and reaching into our homes. Thank you for passing the resolution. It says that we hear you and we stand behind you for the residents of the city of Prineville and Crook County.

She talked about being forced to get a vaccine, moral medical codes and looking them up, the FDA, masks being defined as restrictions, invasive procedures, etc. and it just doesn't make sense.

CITY GOAL: Fiscal Responsibility, Provide Quality Municipal Service & Programs

**SUBJECT:** Notice of Intent to Award Purchase Supply Contract

**REASON FOR CONSIDERATION:** Our capital improvements plan includes upgrades to the potable water system to our wastewater treatment plant. With the recent growth, our treatment needs at the wastewater treatment plant have become more stringent.

**BACKGROUND:** Our chlorine contact chambers are in need of a supply of pressurized water in the cleaning process. Public Works have been experiencing material supply issues for over a year.

**FISCAL IMPACT:** This project is a budgeted item. We have received documentation from 3 suppliers and the results are as follows:

HD Fowler \$35.25 per lineal foot total cost \$59,220 rot able to quote as they cannot guarantee delivery not able to quote as they cannot guarantee delivery

**RECOMMENDATION:** Staff recommends that council approve the intent to award the supply contract to HD Fowler in the amount of \$59,220 for the purchase of 1680 If of 12" C-900 water pipe.

# ORDINANCE NO. 954

# AN ORDINANCE PROVIDING RULES OF PROCEDURE FOR COUNCIL MEETINGS; AND REPEALING ORDINANCE NO. 570,

The people of the city of Prineville ordain as follows:

- Section 1. Meetings. The council shall meet in regular session on the second and fourth Tuesdays of each month and the first Monday of January in the council chambers at a time set by the council. A meeting may be canceled with the concurrence of a majority of the council, but in no event shall there be less than one meeting per month.
- Section 2. Regular Meetings Falling on Holidays. If the regular meeting date of the council falls on a legal holiday, as defined by ORS chapter 187, the council shall meet on the following day in the council chambers and the meeting shall be a regular meeting.
- Section 3. Special Meetings. Special meetings of the council may be called at any time on the request of two members of the council, by the mayor, or by the president of the council in the mayor's absence, by giving notice of the meeting to the council members and the public in a manner and for a time as circumstances may permit, but with a view to obtaining the largest possible attendance of council members.
- Section 4. Adjournment. Any meeting may be adjourned to a time, place, and date certain, but not beyond the next regular meeting.
- Section 5. Study Sessions. Study sessions of the council shall be held in accordance with state statutes whenever special circumstances require such a session, and the session shall be called by either the mayor, administrator, or two council members.
- Section 6. Open Meetings. All meetings, other than executive sessions, shall be open to the public.
- Section 7. Order of Business. The order of business at each council meeting shall be in accordance with the agenda prepared by the city administrator.
- Section 8. Items to be Acted on Generally. Normally, only those items on the agenda shall be acted on by the council. Matters deemed to be emergencies or of an urgent nature by the mayor, a council member, the administrator, or city attorney may be submitted for council consideration and action.

- Section 9. New Business. The mayor or a council member may bring before the council any new business under the "other matters" portion of the agenda. These matters need not be specifically listed on the agenda, but formal action on the matters shall be deferred until a subsequent council meeting unless deemed urgent.
- Section 10. Reading of Minutes. Unless the reading of the minutes of the previous council meeting is requested by a majority of the council, the minutes may be approved without reading if copies have been previously furnished to each of the council members.
- Section 11. Committees. The following standing committees shall be appointed by the mayor at the beginning of the year. Each committee shall consist of three members selected from the city council.
  - (1) Railroad and Finance Committee.
- (2) Public Works Committee. Responsible for sewer, water, and street related areas.
- (3) Public Safety Committee. Responsible for police, fire, and ambulance related areas.

# Section 12. Public Members Addressing the Council.

- (1) Any public member desiring to address the council shall stand and wait to be recognized by the presiding officer. After recognition, the person's name and address shall be stated for the record and the remarks shall be limited to the question under discussion. All remarks and questions shall be addressed to the presiding officer and not to any individual council member, staff member, or other person. No person shall enter into any discussion without being recognized by the presiding officer.
- (2) Any public member addressing the council shall be limited to five minutes unless further time is granted by the presiding officer. No public member shall be allowed to speak more than once upon any one subject until every other public member choosing to speak thereon has spoken.
- (3) After a motion has been made or after a public hearing has been closed, no public member shall address the council without first securing permission from the majority of the council.
- Section 13. Voting. Every member shall vote when a question is taken, unless the council excuses the member for a special reason; but no member shall be permitted to vote on any subject in which he has a direct pecuniary interest. Two members may demand the ayes and nays on any question. If not otherwise controlled by charter provision, the concurrence of a majority of the members of the council present at a council meeting shall be necessary to decide any question before the council.

Section 14. Passage of Resolutions. Each resolution shall be read only once before being voted on, and that reading may be by title only unless any member of the council requests the resolution be read in full. A resolution is effective immediately upon passage.

Section 15. Robert's Rules of Order. Robert's Rules of Order Revised shall be used as the guideline for conduct of council meetings, except in those cases where specific provisions contrary to Robert's Rules are provided in this ordinance.

Section 16. Repeal. Ordinance No. 570, Council Rules of Procedure, adopted January 27, 1965, as amended by Ordinance No. 633, adopted June 18, 1969, Ordinance No. 719, adopted February 26, 1974, Ordinance No. 849, adopted June 9, 1981, and Ordinance No. 900, adopted May 27, 1986, are repealed.

# RESOLUTION NO. 1507 CITY OF PRINEVILLE, OREGON

# A RESOLUTION APPROVING THE CONTINUATION OF STANDARD ENTERPRISE ZONE TAX ABATEMENTS UNDER ORS 285C.203, PURSUNAT TO SECTION 3, CHAPTER 522, OREGON LAWS 2021

# **RECITALS:**

Whereas, the City of Prineville ("City") is a co-sponsor of the Prineville/Crook County Enterprise Zone ("Zone"), along with Crook County ("County") (collectively, the "Sponsoring Governments"); and

**Whereas**, authorized and qualified business firm within the Zone, Endura Products, Inc. (Endura), has filed a claim for a new or ongoing property tax exemption that could be disqualified by the Crook County Tax Assessor due to failure to meet requirements under ORS 285C.200(1)(c), (d), (e), or (2) (the "Qualifications"); and

Whereas, Section 3, Chapter 522, Oregon Laws 2021 allows zone sponsors to adopt resolutions within 45 days of the laws' effective day establishing standards by which said business firms that were distressed by the COVID-19 pandemic may receive or continue to receive exemptions under ORS 285C.175 in the 2021-22 and 2022-23 tax years or for only the 2022-23 tax year by June 30, 2022; and

Whereas, receipts of exemption pursuant to Section 3, Chapter 522, Oregon Laws 2021 depend on setting procedures for allowing zone sponsors to grant exemptions, including standards for establishing minimum employment for a firm to maintain, and criteria for why a firm is prevented from meeting the Qualifications, including but not limited to reasons under Section 3(1)(a)(C), Chapter 522, Oregon Laws 2021.

NOW, THEREFORE, the Prineville City Council hereby resolves as follows:

- 1. The executive(s) or appointee(s) of executive(s) of the Sponsoring Governments and the local zone manager, in consultations with the Crook County Tax Assessor (who shall receive written notice), are hereby directed to issue a public memorandum (the "Memorandum") to this body granting the exemption in accordance with Nos. 2 and 3, below, for Endura:
  - a. In the case of the 2021-22 tax year, by December 31, 2021, in the event that the authorized or qualifying business has made a payment in lieu of disqualification under ORS 285C.240(6) for the purpose of the 2021-22 tax year; or
  - b. In the case of the 2022-23 tax year, by June 30, 2022.
- 2. The Memorandum shall establish the number of employees that Endura must have on average in the Zone at a minimum during 2021 or 2022, at or more than is normally required under ORS 285C.210 and not less than 80 percent of Endura's existing average annual number

of employees with authorization and shall otherwise be based on the number that Endura demonstrates it can expect to maintain each year.

- 3. The Memorandum shall identify criteria of distress that have prevented Endura from qualifying in the Zone from among one or more of the following:
  - a. Compliance with mandatory public health safety measures or closures;
  - b. Mandatory limitations on facility capacity in excess of thirty percent (30%);
  - c. At least a twenty percent (20%) decrease in receipts;
  - d. A twenty percent (20%) reduction in sales;
  - e. Significant disruption of Endura's access to markets or supply chains; or
  - f. Other measurable factors attributable to the COVID-19 pandemic.
- 4. The Crook County Tax Assessor is not obligated to address compliance with these requirements.
- 5. One hundred percent (100%) of the payment in lieu of disqualification made by Endura under ORS 285C.240(6) for purposes of the 2020-21 tax year shall be refunded to Endura by December 31, 2021.
- 6. The Crook County Tax Assessor, Oregon Department of Revenue, and Oregon Business Development Department shall receive copies of this resolution within thirty (30) days of its adoption.



# What will this Resolution accomplish?



Allows for a grace period to relieve local Enterprise Zone companies

This House Bill gives local jurisdiction the ability to waive the employment requirement for companies negatively impacted by the pandemic in 2020 and 2021.



Endura will remain an eligible Enterprise Zone company for the 2020 tax year

Endura has historically been and continues to be one of our top employers in Crook County and has invested millions in the local economy. They are actively hiring to bring employment back up.




The PILOD will be refunded to Endura due to the uncontrollable variables faced
