Councilor Sumner made a motion to approve consent agenda as presented. Motion seconded. No discussion on motion. Motion carried.

3. Republic Disposal Rate Increase Request (PUBLIC HEARING)

Mayor Beebe opened the public hearing portion of the meeting.

Steve Forrester, City Manager provided the background on the process for reviewing requests for rate increases. A request was received for a 14% increase and the Solid Waste Committee counter offered at 10%, which Republic accepted. They are currently under 8 % profit margin and the city considers a 8-12% profit margin acceptable. Part of the franchise agreement allows the city to request financials at any time.

Mayor Beebe talked about how Republic responded to the city and county requesting to have the Prineville office staffed.

Discussions continued regarding rate of return (profit margin).

No one came forward. No written comments were received, and no comments were received over the phone.

Mayor Beebe closed the public hearing portion of the meeting.

- 4. Adopting Updated Wastewater Master Plan Josh Smith / Casey Kaiser
- 5. Adopting Update Water Master Plan Josh Smith / Casey Kaiser
- 6. Chapter 8 Amendment to the City's Comprehensive Plan (City Facilities) Josh Smith / Casey Kaiser

Mayor Beebe opened the public hearing portion of the meeting.

Josh Smith, Planning Director explained that it made sense to combine the public hearing for all of these since they are related.

Mr. Smith went through a power point presentation for the Chapter 8 amendments and how this chapter pertains to city facilities. With the updating of the Wastewater & Water Master Plans, this was a good time to update this chapter at the same time. This went through a public hearing with the Planning Commission. The Planning Commission recommended approval as written.

Mr. Smith added that we are not adopting tonight, this is just the required public hearing portion of the updates and ordinances will come back to Council at the next meeting.

There were questions regarding the Willowdale / Melrose area getting on city water and sewer, that area is in the master plan, DEQ requirements and the property owner paying for the connection. Central Oregon Intergovernmental Council (COIC) does have programs to help property owners with connections, especially if septic or wells fail.

Mr. Forrester explained that the city has always looked ahead to make such connections possible for example when St. Charles was built, larger pipes were installed with major upgrades and infrastructure placed for future expansion of service, development and enlarging capacity.

Casey Kaiser, Public Works Director took over the power point presentation regarding the Wastewater and Water Master Plans and explained the purpose of updates. The updates look out to the next 20 years' worth of planning for future growth and needs.

Mr. Kaiser went over the difference between Capital Improvement Projects (CIP's) and System Development Charges (SDC's) and the existing conditions and capacities for each of the facilities.

Mr. Kaiser went through the three main categories for CIP's.

There were discussions regarding rags and other materials that make their way into the wastewater treatment plant affecting filtration of water. Upgrading the chlorine treatment of the wastewater process will have no change in effectiveness of treatment.

There were no further discussions or presentations.

There were no written comments received and the person on the phone did not respond. No one came forward.

Mayor Beebe closed the public hearing portion of the meeting.

7. Consideration of a Proclamation – July Parks & Recreation Month – Sponsor Sumner

Councilor Sumner agreed to sponsor the request for this proclamation and went through the wording of the proclamation.

Councilor Uffelman made a motion to support the official reading of the proclamation at the next meeting. Motion seconded. No discussion on motion. All in favor, motion carried.

8. City Manager's Report – Steve Forrester

Steve Forrester, City Manager thanked Alan Alderman who was in the audience for his participation in the first round of Chief candidates interview process.

Mr. Forrester then presented his Managers report highlighting activity in each department.

Councilor Hutchison asked who won the chili cookoff during the rodeo activities and it was the Sherriff's Department again this year.

There were no further discussions.

He went to school in Crook County and went into the Army at 18 years old.

Lori Hooper Antram, Finance Director presented the staff report adding that the last public hearing was on June 5th during the Budget Committee Meeting and was passed by the Budget Committee.

No one came forward, no written comments were received, and no one responded on the phone.

Mayor Beebe closed the public hearing portion of the meeting.

Councilor Merritt made a motion to approve Resolution No. 1597. Motion seconded. No discussion on motion. All in favor, motion carried.

11. Resolution No. 1598 – Establishing Fees and Charges for the City of Prineville for FY 2024-2025 (PUBLIC HEARING) – Lori Hooper Antram

Mayor Beebe opened the public hearing portion of the meeting.

Lori Hooper Antram stated that a public hearing has to be held prior to voting on the resolution.

There were no questions.

No one came forward, no written comments were received, and no one responded on the phone.

Mayor Beebe closed the public hearing portion of the meeting.

Councilor Uffelman made a motion to approve Resolution No. 1598. Motion seconded. No discussion on motion. All in favor, motion carried.

12. Resolution No. 1599 – Approving a Rate Increase for Solid Waste Franchisee Services – Mayor Beebe

Mr. Kaiser said that he received word from Courtney Voss of Republic that they did hire someone full time for the Prineville office that will begin July 1st five days a week.

Mayor Beebe who serves as Chair for the Solid Waste Advisory Committee said that the committee said the committee agreed to a 10% increase.

There were discussions why the County passed an 8% increase and why is the city's request 10%. Mr. Forrester stated that the operations between the County and City are very different.

Discussions continued regarding tipping fees and new equipment, whether or not there are any other companies that could service us, and other service concerns previously brought up.

Councilor Hutchison added that until we see how the changes in service requested works out and sees how it could go with a person in the Prineville office, she cannot support a request for an increase. When they (Republic) first took over, they said they wouldn't change how things were operating and it didn't take anytime at all to change everything.

Councilor Uffelman made a motion to approve Resolution No. 1599. A second was not made. Motion failed.

There will be a workshop scheduled in August to discuss this further and what our options are.

13. Resolution No. 1600 – Approving Personal Services Agreement with Divergent Engineering Regarding Prineville Water Treatment Plant Operations – Casey Kaiser

Mr. Kaiser presented the staff report.

There were discussions regarding educational opportunities, having a technical person in house probably being a couple of years out, and the Aquifer Storage and Recovery (ASR) is a critical component to our water delivery, especially if we had another hot summer.

City Manager Update to Council

Public Safety / Dispatch

Officer lateral interviews were held last week and we have selected a very experienced officer to move forward to background.

We are having another lateral background interview on July 5th with an officer that has about 5 years' experience and is moving to Prineville. More to come on that after the interview.

PD is still working on a couple entry level backgrounds and getting closer to completion, so we can make hiring decisions.

PD is also very busy with the horse races prep beginning soon. OSP and CCSO will be assisting in that event.

Officer Bruce is almost done with academy and will graduate at the end of month. We are excited to get him back to complete his field training.

Dispatch is still testing applicant and is actively engaged in improving recruitment.

Tobi and Sam are still working on the 911 accreditation.

Public Works

Public Works had the pre-construction project kick off meeting for the Combs Flat Road/OID Canal Piping project. Taylor Northwest will be starting on the project in July. Construction is expected to be ongoing at the Barnes Butte Area until it is completed next July.

The Heliport ASR well upgrade is nearing completion. The pump and well is operational in time for the warm weather with some minor electrical work to be completed over the next few weeks.

The design for the annual waterline replacement project is completed and out to bid. A large section of undersized line in the S. Main Street area will be replaced. We hope to have a contract in place in July with the project under construction in early fall.

We are finalizing design on the ASR2 well and are still pushing to go out to bid in July or early August for its construction.

Matt and crew remain very busy with the new business recently acquired.

ORDINANCE NO. 1294

AN ORDINANCE AMENDMENT IN THE CITY'S COMPREHENSIVE PLAN TO UPDATE CHAPTER 8 (PUBLIC FACILITIES & SERVICES)

Whereas, City of Prineville ("City") adopted a Comprehensive Plan on or about April 10, 2007, pursuant to Ordinance 1143 and codified in Chapter 154 of the Prineville City Code; and

Whereas, the City has updated its public facility master plans numerous times without changes to Chapter 8; and

Whereas, The City has just completed updates to its Wastewater Facility Plan and Water System Master Plan in 2024; and

Whereas, based on the aforementioned Plans, City staff initiated amendment procedures to the City's Comprehensive Plan (Chapter 8) for review by the City Planning Commission; and

Whereas, pursuant to Section 153.252.020 of the Code, required notice was submitted to the Department of Land Conservation and Development and published 10 days prior to the initial public hearing scheduled for May 21, 2024; and

Whereas, on May 21, 2024, the City Planning Commission held a public hearing and consented to the amendment and recommended the City Council approve the proposed amendment to Chapter 8 of the Comprehensive Plan as shown on Exhibit A, attached hereto and by this reference made a part hereof; and

Whereas, pursuant to Section 153.252.020 of the Code, required notice was published 10 days prior to the City Council hearing of a legislative change scheduled for June 25, 2024; and

Whereas, the Prineville City Council conducted a public hearing on June 25, 2024, which consisted of the opportunity of written and oral testimony, review of staff reports, and consideration of the recommendations of the City of Prineville Planning Commission.

NOW, THEREFORE, the people of the City of Prineville ordain as follows:

- 1. That the City's Comprehensive Plan Chapter 8 is hereby amended as shown on Exhibit A.
- 2. The City Recorder shall place a certified copy of this Ordinance in the City's permanent records.
 - 3. The Ordinance shall be effective 30 days following its passage by the City Council.

Chapter 8 Public Facilities and Services

Purpose and Intent

Public Facilities are improvements, which provide services through various government entities or through franchise agreements with private utilities. The purpose of this chapter is to identify existing public and private facilities and services and identify present and future needs based on projected growth.

Key public facilities are typically described as transportation, water, wastewater, storm drainage, planning & zoning, parks & recreation, solid waste collection, energy, communication, schools, emergency services, health services and community governmental services. While the City and other local providers offer a wide range of services, these key elements are essential to accommodating growth and maintaining public health and safety. Likewise, the City is required to prepare and maintain planning tools that make sure adequate levels of key services are available and not stressed beyond their carrying capacities.

The City of Prineville manages key facilities such as governance, police, transportation, water, wastewater, stormwater and some elements of recreation, which are under their jurisdiction. Services such as; health, parks & recreation, fire protection, solid waste collection, building permitting, schools, energy, other utilities and communication services are provided by other entities and in some cases through franchise agreements with the City.

This chapter does not list specific current or needed public improvements. That information is found in various facility plans, commonly referred to as "master plans" from each serving entity. The City maintains and adopts Public Facility Plans for Transportation, Water, Wastewater and Stormwater. The City also adopts facility plans by local partnering agencies for Parks & Recreation, Airport and others as may be applicable. Transportation (Chapter 6) and Parks (Chapter 4) are separate individual Chapters in this Comprehensive Plan. The most current versions of the aforementioned plans are supporting documents to the Comprehensive Plan and are hereby referenced and made part of this chapter.

Goals and Policies

Statewide planning Goal 11, OAR 660-015 (Public Facilities and Services); requires that cities plan and develop a timely, orderly and efficient arrangement of public facilities and services to serve as a framework for urban and rural development.

Goal #1: Provide public facilities, services and private utility systems at levels necessary and practical for existing and future uses.

Policies

- 1. Plans and development impacting public facility and service shall consider; desired service levels, system and area protections, infrastructure needs and impacts to the following areas within the UGB.
 - o Police Protection
 - o Fire Protection
 - o Emergency Medical Service
 - Transportation
 - Parks and Recreation
 - Natural Open Space
 - Natural Hazards
 - Public Buildings

- Water System
- Wastewater System
- o Stormwater System
- o Solid Waste Management
- Schools
- Airport
- Railroad
- o Other Public/Private Utilities
- 2. Plans providing for public facilities and services should be coordinated with plans; for the designation of urban boundaries, zoning, urbanizable land, rural uses and for the transition of rural land to urban uses. The following factors shall be considered when determining public facility locations:
 - Availability and cost of usable land
 - Geographic restrictions
 - o Carrying capacity of planning area
 - Operational efficiency

- o Related project improvements
- Long term cost burden
- o Disruption of residential areas
- Comprehensive Plan goals and policies
- 3. Public facilities and services in urban and urbanizable areas should be provided at levels necessary and suitable for urban uses without reducing service levels of existing residents.
- 4. A public facility or service should not be provided to outlying urbanizable areas within the UGB, unless there are provision for the coordinated annexation and development of all other urban facilities, services and rights-of-way appropriate to that area.
- 5. Collaborate with private utility companies to ensure equitable access to services throughout the City. Various agencies and entities other than the City of Prineville may be allowed to use City rights-of way. This may require the imposition of franchise agreements and special protocols and fees. In no case, shall these entities create a situation whereby the City must subsidize activity or repair damage caused by other service providers.
- 6. All utility lines and facilities should be located on or adjacent to existing public or private rights-of-way to avoid easements and dividing lots. Whenever feasible, all utility lines and components shall be placed underground.
- 7. New Development shall not exceed the carrying capacity of public facilities and services. New development shall provide appropriate infrastructure and public services or mitigate for such impact as a condition of development. Anticipated growth within the community

may require expansion of facilities faster than the local government can provide. In these cases, it is essential that growth pay its own way in order to avoid unnecessary impacts upon existing residents and quality of life. This means that new development may need to supply an array of services to developments ahead of the City schedule and at their own cost, subject to City approval and authorization before development.

8. The City and other agencies and partners should utilize sustainability practices and other techniques for sustaining limited resources and facilities including such things as; recycling programs, preservation of natural areas, water conservation, wastewater reuse, air quality monitoring, energy production and energy consumption.

Goal #2: Maintain and regularly update public facility plans and capital improvement programs and budgeting.

Policies

- 1. City Facility Plans for transportation, wastewater, water and stormwater shall be adopted and periodically updated throughout the planning period.
- 2. The City shall periodically update short- and long-term Capital Improvement Plans (CIPs) for public facilities throughout the planning period, including property acquisition needs.
- 3. The City shall adopt and periodically update funding methodologies and coordinate investments to pay for and leverage planned capital improvements.
- 4. The City shall explore innovative ways of providing public facilities and services as well as funding alternatives to ensure the equitable and adequate development and implementation of public facilities and services.

AMENDMENT NUMBER 01 COOPERATIVE IMPROVEMENT AGREEMENT 2017 Oregon Transportation Funding US26: Meadow Lakes Drive-Combs Flat Rd (Prineville) City of Prineville

This is Amendment No. 01 to the Agreement between the **State of Oregon**, acting by and through its Department of Transportation, hereinafter referred to as "State" or "ODOT", and the **CITY OF PRINEVILLE**, acting by and through its elected officials, hereinafter referred to as "Agency," entered into on March 4, 2019.

This Agreement is now identified as Agreement No. 73000-00023184. All terms remain unchanged, except as amended herein.

It has now been determined by State and Agency that the Agreement referenced above shall be amended to revise the maintenance responsibilities of the Parties and the contact information.

- 1. <u>Effective Date.</u> This Amendment shall become effective on the date it is fully executed and approved as required by applicable law.
- 2. Amendment to Agreement.
- a). Insert new Exhibit D, identifying that section of the Ochoco Highway, US Route 26, State Highway No. 41 through the city of Prineville and resoluted to the state.
- b). Insert new RECITALS, Paragraph 11, to read as follows:

It has been determined by the Parties that it is in the best interests of the travelling public that Agency assume responsibility for agreed upon pavement markings and winter maintenance on U.S. 26.

c). Insert new TERMS OF AGREEMENT, Paragraph 8 to read as follows:

The Parties agree to coordinate on needed Traffic Control for any needed maintenance and to work in good faith to offer assistance to the other Party as available.

- d).TERMS OF AGREEMENT, Paragraph 8, shall be hereinafter re-numbered as Paragraph 9.
- e). AGENCY OBLIGATIONS, Paragraph 13, Page 7, which reads:

f). Insert new AGENCY OBLIGATIONS, Paragraphs 5 thru 9, to read as follows:

- 5. In addition to the responsibilities described in AGENCY OBLIGATIONS, Paragraph 4, Agency further agrees at its own expense to the below referenced maintenance responsibilities on State property within the Project limits:
 - a. Parking stall striping including ADA parking stall markings;
 - b. Striping of marked crosswalks on city streets;
 - c. Signing associated with ADA parking stalls;
 - d. ADA ramps where said ramps are located on a resoluted highway (MP 18.3 19.4):
 - e. Vactoring of drainage facility; and
 - f. Discretionary winter maintenance of on-street parking.

Agency agrees to perform all maintenance responsibilities in accordance with ODOT's Traffic Manual, ODOT Traffic Line Manual, ODOT Sign Policy and Guidelines, and ODOT Sign Design Manual.

- Notwithstanding the maintenance obligations described in TERMS OF AGREEMENT, Paragraph 7(d) and AGENCY OBLIGATIONS, Paragraph 4; all maintenance obligations shall survive termination of this Agreement.
- 7. Agency shall obtain a permit to "Occupy or Perform Operations upon a State Highway" from assigned State District 10 Project Manager as well as land use permits, building permits, and engineering design review approval from State. Agency agrees to comply with all provisions of said permit(s), and shall require its developers, contractors, subcontractors, or consultants performing such work to comply with such permit and review provisions.
- 8. Agency shall require its contractor(s) and subcontractor(s) that are not units of local government as defined in ORS 190.003, if any, to indemnify, defend, save and hold harmless the State of Oregon, Oregon Transportation Commission and its members, Department of Transportation and its officers, employees and

agents from and against any and all claims, actions, liabilities, damages, losses, or expenses, including attorneys' fees, arising from a tort, as now or hereafter defined in ORS 30.260, caused, or alleged to be caused, in whole or in part, by the negligent or willful acts or omissions of Agency's contractor or any of the officers, agents, employees or subcontractors of the contractor ("Claims"). It is the specific intention of the Parties that the State shall, in all instances, except for Claims arising solely from the negligent or willful acts or omissions of the State, be indemnified by the contractor and subcontractor from and against any and all Claims.

- 9. All employers, including Agency, that employ subject workers who work under this Agreement in the State of Oregon shall comply with ORS <u>656.017</u> and provide the required Workers' Compensation coverage unless such employers are exempt under ORS <u>656.126</u>. Employers Liability insurance with coverage limits of not less than \$500,000 must be included. Agency shall ensure that each of its contractors complies with these requirements.
- 10. Agency shall require its contractor(s) and subcontractor(s) that are not units of local government as defined in ORS 190.003, if any, to indemnify, defend, save and hold harmless the State of Oregon, Oregon Transportation Commission and its members, Department of Transportation and its officers, employees and agents from and against any and all claims, actions, liabilities, damages, losses, or expenses, including attorneys' fees, arising from a tort, as now or hereafter defined in ORS 30.260, caused, or alleged to be caused, in whole or in part, by the negligent or willful acts or omissions of Agency's contractor or any of the officers, agents, employees or subcontractors of the contractor ("Claims"). It is the specific intention of the Parties that the State shall, in all instances, except for Claims arising solely from the negligent or willful acts or omissions of the State, be indemnified by the contractor and subcontractor from and against any and all Claims.
- 11. Any such indemnification shall also provide that neither the Agency's contractor and subcontractor nor any attorney engaged by Agency's contractor and subcontractor shall defend any claim in the name of the State of Oregon or any agency of the State of Oregon, nor purport to act as legal representative of the State of Oregon or any of its agencies, without the prior written consent of the Oregon Attorney General. The State of Oregon may, at anytime at its election assume its own defense and settlement in the event that it determines that Agency's contractor is prohibited from defending the State of Oregon, or that Agency's contractor is not adequately defending the State of Oregon's interests, or that an important governmental principle is at issue or that it is in the best interests of the State of Oregon to do so. The State of Oregon reserves all rights to pursue claims it may have against Agency's contractor if the State of Oregon elects to assume its own defense.
- g). AGENCY OBLIGATIONS, Paragraphs 5 through 13, shall be hereinafter renumbered as Paragraphs 10 through 18.

h). STATE OBLIGATIONS, Paragraph 7, Page 7, which reads:



State reserves the right at any time to require the submission of the hard copy originals of any documents.

THE PARTIES, by execution of this Agreement, hereby acknowledge that their signing representatives have read this Agreement, understand it, and agree to be bound by its terms and conditions.
