Citizens and other visitors attending the joint meeting shall observe the same rules of propriety, decorum, and good conduct applicable to members of the CEC and PARB. Any person making personal, impertinent, profane or slanderous remarks or who becomes boisterous while addressing CEC and PARB or while attending the meeting shall be removed from the room, if so directed by the Mayor or presiding officer, and the person shall be barred from further audience before the joint meeting. Disruption of a public meeting could constitute a violation of Section 42.05 of the Texas Penal Code.
