Any person taking personal, impertinent, profane or slanderous remarks or who becomes boiste ous while addressing Community Engagement Committee and Parks and Recreation Board or while attending the meeting shall be removed from the room, if so directed by the latter presiding officer, and the person shall be barred from further audience before the join meeting. Disruption of a public meeting could constitute a violation of Section 42.05 of the 100 Penal Code.
