Citizens and other visitors attendify Packs and Recreation Board meetings shall observe the same rules of propriety, decorum, and good conduct applicable to members of the Board. Any person making personal, impertinent professor slanderous remarks or who becomes boisterous while addressing the Board or while at ending the meeting shall be removed from the room, if so directed by the Mayor or presiding efficer, and the person shall be barred from further audience before the Board during that session of the meeting.
