Tree Cut List

The list of boulevard and park trees requiring cutting was completed. Eleven trees are on the list to be removed. Letters to property owners adjacent to boulevards will go out shortly. Letters are a courtesy notice to property owners. Replacement letters will be sent in early Spring to properties which warrant replacements. Currently there are no private hazard trees requiring cutting. Fruit advised that a small tree near Jefferson school at 3rd street is blocking a stop sign.

Tree Cutting/Pruning Update

Buildings and Grounds seasonal, Finley Hamblin, has been focused on tree work in red playground and footbridge in Krouskop Park as well as North Pond Park. This has been helpful for mowing and tree health and aesthetics. Some small trees were pruned on Church and Haseltine to improve visibility.
