2. Motion to waive the reading of the minutes of the last meeting in lieu of printed copies and to approve the same.

Motion by Downs to waive the reading of the minutes. Seconded by Chambers, motion carried.

3. Consider approval of Operator Licenses.

Motion by Melby to approve operator licenses for Zac Hamel, Brandi Pizer, Bethany Feinz, Shawn Logue, and Anna Harris, seconded by Downs, motion carried.

- 4. Discussion and Possible Action:
  - -Motion by Downs to approve the parade permit from VFW Post 2267 for May 29, 2023 @ 10:00am- route is the same as it has been in the past, seconded by Chambers, motion carried.
  - -Motion by Chambers to approve the street closure application from the Brewer Library for Community Safety Days on June 17<sup>th</sup> 9a to 12p- Downs wants to make sure the neighbors with driveways that enter onto Central are aware of the street closure- Stacy Pilla was going to make contact. Seconded by Downs, motion carried.
  - -Motion by Melby to approve the application for Mobile Dessert Establishment from Nancy Schoepp from Grandma's Ice Cream, LLC, Melby asked about restrictions around the pool? None that we know off. Downs asked about Strobe lights on the top, concerned kids will run out in the street and get hit by cars- want to make sure the ice cream truck is visible to other traffic.
