SUBJECT: NORTH WATER PLANT BOOSTER STATION (CHANGE ORDER)

SUMMARY:

WW Payton's SCADA subcontractor, Mercer Controls included a product submission to Strand Associates for a magnetic flow meter that would serve best for the tracking of water pumped from the storage tank at the North Water Plant. In the interim between the product submission to Strand for review and the purchasing of the meter, the price of the meter increased dramatically.

In addition to the increased cost of the magnetic flow meter, an upgrade to Richwood's current PLCs at other SCADA sites in town are required to ensure serviceability and communication between water plant sites for years to come.

BACKGROUND INFORMATION:

Cherrell Mercer of Mercer Controls brought to my attention the increased cost of the magnetic flow meter being a situation of Force Majeure because the specific increase of the flow meter cost could not be foreseen, nor the cost increase from the manufacturer be controlled.

Additional increases included in the Change Order fund upgrades of programmable logic controllers (PLCs) at Richwood's SCADA sites for future communication integrity and serviceability.

A programmable logic controller (PLC) is an industrial computer that has been ruggedized and adapted for the control of manufacturing processes, such as assembly lines, machines, robotic devices, or any activity that requires high reliability, ease of programming, and process fault diagnosis. The PLCs utilized in Richwood's SCADA system ensure dependable automatic function of Richwood's water plants to fill water storage tanks to maintain water distribution pressure as well as an abundant water supply.

For years Richwood has utilized Allen-Bradly components within the SCADA system because of their excellent service record. Currently, Allen Bradly PLC Model 1400 is in service throughout Richwood's SCADA sites. It has recently been discovered that the model 1400 PLC will no longer

be supported by the manufacturer. The manufacturers suggestion was to upgrade to the next generation PLC known as Model 850. The downfall to this option is that the Models 1400 & 850 will not communicate therefore requiring a full system upgrade to ensure future communication between SCADA sites. The upgrade to the Model 850 PLC will also ensure compatibility between all SCADA sites and Richwood's master panel allowing Richwood to receive all additional SCADA options outlined in the original construction contract.

ISSUE:

None

FISCAL IMPACT:

\$20,595.00

This will increase the amended contract price from \$1,871,000.00 to \$1,891,595.00. The overall North Water Plant construction cost totals \$3,990,909.50. Due to interest gains, Richwood currently has an additional \$74,000.00 more than the original \$4,000,000.00 of bond funds received.

RECOMMENDATION:

I recommend Council make a motion approving the North Water Plant Booster Pump Station Change Order #2 in the amount of \$20,595.00.

RE: Bypass at South Water Plant

PROPOSAL

Mercer Controls proposes to furnish and install necessary equipment to provide a dependable bypass around the ground storage tank (GST) at your South Water Plant. Our installation will include the following:

- Providing two 1,500-gallon temporary trailer-mounted tanks;
- Connection to existing booster pump suction line from temporary tank outlets;
- Connection from BWA metering vault to temporary tanks, with +/- 150 feet of 4-inch piping placed on ground and anchored;
- Furnishing two Variable Frequency Drive (VFD) units, one Pressure Transmitter, and one Mercer Controls Precision VFD Controller for temporary use;
- Modification of control structure at the plant to allow water demand at the site to cause the control valve in the BWA vault to open and close as needed;
- Allowing for operation 24 hours a day if needed to properly manage pressure in the vicinity;
- Furnishing protective enclosures for VFD units at the site;

At the completion of the project, we will restore operation to normal and remove the temporary piping and equipment.

This plant supports the rest of the water system in Richwood. The maximum amount of water that can be contributed from the plant during emergency bypass operation will be the limit on the

amount of BWA water that is available. In the event of a fire, the area around the plant will be supported by water from the sources at the north side of town.

We include an allowance of \$1,500.00 for the connection inside the BWA valve vault. Price will be adjusted to actual charges.

Price complete, for the first seven days, \$27,880.42. Price per day after the seventh day, \$180.40.

We encourage operation of the bypass system for 48 to 72 hours before taking the tank out of service. We will work with the City to allow the use of as much of the water in the tank as possible.

Start date will be subject to availability of material once approved. Normally 2-4 weeks.

WHEREAS, staff requests council approve the transfer from undesignated funds within Fund 32 to Fund 30.

SUBJECT: BUDGET AMENDMENT (SOUTH WATER PLANT TANK MAINTENANCE)

SUMMARY:

Maintenance of Richwood's ground storage tank located at the South Water Plant has become a necessity. This maintenance will come in the form of an interior sand blast and paint coating of the tank. In best attempts to equalize water pressure in this region of the city, a temporary tank and pumps must be staged at this water plant site while the ground storage tank is drained, and an interior paint coating is applied.

BACKGROUND INFORMATION:

An interior tank coating of the South Water Plant ground storage tank is necessary to inhibit the degradation of steel that takes place when exposed to chlorine vapors. Public Works has made their best effort to postpone this maintenance until the completion of the North Water Plant which would have added high service pumping as well as an additional water source during the time the South Water Plant tank is drained for maintenance.

Due to the delay of completion of the North Water Plant and the postponement of necessary maintenance at the South Water Plant tank, Richwood risks being in breach of contract with Utility Service Group by not allowing the contractor to perform necessary maintenance to protect the structural integrity of the water tank.

The use of a temporary tank and high service booster pumps is the only viable option Richwood possesses to equalize pressure in the south portion of the city while Richwood's ground storage tank is drained for maintenance.

ISSUE:

In the past when the ground storage tank was drained or had a low level of water, 2nd and 3rd story apartments begin to call City Hall complaining of loss of water pressure. It is the opinion of Public Works that allowing that situation to manifest over a 10-14 day period (estimated time duration to coat the interior of the tank) would be irresponsible and reckless.

\$37,000

RECOMMENDATION:

I recommend Council make a motion to approve the budget amendment moving funds from Capital Improvements to Professional Services within the Enterprise Fund, to fund a temporary tank and booster pumps at the South Water plant while the water storage tank is drained for maintenance.

SUBJECT: SOLID WASTE SERVICE CONTRACT

SUMMARY:

According to the contractual agreement between Richwood and Waste Connections, Richwood has extended the contractual agreement for Solid Waste Services the maximum allotted times. The contract for Solid Waste Services must go out for bid in FY-23.

BACKGROUND INFORMATION:

Historically Richwood has entered into contractual agreements with solid waste service providers for a term of three years with an option to renew for two one-year periods. Since 2012 Richwood has had a solid waste service provider that provided residential refuse and recycling, commercial refuse, and heavy trash services.

In past years Richwood has facilitated residential refuse, recycling, and heavy trash while the service provider has facilitated and managed commercial refuse accounts. I the past this has not allowed Richwood to charge the service provider any franchise fees.

ISSUE:

Before any RFP is advertised for solid waste service providers, Staff would like to have the conversation with Council regarding Richwood's future service plan including:

- Frequency of service
- Heavy trash quantities
- Commercial refuse and franchise fees

This conversation is meant to provide Staff with direction regarding the degree of solid waste services that are expected to be outlined in the upcoming RFP submittals.

FISCAL IMPACT:

None

RECOMMENDATION:

Based on Staff's knowledge and input combined with Council's experience with solid waste services, provide staff with feedback that highlights Council's service goals for the FY-23 solid waste service bid submittals.

BACKGROUND INFORMATION:

Charter States:

Section 11.12. - Charter Review Commission.

The City Council shall appoint each even numbered year, a Charter Review Commission of five citizens of the City.

- (a) Duties of the Commission. It shall be the duty of such Charter Review Commission to:
- 1. Inquire into the operations of the City government under the Charter provisions and determine whether any such provisions require revision. To this end public hearings may be held and the Commission shall have the power to compel the attendance of any officer or employee of the City and to require the submission of any of the City records which it may deem necessary to the conduct of such hearing;
- 2. Propose any recommendations it may deem desirable to ensure compliance with the provisions of the Charter by the several departments of the City government;
- 3. Propose, if it deems desirable, amendments to this Charter to improve the effective application of said Charter to current conditions;
- 4. Report its finding and present its proposed amendments if any, to the City Council.
- (b) Action by the City Council. The City Council shall receive and have published in a newspaper of general circulation in the City any report presented by the Charter Review Commission, shall consider any

recommendations made, and if any amendments or amendment be presented as a part of such report may order such amendment or amendments to be submitted to the voters of the City in the manner provided by the applicable statute of the State of Texas.

(c) Term of office. The term of office of such Charter Review Commission shall be one year and, if during such term no report is presented to the City Council, then all records of the proceedings of such Commission shall be filed with the person performing the duties of City Secretary and shall become a public record.

ORDINANCE 22-499

AN ORDINANCE AMENDING CHAPTER 16 POLICE OF THE CITY OF RICHWOOD CODE OF ORDINANCES TO INCLUDE ADDITIONAL PROVISIONS FOR APPOINTMENT OF RESERVE POLICE OFFICERS; PROVIDING THAT ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH SHALL BE REPEALED TO THE EXTENT OF THE CONFLICT ONLY; PROVIDING FOR A SAVINGS CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Richwood adopted Ordinance 143 creating a Police Reserve Force on July 8, 1980.

WHEREAS, the City Council of the City of Richwood wishes to amend Section 16-49 of Chapter 16 Police.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF RICHWOOD, TEXAS:

Section 1: That section 16-49 – Appointments, regulations - is hereby amended to reflect the following:

Any person appointed under the terms of this article shall be appointed by the chief of police and approved by City Council prior to carrying a weapon or otherwise acting as a peace officer. They shall serve under the regulations set forth by the chief of police for the remuneration as may be prescribed by the city council.

Section 2: That if any provision of this ordinance or application thereof to any person or circumstance is held invalid by any court, such holding shall not affect the validity of the remaining portions of this ordinance, and the City Council of the City, hereby declares that it would have enacted such remaining portions despite any such invalidity.

Section 3: That all ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of the conflict only.

Section 4: That this ordinance shall be in effect on October 10, 2022.

H-GAC is the regional organization through which local governments consider issues and cooperate in solving area wide problems. Through H-GAC, local governments also initiate efforts in anticipating and preventing problems, saving public funds. The 13-county H-GAC service region is growing, becoming more diverse, and constantly changing. In order to address the needs of citizens and businesses, local governments are providing leadership to guide regional development wisely and manage change constructively.

- Sec. 341.012. POLICE RESERVE FORCE. (a) The governing body of a municipality may provide for the establishment of a police reserve force.
- (b) The governing body shall establish qualifications and standards of training for members of the reserve force.
- (c) The governing body may limit the size of the reserve force.
- (d) The chief of police shall appoint the members of the reserve force. Members serve at the chief's discretion.
- (e) The chief of police may call the reserve force into service at any time the chief considers it necessary to have additional officers to preserve the peace and enforce the law.
- (f) A member of a reserve force who is not a peace officer as described by Article 2.12, Code of Criminal Procedure, may act as a peace officer only during the actual discharge of official duties.
- (g) An appointment to the reserve force must be approved by the governing body before the person appointed may carry a weapon or otherwise act as a peace officer. On approval of the appointment of a member who is not a peace officer as described by Article 2.12, Code of Criminal Procedure, the person appointed may carry a weapon only when authorized to do so by the chief of police and only when discharging official duties as a peace officer.
- (h) Reserve police officers may act only in a supplementary capacity to the regular police force and may not assume the full-time duties of regular police officers without complying with the requirements for regular police officers. On approval of the appointment of a member who is a peace officer as described by Article 2.12, Code of Criminal Procedure, the chief of police may authorize the person appointed to carry a weapon or act as a peace officer at all times, regardless of whether the person is engaged in the actual discharge of official duties, or may limit the authority of the person to carry a weapon or act as a peace officer to only those times during which the person is engaged in the actual discharge of

official duties. A reserve police officer, regardless of whether the reserve police officer is a peace officer as described by Article 2.12, Code of Criminal Procedure, is not:

- (1) eligible for participation in any program provided by the governing body that is normally considered a financial benefit of full-time employment or for any pension fund created by statute for the benefit of full-time paid peace officers; or
 - (2) exempt from Chapter 1702, Occupations Code.
- (i) This section does not limit the authority of the mayor of a Type A general-law municipality to summon a special police force under Section 341.011.

Sec. 16-46. - Established, qualifications.

There shall be established a position of reserve peace officer which shall be an office staffed by persons who are qualified under Vernon's Ann. C.C.P. art. 2.12 or who may have qualified as peace officers under some other provision of the law with equivalent qualifications thereof.

Sec. 16-47. - Standards, duties of service.

Any peace officer who shall serve under the provisions of this article shall serve in accord with the requirements upon such officer, including his duties set forth in Vernon's Ann. C.C.P. arts. 2.13, 2.14 and 2.16.

Sec. 16-48. - Powers.

Except as otherwise provided by law, each officer qualifying under this article shall have the power set forth to him under Vernon's Ann. C.C.P. arts. 2.15, 2.17.

Sec. 16-49. - Appointment, regulations.

Any person appointed under the terms of this article shall be appointed by the chief of police and shall serve under the regulations set forth by the chief of police for the remuneration as may be prescribed by the city council.

Sec. 16-50. - Termination.

Any officer who may be employed as a reserve peace officer under the terms hereof shall be subject to termination at the will of the chief of police whether with cause or without cause.
