SUBJECT: Monthly Budget Summary Report

SUMMARY: Receive and/or approve the November 2022 Budget Report

BACKGROUND INFORMATION:

The information provided is for the FY 2022-2023 budget period, month ending November 30, 2022. This summary highlights several key points related to the current month's activity for the General Fund and for the Water and Sewer Enterprise Fund. The attached report is unaudited, and this month may include corrections from prior months.

DISCUSSION:

Attached is the budget report for November 2022, which is the second month of Fiscal Year 23. 16.7% of the year has passed. The report reflects the original budget as approved for FY23 as well as the revised budget reflecting all budget amendments approved by council since the original budget was approved. <u>This budget report is a preliminary report reflecting current year to date figures that are unaudited and may be adjusted at a future time.</u>

10-General Fund

As of November 30, 2022, General Fund revenues total \$127,215. General Fund expenditures total \$567,828.

Revenue (GF)

Total Revenue collected in the General fund is at 5.46% of budget.

- M & O (Maintenance and Operations) Property tax (including current, delinquent and penalties) received through the end of November is \$127,215. November is the first month to see large deposits come in from the county for Property Tax revenue. The majority of property tax revenue will be received between October and January.
- Sales Tax revenue received in November was earned in September. Therefore, it does not show on this budget report as it was included in FY22 revenue.
- Permits and Licenses revenues total \$858 this month. Inspection fees collected are \$2,530 while fees paid for inspections are \$4,840 as of the end of November.

Water Impact fees collected this year total \$4,828. No Sewer impact fees have been collected. All Impact Fees are posted to Fund 32 Utility Capital Improvements.

• Court revenue for the month of November is \$9,525, year to date totaling \$18,706.





Expenditures (GF)

Expenditures in the General Fund are currently shown at \$567,828, 20.18% of budget. Expenditures are tracking slightly ahead of expected budget at this point in the year due to front loaded expenses, such as insurance, and one-time expenses, such as the payment on the Fire Engine and software annual fees. The only line item that is currently exceeding annual budget is Attorney Fees.


You may notice a negative amount under city maintenance capital equipment. The new sign for city hall was originally coded to the incorrect department in October and November when invoices were paid. I created a journal entry to move it to administration capital equipment dated in November. This caused current period expenditure in city maintenance to be negative but brought year to date to the correct amounts for each.

All approved transfers to and from the General Fund have been made, with the exception of the transfer to Transportation Fund for road repairs. This brings our Total Income (bottom line) \$798,722 less than anticipated annual income. As revenue is received, this disparity will lessen.

30-Water, Sewer and Solid Waste Fund

Operating Revenues received through FY23 total \$427,946. Operating expense is \$387,809. As mentioned in the discussion of General Fund expenditures, some expenses have been paid for the year.

William Yearsin - 244 Briar Creek – Mr. Yearsin addressed council requesting investigation into council woman Melissa Strawn.

VII. PUBLIC HEARING

A. Public hearing and possible action adopting Ordinance 22-500 amending Appendix B Zoning Ordinance, Section Four - Districts, Subsection Five - R-4 Single Family Rural Residential Zoning District of the Code of Ordinances.

Open public hearing at 6:09 p.m.

Mike Challenger - 32726 Bayou Bend - Spoke regarding the zoning change and how he would like to see it handled. Stated the city shouldn't be destructive and ordering buildings to be torn down. Stated rules changed based on the mission. He added that the mission should be building at this time. Would like to see the City establish a vision to establish a mission.

Chris & Taylor Clinton - 31511 Bayou Bend - Spoke in favor of 7.5 foot setbacks on Bayou facing lots and 15 feet not to exceed 10% for all other lots.

Daniel Coffey - 33502 Blue Crab Ct – spoke in favor of changing the setbacks to match the plats.

Ed Podhiry - 32502 Bayou Bend- agreed with previous statement

Michael Durham- 31434 Bayou Bend – spoke in favor of changing the setbacks and clarifying the variance from 2008.

Cindy Moriarty - 31610 Bayou Bend - expressed thanks for all the effort in this matter. She stated their opinion is to keep setbacks as they are. Wanted to see if Council has taken the time to visit the properties in question and how they appear. Stated the current issue has become hostile and many that are against the proposed change are refusing to enter their opinion. Also questioned what precedent this sets by allowing a violation to cause a movement to change ordinance.

Mayor Boykin addressed the research done by Council and Staff.

Council member Strawn stated she found the original design of the neighborhood and has the language regarding the drainage out in the neighborhood.

Jimmie Silver - 34110 Bayou Bend - asked how this makes a difference when he can build his home in the same location. Spoke in favor of changing the setbacks.

Discussion held on drainage and how setbacks affect the area.

Council member Yarborough spoke regarding his research on the issue.

Discussion was held on drainage and the responsibility of the HOA since they maintain drainage within the neighborhood.

Irma Callaway - 31603 Bayou Bend - spoke against the change. Mrs. Callaway addressed the council regarding the rural residential zoning and preserving the feel of the neighborhood by keeping the setbacks. Stated Council is not hearing from everyone who has opinions in the matter. Would like to see focus put on the future of the neighborhood and not just on the opinion of a few. Added the change will create added risk to fire and flooding.

CITY OF RICHWOOD CHARTER REVIEW COMMISSION 2022

General Comments:

The 2022 Charter Review Commission was appointed in October 2022. They met as available in three separate meetings beginning October 20, 2022, through November 22, 2022. The Commission was supported by administrative staff.

Recommendations:

Section 7.02. Initiative.

Qualified voters of the City of Richwood may initiate legislation by submitting a petition addressed to the City Council which requests the submission of a proposed ordinance or resolution to a vote of the qualified voters of the City. The petition must be signed by the qualified voters of the City equal in number to at least twenty percent (20%) ten percent (10%) of the qualified voters of the City. The petition shall be signed as provided in section 6.03 of this Charter. The petition may consist of one or more copies as permitted in section 6.04 of this Charter, but each copy shall have attached to it a copy of the proposed ordinance or resolution. The petition shall be filed with the person performing the duties of City Secretary. In the next regularly scheduled City Council meeting and noticed in accordance with the Texas Open Meetings Act, the person performing the duties of City Secretary shall present the petition and the proposed ordinance or resolution to the City Council. Upon presentation to it of the petition and the proposed ordinance or resolution, it shall become the duty of the City Council, within ten (10) days after the receipt thereof, to pass and adopt such ordinance or resolution without alteration as to meaning or effect in the opinion of the persons filing the petition or within the time frames established by law, call a special election to be held on the next uniform election date under state law by which lawful notices can be given and full absentee balloting had, at which the qualified voters of the City of Richwood shall vote on the question of adopting or rejecting the proposed legislation. City Council shall be permitted to make any such alterations as are necessary to make such legislation compliant with state law. If any such legislation seeks the enforcement of any illegal act or any act for which the City lacks authority to enforce, City Council shall not pass or adopt the ordinance or resolution.

Rationale

The proposed amendment lowers the threshold of required signatures on a petition by 10%, thus making it more obtainable for residents to present initiatives to the City.

Section 11.12. Charter Review Commission.

The City Council shall appoint each even numbered year a Charter Review Commission of five citizens of the City.

(a) Duties of the Commission. It shall be the duty of such Charter Review Commission to:

1. Inquire into the operations of the City government under the Charter provisions and determine whether any such provisions require revision. To this end public hearings may be held, and the Commission shall have the power to compel the attendance of any officer or employee of the City and to require the submission of any of the City records which it may deem necessary to the conduct of such hearing;

2. Propose any recommendations it may deem desirable to ensure compliance with the provisions of the Charter by the several departments of the City government;

3. Propose, if it deems desirable, amendments to this Charter to improve the effective application of said Charter to current conditions;

4. Report its findings and present its proposed amendments if any, to the City Council.

(b) Action by the City Council. The City Council shall receive and have published in a newspaper of general circulation in the City any report presented by the Charter Review Commission, shall consider any recommendations made, and if any amendments or amendment be presented as a part of such report may shall order such amendment or amendments to be submitted to the voters of the City in the manner provided by the applicable statute of the State of Texas.

(c) Term of office. The term of office of such Charter Review Commission shall be one year and, if during such term no report is presented to the City Council, then all records of the proceedings of such Commission shall be filed with the person performing the duties of City Secretary and shall become a public record.

Rationale

The proposed amendment requires the City Council to order amendments presented by the Charter Review commission to be submitted to the voters of the City of Richwood.

ORDINANCE NO. 23-501

AN ORDINANCE ORDERING AN ELECTION TO BE HELD IN THE CITY OF RICHWOOD, ON SATURDAY, MAY 6, 2023, FOR THE PURPOSE OF ELECTING CERTAIN OFFICERS FOR THE CITY OF RICHWOOD; PROVIDING THAT ALL PERSONS DESIRING TO HAVE THEIR NAME PLACED ON THE OFFICIAL BALLOT AS A CANDIDATE FILE AN APPLICATION NOT LATER THAN FEBRUARY 17 2023, PROVIDING THAT ALL DULY QUALIFIED **ELECTORS** BE **QUALIFIED** RESIDENT SHALL TO VOTE: APPROVING A JOINT ELECTION AGREEMENT WITH BRAZORIA **COUNTY; AND PROVIDING FOR SEVERABILITY.**

WHEREAS, the City of Richwood is a home rule city acting under its charter adopted by the electorate pursuant to Article XI, Section 5 of the Texas Constitution and Chapter 9 of the Texas Local Government Code; and

WHEREAS, Section 41.001 of the Texas Election Code (the "Code") specifies that the first Saturday in May shall be a uniform election date; and

WHEREAS, all of the City of Richwood and its voting precincts are located within Brazoria County only; and

WHEREAS, by this Ordinance, it is the intention of the City Council to adopt all requirements of an Election Order and Notice of Election in accordance with state law, and authorize a contract with Brazoria County for joint election services.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RICHWOOD, TEXAS:

Section 1. That an election is hereby ordered and shall be held in and throughout the City of Richwood, Texas, on the 6th day of May, 2023, being the first Saturday in May, between the hours of 7 a.m. and 7 p.m.. Voting will be held at the Richwood City Hall, 1800 Brazosport Blvd., Richwood, Texas. Voting will also be conducted at all the Vote Centers in Brazoria County, Texas that are listed on Exhibit A.

Section 2. That early voting by personal appearance will begin on April 24, 2023 and end on May 2, 2023. Early voting locations are attached as Exhibit B.

Section 3. That the election is ordered for the purpose of electing the following officers for the City:

The Mayor and Council Member Positions two and three

Section 4. That any person having the qualifications set out in Section 3.02 of the Charter of the City of Richwood for Mayor and Council member positions two and three may file an application to have his or her name placed on the official ballot as a candidate. Said application shall be accompanied by a loyalty affidavit of the candidate as prescribed by Section 141.031 of the Texas Election Code and said application shall be filed with the City Secretary as prescribed by Section 143.006 of the Texas Election Code not earlier than January 18, 2023 and not later than February 17, 2023.

Section 5. That said election shall be held in accordance with the Constitution and laws of the State of Texas and the Charter of the City of Richwood, and all duly qualified resident electors of the City of Richwood, Texas, shall be qualified to vote.

Section 6. JOINT ELECTION AGREEMENT APPROVED: The City Secretary is authorized to execute the Joint Election Agreement between Brazoria County and Richwood. In the event of a conflict between this Ordinance and the Contract, the Contract shall control.

Section 7. NOTICES: This Ordinance shall serve as the Order of Election (as required by Section 3.001 of the Texas Election Code).

Section 8. NECESSARY ACTIONS: The Mayor or the City Secretary of the City of Richwood, in consultation with the City Attorney as needed, are hereby authorized and directed to take any and all actions necessary to comply with the provisions of the Texas Election Code and the Contract in carrying out and conducting the election, whether or not expressly authorized herein.

Section 9. If any part or portion of this ordinance shall be invalid or unconstitutional, such invalidity or unconstitutionality shall not affect or impair any remaining portions or provisions of this ordinance.

Section 10. This ordinance shall be in full force and effective immediately after its passage.

AN ORDINANCE ORDERING AN ELECTION TO BE HELD IN THE CITY OF RICHWOOD, ON SATURDAY, MAY 6, 2023 FOR THE PURPOSE OF AMENDING THE CITY OF RICHWOOD HOME RULE CHARTER; PROVIDING FOR SEVERABILITY.

Whereas, the residents of the City of Richwood, approved the adoption the City of Richwood Home Rule Charter by majority vote on May 11, 2013;

Whereas, the City Council appointed six residents to serve as the Charter Review Commission at their first regularly scheduled meeting in October 2022;

Whereas, the Charter Review Commission met and reviewed all sections of the Charter and presented their recommendations to City Council for approval to be placed on the May 6, 2023, ballot to be presented to the voters;

Whereas, the City Council finds it appropriate to call the special election to propose amendments to the City Charter be placed on the May 6, 2023 ballot to be presented to the voters; and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF RICHWOOD, TEXAS:

Section 1. That an election to amend the City of Richwood Home Rule Charter is hereby ordered and shall be held in and throughout the City of Richwood, Texas, on the 6th day of May 2023, being the first Saturday in May, between the hours of 7 am and 7 pm. Voting locations are attached as Exhibit B.

Section 2. That early voting by personal appearance will begin on April 24, 2023, and end on May 2, 2023. Early voting locations are attached as Exhibit C.

Section 3. That the proposed text amendments are hereby attached as Exhibit A.

Section 4. That the election is ordered for the purpose of submitting the following proposed amendments to the Home Rule Charter of the City of Richwood to the qualified voters:

Proposition A

Shall Section 7.02 be amended to require petitions for legislation initiative be signed by the qualified voters of the City equal in number to at least ten percent (10%) of the qualified voters of the City?

Proposition B

Shall Section 11.12 (b) be amended to require the City Council to call for any amendments to the Charter of the City of Richwood recommended by the Charter Review Commission be presented to qualified voters of the City.

Section 6. That said election shall be held in accordance with the Constitution and laws of the State of Texas and the Charter of the City of Richwood, and all duly qualified resident electors of the City of Richwood, Texas, shall be qualified to vote.

Section 7. NECESSARY ACTIONS: The Mayor or the City Secretary of the City of Richwood, in consultation with the City Attorney as needed, are hereby authorized and directed to take any and all actions necessary to comply with the provisions of the Texas Election Code and the Contract in carrying out and conducting the election, whether or not expressly authorized herein.

Section 8. If any part or portion of this ordinance shall be invalid or unconstitutional, such invalidity or unconstitutionality shall not affect or impair any remaining portions or provisions of this ordinance.

EXHIBIT A

Proposed Text Amendments to the City of Richwood Home Rule Charter

PROPSITION A

Section 7.02. Initiative.

Qualified voters of the City of Richwood may initiate legislation by submitting a petition addressed to the City Council which requests the submission of a proposed ordinance or resolution to a vote of the qualified voters of the City. The petition must be signed by the qualified voters of the City equal in number to at least twenty percent (20%) ten percent (10%) of the qualified voters of the City. The petition shall be signed as provided in section 6.03 of this Charter. The petition may consist of one or more copies as permitted in section 6.04 of this Charter, but each copy shall have attached to it a copy of the proposed ordinance or resolution. The petition shall be filed with the person performing the duties of City Secretary. In the next regularly scheduled City Council meeting and noticed in accordance with the Texas Open Meetings Act, the person performing the duties of City Secretary shall present the petition and the proposed ordinance or resolution to the City Council. Upon presentation to it of the petition and the proposed ordinance or resolution, it shall become the duty of the City Council, within ten (10) days after the receipt thereof, to pass and adopt such ordinance or resolution without alteration as to meaning or effect in the opinion of the persons filing the petition or within the time frames established by law, call a special election to be held on the next uniform election date under state law by which lawful notices can be given and full absentee balloting had, at which the qualified voters of the City of Richwood shall vote on the question of adopting or rejecting the proposed legislation. City Council shall be permitted to make any such alterations as are necessary to make such legislation compliant with state law. If any such legislation seeks the enforcement of any illegal act or any act for which the City lacks authority to enforce, City Council shall not pass or adopt the ordinance or resolution.

PROPOSITION B

Section 11.12. Charter Review Commission.

The City Council shall appoint each even numbered year a Charter Review Commission of five citizens of the City.

(a) Duties of the Commission. It shall be the duty of such Charter Review Commission to:

1. Inquire into the operations of the City government under the Charter provisions and determine whether any such provisions require revision. To this end public hearings may be held, and the Commission shall have the power to compel the attendance of any officer or employee of the City and to require the submission of any of the City records which it may deem necessary to the conduct of such hearing;

2. Propose any recommendations it may deem desirable to ensure compliance with the provisions of the Charter by the several departments of the City government;

3. Propose, if it deems desirable, amendments to this Charter to improve the effective application of said Charter to current conditions;

4. Report its findings and present its proposed amendments if any, to the City Council.

(b) Action by the City Council. The City Council shall receive and have published in a newspaper of general circulation in the City any report presented by the Charter Review Commission, shall consider any recommendations made, and if any amendments or amendment be presented as a part of such report may shall order such amendment or amendments to be submitted to the voters of the City in the manner provided by the applicable statute of the State of Texas.

(c) Term of office. The term of office of such Charter Review Commission shall be one year and, if during such term no report is presented to the City Council, then all records of the proceedings of such Commission shall be filed with the person performing the duties of City Secretary and shall become a public record.

ORDINANCE NO. 23-503

AN ORDINANCE OF THE CITY OF RICHWOOD, TEXAS ORDERING A SPECIAL ELECTION TO BE HELD ON MAY 6, 2023, TO DETERMINE WHETHER THE VOTERS OF THE CITY OF RICHWOOD DESIRE TO CONTINUE A SALES AND USE TAX FOR MAINTENANCE AND REPAIR OF MUNICIPAL STREETS IN THE CITY; PROVIDING FOR NOTICE; PROVIDING FOR EARLY VOTING; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of RICHWOOD is a home rule city acting under its charter adopted by the electorate pursuant to Article XI, Section 5 of the Texas Constitution and Chapter 9 of the Texas Local Government Code; and

WHEREAS, pursuant to the Texas Tax Code, V.T.C.A., Chapter 327.001 et. seq, (the "Act"), the City of RICHWOOD adopted a one-fourth $(1/4^{th})$ of one percent (1%) sales and use tax to provide for street maintenance; and

WHEREAS, the Act provides that the sales and use tax for street maintenance expires after four (4) years unless it is reauthorized at an election; and

WHEREAS, the Act provides that the City Council may call an election to reauthorize a previously adopted sales and use tax to provide for street maintenance by adopting an ordinance; and

WHEREAS, the Act provides that an election to reauthorize the sales and use tax shall be held in accordance with Chapter 321 of the Texas Tax Code; and

WHEREAS, Section 321.403 of the Texas Tax Code states that such an election must be held on the first succeeding uniform date for which sufficient time elapses for the holding of an election; and

WHEREAS, Section 41.001 of the Texas Election Code (the "Code") specifies that the first Saturday in May shall be a uniform election date;

WHEREAS, all of the City of RICHWOOD and its voting precincts are located within Brazoria County only; and

WHEREAS, by this Ordinance, it is the intention of the City Council to adopt all requirements of an Election Order and Notice of Election in accordance with state law, and authorize a contract with Brazoria County for joint election services.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RICHWOOD, TEXAS:

Section 1. That special election to submit to the voters a proposition to determine whether to reauthorize the one-fourth $(1/4^{\text{th}})$ of one percent (1%) sales and use tax for street maintenance purposes is hereby ordered and shall be held in and throughout the City of Richwood, Texas, on the 6^{th} day of May 2023, being the first Saturday in May.

Section 2. That voting on Election Day will be held at the Richwood City Hall, 1800 Brazosport Blvd, Richwood, Texas. Voting will also be conducted at all of the Vote Centers in Brazoria County, Texas that are listed on Exhibit A. That early voting by personal appearance will begin on April 24, 2023, and end on May 2, 2023. Early voting locations are attached as Exhibit B.

Section 3. The official ballots for said election shall be prepared in accordance with the Texas Election Code so as to permit the electors to vote 'FOR" or "AGAINST" the proposition, with the ballots to contain such provisions, markings and language as required by law, and with such proposition to be expressed substantially as follows:

Section 4. NOTICES: This Ordinance shall serve as the Order of Election (as required by Section 3.001 of the Code) and as the Notice of Election (as required by Section 4.001 of the Code). Notice shall be published in the newspaper in accordance with state law.

Section 5. NECESSARY ACTIONS: The Mayor or the City Secretary of the City, in consultation with the City Attorney as needed, are hereby authorized and directed to take any and all actions necessary to comply with the provisions of the Code and the Contract in carrying out and conducting the election, whether or not expressly authorized herein.

Section 6. If any part or portion of this ordinance shall be invalid or unconstitutional, such invalidity or unconstitutionality shall not affect or impair any remaining portions or provisions of this ordinance.

Section 7. This ordinance shall be in full force and effective immediately after its passage.
