BACKGROUND INFORMATION:

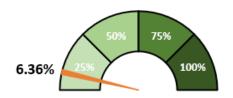
The information provided is for the FY 2024-2025 budget period, month ending November 30, 2024. This summary highlights several key points related to the current month's activity for the General Fund and for the Water and Sewer Enterprise Fund. The attached report is unaudited, and this month may include corrections from prior months.

DISCUSSION:

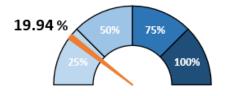
Attached is the budget report for November 2024, which is the first month of Fiscal Year 2025. 16.7% of the year has passed. The report reflects the original budget as approved for FY25 as well as the revised budget reflecting all budget amendments approved by council since the original budget was approved. <u>This budget report is a preliminary report reflecting current year-to-date figures that are unaudited and may be adjusted at a future time.</u>

10-General Fund

As of November 30, 2024, General Fund revenues total \$233,090. General Fund expenditures total \$693,286.

Revenue (GF)

Total Revenue collected in the General fund is 6.36% of budget projection.

- M & O (Maintenance and Operations) Property tax (including current, delinquent and penalties) received through the end of November is \$163,010, 5% of projected property taxes for the year. Property tax revenue comes in throughout the year, but the majority comes in during the months of December and January.
- Sales Tax revenue received in November was earned in August. Sales tax is received 2 months after it is earned. The revenue received in October and November 2024 was posted to revenue in FY24.

City of Richwood TEXAS

Accordingly, the revenue earned in August and September 2025, will be posted as revenue for FY25 even though it will not be received by the city until October and November. Therefore, we will not show any revenue in the current fiscal year until December.

- Permits and Licenses revenues total \$7,440 this month. This is compared to \$3,522 collected at this time last year.
- Inspection fees collected are \$5,600 year to date. Of this amount, \$2,265 has been paid to Safebuilt for inspections.
- Municipal Court revenue for the month of November is \$10,537. This compares to \$12,903 at this time last year.
- Interest revenue is \$4,568 this month for a total of \$10,808 year to date.
- The Ambulance fee collected year to date is \$16,898.

Expenditures (GF)

Expenditures in the General Fund are currently shown at \$693,286, 19.94% of budget.

Transfers (GF)

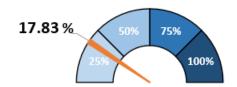
Interfund transfers have not yet been made. They will be processed after more revenue comes in to negate the need to take from investments as we are keeping a minimal amount in pooled cash.

Operating Revenues in November total \$498,497 year to date. Operating expenses are \$424,626.

Elections

CITY OF RICHWOOD CHARTER REVIEW COMMISSION 2024

MEMBERS:

General Comments:

The 2024 Charter Review Commission was appointed in October 2024. They met as available in three separate meetings beginning October 23, 2024, through November 18, 2024. The Commission was supported by administrative staff.

Recommendations:

Section 3.01. - Number, selection and term.

The legislative and governing body of the City shall consist of a Mayor and five council members and shall be known as the "City Council of the City of Richwood."

- (1) The Mayor shall be elected from the City at large. The election of members of the City Council shall be by position from the City at large, designating council positions as position one through position five, inclusive, authorizing qualified voters to vote on a candidate for each council position and providing for interim determination of council positions by lot.
- (2) The Mayor shall be the presiding officer of the City Council and shall be recognized as the head of the City government for all ceremonial purposes and by the governor for purposes of military law, but shall have no regular administrative duties. The Mayor shall be entitled to vote only in the event it becomes necessary to break a tie vote.
- (3) In each odd-numbered year two council members and a Mayor shall be elected, and in each even-numbered year three council members shall be elected.
- (4) The Mayor and each council member shall hold office for a period of two years and until his/her successor is elected and qualified. No person shall serve as Mayor or council member for more than three (3) consecutive terms in any position. One must be removed from City Council for a period of one (1) year to reapply. However, should a position or vacancy go unfilled, termed out individuals may apply for an appointment within one (1) year. All elections shall be held in the manner provided in article 5 of this Charter.
- (5) All members of the City Council shall be subject to removal from office under the terms and conditions of the recall provisions of this Charter.

Rationale

The proposed amendment allows individuals who have termed out of an elected position to apply for a vacancy appointment should there be no other applications for appointment.

Section 3.06. - Vacancies.

When a vacancy occurs in the City Council, the remaining members of the council, shall, within thirty (30) days (except within sixty (60) days of a regular City election or during a run-off election period), appoint a qualified person to fill the unexpired term. However, the City Council shall not appoint more than two council members in any twelve (12) month period, and in case a vacancy has been filled by the City Council within the twelve (12) month period prior to the subsequent vacancy, or if more than two (2) vacancies occur at the same time or before a prior vacancy has been filled, the City Council shall call a special election within thirty (30) days from the date the last vacancy occurred, to be held within fifty (50) days thereafter, for the purpose of electing the successor or successors to the office or offices vacated. When a vacancy occurs in the Mayor's position, the Mayor Pro Tem will serve as Mayor for the remainder of the term and the City Council will follow the provision of this section to fill the vacancy left by Mayor Pro Tem.

Rationale

The proposed amendment requires the Mayor Pro Tem to move into the position of Mayor in the instance of a vacancy and Council to appoint a replacement for the Council Member moving to the Mayors position.

Section 3.12. - Investigation by the City Council.

The City Council shall have the power to inquire into the conduct of any office, department, agency, officer, employee, or elected/appointed officials of the City and to make investigations as to municipal affairs, and for that purpose may subpoena witnesses, administer oaths and compel the production of books, papers, and other evidence. Failure to obey such subpoena or to produce books, papers or other evidence as ordered under the provisions of this section shall constitute a misdemeanor and shall be punishable by fine not to exceed \$500.00.

Rationale

The proposed amendment allows council members to inquire into the conduct of other elected or appointed officials.

ORDINANCE NO. 25-524

AN ORDINANCE ORDERING AN ELECTION TO BE HELD IN THE CITY OF RICHWOOD, ON SATURDAY, MAY 3, 2025, FOR THE PURPOSE OF ELECTING CERTAIN OFFICERS FOR THE CITY OF RICHWOOD; PROVIDING THAT ALL PERSONS DESIRING TO HAVE THEIR NAME PLACED ON THE OFFICIAL BALLOT AS A CANDIDATE FILE AN APPLICATION NOT LATER THAN FEBRUARY 14, 2025, PROVIDING THAT ALL DULY QUALIFIED RESIDENT ELECTORS SHALL BE QUALIFIED TO VOTE; APPROVING A JOINT ELECTION AGREEMENT WITH BRAZORIA COUNTY; AND PROVIDING FOR SEVERABILITY.

WHEREAS, the City of Richwood is a home rule city acting under its charter adopted by the electorate pursuant to Article XI, Section 5 of the Texas Constitution and Chapter 9 of the Texas Local Government Code; and

WHEREAS, Section 41.001 of the Texas Election Code (the "Code") specifies that the first Saturday in May shall be a uniform election date; and

WHEREAS, all of the City of Richwood and its voting precincts are located within Brazoria County only; and

WHEREAS, by this Ordinance, it is the intention of the City Council to adopt all requirements of an Election Order and Notice of Election in accordance with state law, and authorize a contract with Brazoria County for joint election services.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RICHWOOD, TEXAS:

Section 1. That an election is hereby ordered and shall be held in and throughout the City of Richwood, Texas, on the 3rd day of May, 2025, being the first Saturday in May, between the hours of 7 a.m. and 7 p.m.. Voting will be held at the Richwood City Hall, 1800 Brazosport Blvd., Richwood, Texas. Voting will also be conducted at all the Vote Centers in Brazoria County, Texas that are listed on Exhibit A.

Section 2. That early voting by personal appearance will begin on April 22, 2025 and end on April 29, 2025. Early voting locations are attached as Exhibit B.

Section 3. That the election is ordered for the purpose of electing the following officers for the City: **The Mayor and Council Member Positions two and three**

Section 4. That any person having the qualifications set out in Section 3.02 of the Charter of the City of Richwood for Mayor and Council member positions two and three may file an application to have his or her name placed on the official ballot as a candidate. Said application shall be accompanied by a loyalty affidavit of the candidate as prescribed by Section 141.031 of the Texas Election Code and said application shall be filed with the City Secretary as prescribed by Section 143.006 of the Texas Election Code not earlier than January 15, 2025 and not later than February 14, 2025.

Section 5. That said election shall be held in accordance with the Constitution and laws of the State of Texas and the Charter of the City of Richwood, and all duly qualified resident electors of the City of Richwood, Texas, shall be qualified to vote.

Section 6. JOINT ELECTION AGREEMENT APPROVED: The City Secretary is authorized to execute the Joint Election Agreement between Brazoria County and Richwood. In the event of a conflict between this Ordinance and the Contract, the Contract shall control.

Section 7. NOTICES: This Ordinance shall serve as the Order of Election (as required by Section 3.001 of the Texas Election Code).

Section 8. NECESSARY ACTIONS: The Mayor or the City Secretary of the City of Richwood, in consultation with the City Attorney as needed, are hereby authorized and directed to take any and all actions necessary to comply with the provisions of the Texas Election Code and the Contract in carrying out and conducting the election, whether or not expressly authorized herein.

Section 9. If any part or portion of this ordinance shall be invalid or unconstitutional, such invalidity or unconstitutionality shall not affect or impair any remaining portions or provisions of this ordinance.

Section 10. This ordinance shall be in full force and effective immediately after its passage.
