ORDINANCE NO. 23-504

AN ORDINANCE AMENDING CHAPTER 15 PLANNING AND DEVELOPMENT ARTICLE II PLANNING AND ZONING COMMISSION OF THE RICHWOOD CODE OF ORDINANCES FOR THE PURPOSE OF AMENDING SECTION 15-27 – MEMBERSHIP AND SECTION 15-28 - VACANCIES; PROVIDING A SAVINGS CLAUSE; AND PROVIDING THAT THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FORCE IMMEDIATELY UPON ITS PASSAGE.

WHEREAS, The City of Richwood finds it necessary to amend the provisions of the planning and zoning commission;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RICHWOOD THAT:

Section 1. Section 15-27. – Membership is hereby amended to read:

The city council shall appoint a city planning commission consisting of six (6) members who shall be residents of the City of Richwood and shall serve without compensation and shall not currently hold elected office within the City of Richwood. and shall not hold any other position in the city government.

Section 2. Sec. 15-28. – Vacancies is hereby amended to read:

Membership on the planning commission shall be accompanied by active participation in the activities of the commission, and the city council may by ordinance provide attendance requirements. If there shall be a lack of quorum or shortage of volunteers to serve on the commission for not more than two scheduled meetings, the city council may serve as planning commission.

- **Section 3.** That if any provision of this ordinance or application thereof to any person or circumstance is held invalid by any court, such holding shall not affect the validity of the remaining portions of this ordinance, and the City Council of the City of Richwood, Texas, hereby declares that it would have enacted such remaining portions despite any such invalidity.
- **Section 4**. That all ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of the conflict only.
- **Section 5.** That this ordinance shall be effective immediately upon adoption.

A RESOLUTION AMENDING THE FISCAL YEAR 2022-2023 BUDGET TO ALLOW TRANSFER \$37,000 FROM CAPITAL EXPENDITURES TO ENTERPRISE FUND

WHEREAS, the City of Richwood City Council adopted a budget for the City of Richwood, Texas, for the fiscal year 2022-2023 in September 2022;

WHEREAS, Public Works Director Clif Custer has requested that a budget amendment be approved in an amount not to exceed \$50,000 within Fund 32 Utility Capital Improvements for the rebuildfing of the electrical panel at Lift Station #4

WHEREAS, staff requests council approve the capital expenditure in Fund 32.

SUBJECT: Budget Amendment to fund rebuilding of electrical panel at Lift Station 4

SUMMARY:

Public Works has requested the council approve a budget amendment to increase the budget line item 32-32-5240 System Improvement Expenditures by no more than \$50,000 for the necessary rebuilding of the electrical panel at Lift Station 4.

BACKGROUND INFORMATION:

This will pay for a new control box, main disconnect, and meter can, complete with all new electrical components to operate and monitor the lift station. The cost will also cover necessary bypass pumping while the station's electrical service is brought down to transfer service to the new electrical panel. Richwood Public Works will offset some of that cost by building the structural rack that electrical components will be mounted to.

FISCAL IMPACT: Increase in Fund 32 expenditures. Ample fund balance is available for this capital expenditure.

RECOMMENDATION: We are requesting of Council a motion to approve a budget amendment not to exceed \$50,000 for the expenditure in Fund 32.

Corrosiveness of H2S requires more frequent service including the cleaning of points and contacts to keep the station operational.





The compromised structural integrity of the electrical panel is causing it to lean under the weight of electrical components. Public Works is out of viable locations from which to brace the existing panel.





Further evidence of the corrosiveness H2S can be seen on the main disconnect and meter can that compromises a weather-tight seal crucial for safe operations.
