3. Farmers Market Recap/Winter Market

Amber Chitwood was present and gave an overview of the 2024 outdoor market season. 63 vendors that were approved came to the market at least once this season. Foot traffic did not increase, but Amber mention that most markets were having the same issue. The first outdoor market, 4th of July event, and Halloween were some of the best days for the market. Amber also noted that the market is considering starting an hour earlier next year, continuing the youth market, and applying for new grants for next year.
