3. M James present City of Dodgeville Park & Recreation-Financial Assistance Program  
 M James explained the process and indicated there is a grant and sponsorship search for funds as well. This is a year-round program.  
 B Butler verified funds would not come from tax roll  
 C Niehaus suggested a cap of \$1000

Motion by J Garner to recommend to the Board that the Village of Ridgeway earmark \$1000 from fund source TBD by board for the Dodgeville Parks and Rec Financial Assistance Program, for the benefit of Ridgeway kids. Seconded by C Niehaus. Motion passed.

4. Ordinance clarification

MC clarified how it came to be as is in current form. The forestry portion was more a "greenery" thing and there were trees to cut and repurchasing of trees all of that fell into that category. Funding the garden club and the current Main St project fall into the duties definition as well. After going in depth she feels it is good as it stands.

C Niehaus looked at other villages and towns and stated they work similarly to ours.

M Casper asked M Riniker to look for contacts at other villages and towns to see what they do.

Will continue to research and see if there are changes that need to be made and perhaps another statute that could apply for community events planning that might need to be folded in to the existing ordinance.

Suggested the commission walk the park to see what further needs to be done.

5. Gym floor update

Riniker shared that the board will be donated for the gym and others have volunteered their time to assist in installing them. Work will commence after Board approval next week.

Public Works is determining if there is still leakage.
