Call to Order

o Mayor Joshua Ramsell called the City Council Special Workshop to order at 10:13 am.

Attendees

- PRESENT: Mayor Joshua Ramsell, Mayor Pro-tem Margaret R. Gutjahr, Councilor Arthur Apodaca, Councilor Lawrence Gordon, Councilor Jimmie Winters.
 - Present: City Manager Dr. Martin Moore, Municipal Clerk Elizabeth Adair, Fire Chief/Code Enforcement Director Andrew Tabet.

Law Enforcement

- Manager Dr. Moore began a discussion on the call outs in the community around 228 of the 233 calls where for Rio Communities as well as some for extra patrol just for one month, he showed a date range from LexisNexis community crime map and explained what icons can be shown and proceeds to explain the functions as well as explains why people have not been reporting incidents due to long wait times and officers not responding due to another incident.
- Councilor Gutjahr said for clarity this is the same thing that will happen if we have officers.
- Manager Dr. Moore continued with the crime map and showed how much different Belen and Rio Communities are on the crime map as well as showing council Valencia County and how much crime is around.
- Councilor Gutjahr said to remember that Belen has 25 officers, and we have 1 plus backup the citizens really wanted us to go for a police chief back in 2015. She continued by saying there was a different website back then and anyone had access to it, she categorized where the most crime was located and only had 3 locations where you had meaningful calls but, on this map, now she describes the pattern had changed but not so much, but this is the right way to go.
- Manager Dr. Moore continued with the discussion by stating on one side of town it appears to have more domestics than others as well as a part of town that has more deaths than others. He then said we can consider ourselves fortunate that our crime rate is where it is right now.
- Manager Dr. Moore said an issue in front of us is talking about law enforcement as our final year with the Sheriffs Department is here and with a possibility for an extension, we are pulling out of the community policing service, and continued with the discussion.
- Manager Dr. Moore said this is a hypothetical decision looking at a critical path for approximately 6 months to getting a police chief that's with remodeling as well as getting new police equipment/cars.
- Councilor Gordon asked what the scenario is for getting officers after the police chief.
- Manager Dr. Moore explained the scenario is within the first 6 months getting a chief and then by July of the following year you will be ready to hire several officers

depending on revenue. He then said if the Sheriffs office gives us an addition 6 months hopefully a year but if not then we will start the hiring process as soon, hopefully, as May if not July next fiscal year and then start having them do trainings as well as team up with the Sheriff's department so they can get insight on where to patrol the most in our community.

- Councilor Apodaca said last time we attended the VALEO meeting, The Mayor of Belen brought up to have a discussion having a County Law enforcement agency instead of having one of municipalities having their own. Then said looking into the future he's not sure if this would be a point of discussion but just wanted to bring this to attention. He continued stating that each city across the county have all been having problems with their own police departments, and this is why a county wide police force has been brought up.
- Manager Dr. Moore said in relationship to having a community of 7k people and a total department of 25 in Belen and continued with the discussion with if the city wants law enforcement and if they do then it will be a very critical 6-month path. He continued by saying this is a very aggressive agenda but a doable agenda.
- Councilor Gutjahr said what is suggesting is critical as well as keeping in mind about the
 comprehensive plan that meets through public safety but agrees that they need to keep
 mentioning it is a critical part of public safety. She continued by explaining without
 neighborhoods, lighting and as well as fire department and EMT and cleanup then the
 city would have to have way more officers than they do now.
- Manager Dr. Moore said there are certain communities that do not have these other
 areas in place and its not a complete reason but a factor as to why they are struggling
 and behind on effectiveness in law enforcement and continued with the discussion.
- Manager Dr. Moore said a community of our size and type, 3-5 officers is reasonable since we are not heavily retail as of yet and a critical component for us to attract new businesses is the amount of officers we are able to fund.
- Councilor Winters said we are fortunate we are a small city geographically as far as our residential and commercial wise being at the growing stage this is a great start for this process for the police department since we didn't have a choice initially till this point. He continued by saying having a county wide police force is appealing to him but would be a very long road especially with 6 different egos involved, not to mention if there is a county police force there would be a county wide tax.
- Councilor Gordon said in Canton NJ they have had they County police department and has been a model for states as well as counties and then proceeded to explain the process of what they did.
- Manager Dr. Moore said they have a joint aid as well as police chiefs, assistant chiefs, sheriffs, and undersheriffs who meet frequently as well frequent communication and proceeded to give an example of how the county wide would benefit Valencia County.
- Councilor Gordon asked if we have repeating system for radios and other equipment.
- Fire Chief Tabet said yes, we do currently have 4 different repeat system, and as of yesterday have gotten an updated system.
- Manager Dr. Moore said some areas have 5g technology and continued the discussion.
- Councilor Winters said it sounds like the mechanical issues make the process easier would just leave accounting left as well as manpower and allegations.

- Fire Chief Tabet said yes, and every agency in Valencia County is cross deputized with the police.
- Councilor Gutjahr said right before COVID she was sitting on the public safety board for NMML and that was a huge conversation about inability to be able to this. She continued by explaining there were only 3 elected officials out of 90 people the rest were EMS head or police chiefs. She finished by saying there were 2 big conversations, one was guns away from the mentally ill without breaking the first amendment and the second was cross deputization.
- Fire Chief Tabet said they constructed a unified command task when the blue hole fire had happened and continued with the discussion.
- Manager Dr. Moore continued with the presentation on revenue sources and explained the most steady revenue would be property taxes. He started by saying the current setup that municipalities are allowed to allocate is 2.75 and the counties allocation is at 2.6. He continued to say we have available 4.9 mills of the taxable assessed value of the home.
- Manager Dr. Moore said with talking with the Mayor, we would need an additional \$250,000 for a police chief and 2 officers and continued with the discussion.
- Manager Dr. Moore stated vehicles and equipment would be purchased with available cash, and said there is about \$300k, plus or minus, in capital investments. He continued to explain how switching the mill levy can benefit to the city for us to add a police chief and a few officers as well as having funds for additional trainings and such.
- Mayor Ramsell said we can try to apply for an MFA loan and stretch those funds as well as stretching vehicle purchases out for 5 to 7 years.
- Councilor Gordon said you shouldn't stretch the funds over 4 to 5 years, because the equipment needs replacements frequently.
- Fire Chief Tabet said with the vehicle purchases we can always get them off a state contract.
- Manager Dr. Moore started to explain the breakdown of the increase of mills by market value.
- Councilor Winter asked if he knew what the average would be.
- Manager Dr. Moore said he had the total assessed value for residential.
- Councilor Apodaca said if you divided it by month on a \$400k increase in property tax for a \$300k home it would only be \$33 a month, and he thinks residents would pay that for the law enforcement to be in the city and continued the discussion.
- Councilor Gutjahr said she thinks this is very sellable to residents.
- Manager Dr. Moore said this is the giving a range for the next presentation you are asking for.
- Mayor Ramsell said with talking to residents when your out and about, they say they are
 more than happy to pay more if we had additional homes, the tune of the city has
 changed, and people are willing to pay additional to help cover the cost. He continued
 by saying the idea is this is going towards public safety and as we move forward the
 dollar amount changes.
- Councilor Winters said there are so new residents within the last year or so and they seem to not have any problems paying higher taxes, and this continued the discussion.

- Mayor Ramsell said yes, they are coming from areas where their municipal rates where
 in the thousands and living here their rates are only say \$1,800 and then realize the
 reason they don't have what they were accustom to is because they are no paying for it
 here.
- Councilor Gutjahr said she thinks it is sometimes to go ahead and ask for the full amount now rather than monthly.
- Mayor Ramsell said that last time that the tax was increased was in 2015 and all council
 did was continue with the 2.75%. He then said what was also talked about if there was
 an increase then we would be able to get the police department and get what the fire
 department needs. He finished with people are more to support if its one lump instead
 of increasing every quarter and continued with the discussion.
- Manager Dr. Moore used an example if we were looking at the operating cost for 3
 officers you are looking at \$500k due to capital costs but looking at operating costs
 without inflation you're looking at \$250k coming out from the city.
- Mayor Ramsell said the issues would be depleting the revenue cash.
- Manager Dr. Moore continued with the discussion on the possibly liability cost on police officers and making sure there is not excessive spending on left over budget.
- Councilor Gutjahr said we are going to have to look at the overall expenses not just what initially comes up.
- Manager Dr. Moore said yes but due to inflation they were built in.
- Councilor Winters asked where we would house this department.
- Manager Dr. Moore said looking at the building since we are still renovating, we may
 have enough room to house public works and the police department together in the
 meantime and began a discussion.
- Councilor Winters said does this give us more leverage to get more funding from the State and the federals since we are adding a department.
- Manager Dr. Moore said tremendously more.
- Mayor Ramsell said we can also apply for grants.
- Manager Dr. Moore said some other areas that is not included in this other revenue source is fines and forfeitures due to the State not allowing that as of right now.
- Manager Dr. Moore explained that the evaluations went down in 2020 but they went back up in 2021 about the same as 2019 levels and continued with the discussion.
- Councilor Gutjahr said so it may go back up from the revenues.
- Manager Dr. Moore said yes.
- Mayor Ramsell said if Council does put anything in place on July 31st of this year it would go into effect in January 2023, if after that it will not be in effect until 2024, and then asked if we could be a special workshop on Monday evening at 6:00 pm.

Accounts payable report

- Finance Clerk Adams began going over all items over \$500.00; TLC Plumbing in the amount of \$1,305.64; 2 accounts for Wells Fargo in the amount of \$3,198.92; NM Municipal League in the amount of \$1,075; Card Service Center in the amount of \$542.56; H&E in the amount of 4,620.30; Ralph T Barnes in the amount of \$975; Card Services in the amount of \$559.94; Sharp in the amount of \$677; TLC Plumbing in the amount of \$676.92; Amazon in the amount of \$505.99; WEX Bank in the amount of \$1,395.54; UniqueFleet in the amount of \$2,351.20; Valencia Soil & Water in the amount of \$9,000; 2 accounts for HDR in the amount of \$3,881.50; Card Services in the amount of \$1,447.06; Sharp in the amount of \$677; NM Kitchen Supply in the amount of \$1,318.38.
- Councilor Gordon asked why was the badges \$505.99.
- Finance Clerk Adams explained these are actually badge holders and they are for all city and fire department employees.
- Fire Chief Tabet stated they bought them in a bulk buy.

Resolution 2022 - XX BAR #4

• Finance Officer went over the budget adjustment for last fiscal year to close it all out. She started by naming each adjustment starting with, Travel expenses for elected officials in the amount of \$775; Employee Training in the amount of \$330; Salaries for Full Time employees in the amount of \$11,620; FICA-Regular in the amount of \$280; FICA-Medicare in the amount of \$65; Retirement in the amount of \$685; Health and Medical Premiums in the amount of \$3,400; Life insurance in the amount of \$7; Dental premiums in the amount of \$155; Vision premiums in the amount of \$25; Workers Compensation in the amount of \$100; Telecommunications in the amount of \$1,100; Contract-Other Services in the amount of \$550; Contract-Professional Services in the amount of \$1,165.05; Contract -Other Services in the amount of \$680; Contributions/Donations in the amount of \$560; Local-Grants from Counties to Fire Excise GRT in the amount of -\$10,450; Salaries-Term Position in the amount of \$13,075; Local-Grants from Counties to EMS in the amount of -\$40,800.

Resolution 2022 - XX Fourth Quarter Financial Report

- Finance Officer Finch began a discussion on the Recap report and went into details on how they
 started in July of 2021 with a certain amount and ended in July 2022 with a certain amount.
 (Please see agenda packet). She then said they ended with great cash balances and goes to
 show that the City of Rio Communities is a good financial steward of the taxpayers' money and
 continued the discussion.
- Manager Dr. Moore explained the home is specifically on 503 Hermosa which is one of the homes the council did a resolution on.
- Finance Officer Finch said all of the cash carryovers are looking very good and stated for all the funds they had 73.96% of budgeted revenue, expenses were only 55.13% so it was only a little over half of what you budgeted to spend.

Resolution 2022 - XX Imposing a Mil Levy Tax for the benefit of Public Safety

- Manager Dr. Moore said that the city is ready for its own Police Department and in order to pay for it we are recommending the mil levy tax increase without cutting a department such as public works or the fire department. He continued by saying since the fire department is doubling as code enforcement the police department will be dealing with highway safety as well as domestic concerns, property crimes and those types of issues. He finishes by saying in order to establish this our mil levy will now be 3.5 for residential and for non-residential it will stay at our original 2.75 mil levy.
- Finance Officer Finch said we should have it state that for non-residential the mil levy will stay at 2.75.
- Mayor Ramsell said he thinks it's a good choice to for people to understand and that way DFA
 understands and if anyone looks at the resolution they also understand, and a commercial
 property or non-residential owner knows their tax is not going to be affected.
- Manager Dr. Moore said he is looked for someone who has long years of experience with law enforcement and then proceed with recruitment and putting the pieces together such as physical location here in city hall.
- Councilor Apodaca said he thinks we are very lucky to have this facility and have a starting place for the police department

Consultant to Startup a Police Department

- Manager Dr. Moore introduced Mr. Larry Curley who is a retired police officer of 38 years. He
 continued by saying he was the marshal, which is the permanent police chief in Magdalena, and
 one of the things we feel fortunate with is he has came from a department the same size we
 are looking at.
- Manager Dr. Moore said Mr. Larry has put a proposal together and started to explain Mr. Larry
 wanted an amount not to exceed \$35k for the consultant position. He continued by stating this
 will be standard operating procedures for the police department such as job descriptions,
 layout location, as well as public and officer safety, equipment, vehicles, and vendors for state
 pricing and is prepared to introduce a draft.
- Councilor Winters asked if Mr. Larry has looked at the space and if it is adequate.
- Mr. Larry said yes he has and it is going to work.

Resolution 2022 - XX Local Government Road Fund/Municipal Arterial Road Program

- Manager Dr. Moore explained that this is the first grant that is federal and explained the
 municipal arterial road grant it deals with roads that are typically perpendicular to or provide
 some arterial or collector access to a state highway. He continued by saying this grant will start
 from the southern area of Horner Street by Hwy 47 all the up the corner street down a piece of
 Hillandale Street down to Manzano and back over to the intersection of Hwy 47 and Hwy 309.
- Manager Dr. Moore recommends drawing up plans and then come back and ask for money to construct and continued by saying he will be looking at looking at several things being both drivability and walkability on that stretch of road. He finished by explaining once all this is in place, he will be talking it to DOT and SOT for sign off and then having HDR start the process.

Authorizing payment of Temporary Wildland Fire Assignments from the State

- Manager Dr. Moore explained the Fire Department took on the major role in the big hole fire as well as another smaller fire in the district and the state stated they will reimburse us for us to pay our fire fighters, well that was in April and its now July and still have not been paid. He continued by saying they have checked on how the state sends the money and would be a reimbursement. He then said the amount requesting is not to exceed \$25k and on the city standpoint we think its only fair since we are in the financial position to do so.
- Finance Officer Finch explained the changed that would happen in the general fund as well as the wildland fire fund.

Resolution 202X - XX FY 202X Final Budget

- Finance Officer Finch went over the 2023 budget presentation which is like the interm budget report. (Please see agenda packet) She stated to explain how she divided a citizens property tax bill and showed how much the municipalities normally gets only 7.5% which means if your property value is \$150,000 then your taxable value us only 1/3rd of the net value and continued the discussion.
- Finance Officer Finch started to breakdown the property taxes and municipalities only get 15.57% the rest is divided by schools, county, and other things around the state. She continued the breakdown on each department and then mentioned for the law enforcement sheriffs' portion as of next year will be gone (if the mil levy is approved) so that will free up some of our funds as well. She continued the presentation with the one-time non-capital expenditures and continued the discussion.
- Councilor Apodaca asked about engineering and architectural services that budgeted for \$100k, do we know how much we have spent so far.
- Finance Officer Finch explained that she believes it was about \$180,000 and then explained we go way over budget but doesn't just come out of one fund but have the engineers and architects do the work for us and continued with the discussion.
- Councilor Apodaca said its great to have the back up for the city and having them making sure we have our homework done before moving on.
- Finance Officer Finch did inform council our fire fighters fund is 97% grant money from the state and continued the presentation.
- Councilor Winters said good report.
- Councilor Apodaca said good report and he is always impressed with the finances, and she always is looking in the best interest of the city to make sure that everything is taking care of.

- Finance Officer Finch explained she is a public servant, and it is her job to do what's in the best interest of the taxpayers of the City of Rio Communities.
- Councilor Gordon thanked the finance department for being very thorough.
- Mayor Ramsell thanked the finance for putting the presentation together and its very daunting for someone who doesn't understand and appreciates Finance Officer Finch for taking the time to explain what is going on.
- Manager Dr. Moore explained that the Judge has identified an individual and is questing \$18 an
 hour for up to 15 hours a pay period. He continued by saying with talking to the individual she
 feels this individual is very qualified and is worthy to request from the city council the \$18 an
 hour which would need a budget adjustment at some point.

Resolution 2022 - XX Dangerous property (86 Horizon Vista Blvd)

- Fire Chief/Code Enforcement Officer Tabet said we have gone through court which isn't getting
 resolved and it is getting worse. He then said we are coming to you to move forward with this
 property.
- Mayor Ramsell asked if they have been working with the property owner.
- Fire Chief/Code Enforcement Officer Tabet said yes they have as well as taking them to court
 twice and they have not shown up as of now they have been decaying the property as well as
 not communicating with the courts nor the code enforcement officers. He continued by saying
 with this he feels it has escalated to this extent and this is why he is here asking to take action.

Public Comment:

- Cindy Nelson said she received a letter from the City to clean up their properties back in January. She continued by explaining she is disabled and got an extension and had everything cleaned up by the middle of March. She further explained since then nothing has happened on either side of her properties alleyway and with talking to her neighbor, he explained it wasn't his responsibility to clean the alleyways and she's not sure who owns the alleyway. She continued her comment with stating she has been in a really bad fire years before that gave her PTSD and spent July 4th with her hose on due to illegal fireworks, and in May she had made a report where the code enforcement came and assessed the situation and with the fire hazard she doesn't know where to turn to. She continued her comments by saying she doesn't want to cause in issue with her neighbors but they do have a dog that barks uncontrollably and doesn't have money to purchase equipment that states how long they have been barking for long periods of time, but she is a light sleeper and will bring a different person for verification as well she called animal control and they informed her she needs evidence on the situation and just is looking for guidance to asset the situations at hand.
- Mayor Ramsell said he will talk this over with her at the end of the meeting.

Manager Report

- Code Enforcement Director Tabet gave an update on code enforcement stating he has 4 people including himself and have been knocking on doors as well as citing people to court or having them bought to council or the city manager. He continued by saying they have 39 to 45 of violations throughout the city and the various parts that were currently parading and within those 10 days after they either get a second knock on the door or a summons to court if they haven't done their part but did say they have been largely welcomed and largely cooperative.
- Manager Dr. Moore asked if the area on Howell Street has been gridded.

- Code Enforcement Director Tabet said that it has not been gridded but have been getting calls about hoarding houses or fire dangers and began to explain the Greg and other code enforcers have that area to grid and he is not sure where they have started as of yet, continued the discussion.
- Manager Dr. Moore said in relationship to alleyways us as a city need to go to individuals and tell them you need to be cleaning up so far into the alleyways but in some areas, we do not have any jurisdiction or ownership. He continued by saying it's his sincere apology that it is frustrating, but they have been doing a lot of work as well as instead of having just one code enforcer part time we have 4 code enforcers all the time.
- Ms. Nelson asked if we are responsible for the alleyways and her neighbor is refusing to clean it, what action would be taken.
- Manager Dr. Moore said there are a few things that can be done, last fall the city adopted a nuisance of dangerous properties ordinance and with this, things have to be taken in steps and if residents do not do it within the time frame, then it will be deemed a dangerous property and the steps taken today of one earlier would be taken to other properties as well. He finished by explaining MyCivic is starting to come together and soon we will have complaints in digital form instead of written documents right now and thanks to the Municipal Clerk who has worked on this for quite some time it is now getting closer.
- · Councilor Apodaca said we as a council need to tell the residents if an alleyway is private property or public property. He then asked the Fire Chief when approaching a property and it is a rental, do you start with the renter or the property owner, this continued the discussion.
- Code Enforcement Director Tabet explained the process starts with the renter and then they tell us it is the landlords' problem and if they don't want to work with us we find out whose house it actually is and get in contact with them. He continued by saying the hard part is some one the rentals are people who live out of state or vacant and trying to track down who the people are who own the property.

a) Parks and Trails update & b) Grants update

- Manager Dr. Moore explained that the Jr. Grant for \$50k was approved and will go to our community program as well as the library.
- Manager Dr. Moore gave an update on parks and trails we did get approved for our \$390k
 has went through the bond sale and DFA said that sometime in August or September get
 grant agreements out to us and then the trails have been in talks for the Rio Grande area
 again and he is not sure when it will happen, but it did pop up.
- Manager Dr. Moore explained the pothole have been worked on as well as we are working to get equipment for public works to work on them instead of asking for help. He continued by saying public works did get a tractor and a brush hog.

Council General Discussion & Future Agenda Items

- Councilor Apodaca said he still hasn't heard anything back from the triangle piece of property.
- Councilor Winters had nothing to report.
- Councilor Gordon said he mentioned the electric vehicles and still wants to see something done with those.
- Mayor Ramsell said there is a \$138 million for charging stations according to the article, the state is currently looking to be putting them along I-25, I-40 and I-10 and they want them to be

no further than one mile from the interstate so unfortunately it takes us out of the running for that funding.

- WHEREAS, local communities may need to provide land buildings infrastructure and other financial incentives to compete with other states and locales in efforts to attract and retain businesses; and,
- whereas, the New Mexico State Legislature enacted NMSA 1978, Sections 5-10-1 to 5-10-17, entitled the Local Economic Development Act, which provides to local governments the authority to use public resources for economic development purposes; and,
- WHEREAS, this Economic Development Ordinance is enacted pursuant to that statutory authority.
- WHEREAS, all ordinances or resolutions, specifically including City of Rio Communities Ordinance 2018-61, previously enacted pursuant to the Local Economic Development Act, are hereby repealed.

NOW THEREFORE BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF RIO COMMUNITIES, NEW MEXICO

Article 1. LOCAL ECONOMY DEVELOPMENT

1.1 This Ordinance may be cited as the "Local Economic Development Ordinance"

Article 2. AUTHORITY

2.1 The Local Economic Development Ordinance is enacted pursuant to the statutory authority conferred upon municipalities and counties to allow public support of economic development (NMSA 1978, Sections 5-10-1 to 5-10-17). This Ordinance is adopted as part of the City's economic development plan.

Article 3. PURPOSE

3.1 The purpose of the Local Economic Development Ordinance is to allow public support of economic projects to foster, promote and enhance local economic development efforts while continuing to protect against the unauthorized use of public money and

other public resources. Further, the purpose of the ordinance is to allow the City to enter into one or more joint powers agreements with other local governments to plan and support regional economic development projects.

3.2 Local Economic Development Act.

Local governments are allowed to provide direct or indirect assistance to qualifying business for furthering or implementing economic development plan and projects, furthermore local and regional governments have the authority to contribute assets to development projects; however, the imposition of a tax must be approved by the voters in referendum option. The City reserves the right to impose the maximum tax for eligible uses.

Article 4. DEFINITIONS AS USED IN THE LOCAL ECONOMIC DEVELOPMENT ORDINANCE

- 4.1 "arts and cultural district" means a developed district of public and private uses that is created pursuant to the Arts and Cultural District Act NMSA 1978, Sections 15-5A-1 through 15-5A-7.
- 4.2 "broadband telecommunications network facilities" mean the electronics, equipment, transmission facilities, fiber-optic cables and any other item directly related to a system capable of transmission of internet protocol or other formatted data at current federal communications commission minimum speed standard, all of which will be owned and used by a provider of internet access services.
- 4.3 "cultural facility" means a facility that is owned by the state, a city, a municipality or a qualifying entity that serves the public through preserving, educating and promoting the arts and culture of a particular locale, including theaters, museums, libraries, galleries, cultural compounds, educational organizations, performing arts venues and organizations, fine arts organizations, studios and media laboratories and live-work housing facilities.
- 4.4 "economic development project" or "project" means the project of a qualifying entity for which public support may be provided pursuant to the Local Economic Development Act.
- 4.5 "governing body" means the City of Rio Communities City Council.
- 4.6 "new full-time economic base job" means a job:
 - (a) That is primarily performed in New Mexico;
 - (b) That is held by an employee who is hired to work an average of at least thirty-two hours per week or at least forty-eight weeks per year;
 - (c) That is:
- Involved, directly or in a supervisory capacity, with the production of a service; provided that the majority of the revenue generated from the service is from sources outside the state; or tangible or intangible personal property for sale; or,
- Held by an employee who is employed at a regional, national or international headquarters operation or at an operation that primarily provides services for other operations of the qualifying entity that are located outside the state; and,

- (d) That is not directly involved with natural resources extraction or processing, on-site services where the customer is present for the delivery of the service, retail, construction or agriculture except for value-added processing performed on agricultural products that would then be sold for wholesale or retail consumption, an individual, corporation, association, partnership or other legal entity.
- 4.7 **"person"** means an individual, corporation, association, partnership or other legal entity.
- 4.8 **"public support"** means the provision of assistance by the state to a local or regional government or the provision of direct or indirect assistance to a qualifying entity by a local or regional government for an economic development project. "Public support":
 - (a) includes the provision of:
 - land, buildings or other infrastructure, by purchase, lease, grant, construction, reconstruction, improvement or other acquisition or conveyance;
 - the placement of new broadband telecommunications network facilities; provided that the facilities shall not serve a public facility or location that already meets federal communications commission baseline speed standards;
 - iii. rights-of-way infrastructure, including trenching and conduit, for the placement of new broadband telecommunications network facilities;
 - iv. public works improvements essential to the location or expansion of a qualifying entity;
 - v. payments for professional services contracts necessary for local or regional governments to implement a plan or provide public support for a project;
 - vi. direct loans or grants for land, buildings or infrastructure;
 - vii. technical assistance to cultural facilities;
 - viii. loan guarantees securing the cost of land, buildings or infrastructure in an amount not to exceed the revenue that may be derived from an increment of the:
 - municipal gross receipts tax imposed at a rate not to exceed one-fourth percent and dedicated by the ordinance imposing the increment for projects; or

- city gross receipts tax imposed at a rate not to exceed one-eighth percent and dedicated by the ordinance imposing the increment for projects;
- ix. grants for public works infrastructure improvements essential to the location or expansion of a qualifying entity and grants or subsidies to cultural facilities;
- x. land for a publicly held industrial park or a publicly owned cultural facility, by purchase; and
- xi. the construction of a building for use by a qualifying entity; but
- (b) does not include the purchase, lease, grant or other acquisition or conveyance of water rights;
- 4.9 "qualifying entity" means a corporation, limited liability company, partnership, joint venture, syndicate, association or other person that is one or a combination of two or more of the following:
 - (a) an industry for the manufacturing, processing or assembling of agricultural or manufactured products;
 - (b) a commercial enterprise for storing, warehousing, distributing or selling products of agriculture, mining or industry, but, other than as provided in Paragraph (e), (f) or (i) of this subsection, not including any enterprise for sale of goods or commodities at retail or for distribution to the public of electricity, gas, water or telephone or other services commonly classified as public utilities;
 - (c) a business, including a restaurant or lodging establishment, in which all or part of the activities of the business involves the supplying of services to the general public or to governmental agencies or to a specific industry or customer, but, other than as provided in Paragraph (e) or (i) of this subsection, not including businesses primarily engaged in the sale of goods or commodities at retail;
 - (d) an Indian nation, tribe or pueblo or a federally chartered tribal corporation;
 - (e) a telecommunications sales enterprise that makes the majority of its sales to persons outside New Mexico;
 - (f) a facility for the direct sales by growers of agricultural products, commonly known as farmers' markets;
 - (g) a business that is the developer of a metropolitan redevelopment project;
 - (h) a cultural facility; and
 - (i) a retail business.

- 4.10 "regional government" means any combination of municipalities and counties that enter into a joint powers agreement to provide for economic development projects pursuant to a plan adopted by all parties to the joint powers agreement.
- 4.11 "retail business" means a business that is primarily engaged in the sale of goods or commodities at retail and that is located in the unincorporated area of the city.

Article 5. RESTRICTIONS ON PUBLIC EXPENDITURES OR PLEDGES OF CREDIT

- 5.1 The City shall not provide public support for economic development projects as permitted pursuant to Article 9, Section 14 of the constitution of New Mexico except as provided in the Local Economic Development Act or as otherwise permitted by law.
- 5.2 The total amount of public money expended, and the value of credit pledged in the fiscal year in which that money is expended by the City for economic development projects pursuant to Article 9, Section 14 of the constitution of New Mexico and the Local Economic Development Act shall not exceed ten percent of the annual general fund expenditures of the local government in that fiscal year. The limits of this subsection shall not apply to:
 - (a) the value of any land or building contributed to any project pursuant to a project participation agreement.
 - (b) revenue generated through the imposition of the municipal infrastructure gross receipts tax at a rate not to exceed one-fourth percent and dedicated to furthering or implementing economic development plans and projects as defined by the Local Economic Development Act or projects as defined in the Statewide Economic Development Finance Act; provided that no more than the greater of fifty thousand dollars (\$50,000) or ten percent of the revenue collected shall be used to promotion and administration of or professional services contracts related to the implementation of any such economic development plan adopted by the governing body.
 - (c) revenue generated through the imposition of a city infrastructure gross receipts tax at a rate not to exceed one-eighth percent and dedicated to furthering or implementing economic development plans and projects as defined in the Local Economic Development Act or projects as defined in the Statewide Economic Development Finance Act; provided that no more than the greater of fifty thousand dollars (\$50,000) or ten percent of the revenue collected shall be used to promotion and administration of or professional services contracts related to the implementation of any such economic development plan adopted by the governing body.
 - (d) the proceeds of a revenue bond issue to which municipal infrastructure gross receipts tax revenue is pledged.
 - (e) the proceeds of a revenue bond issue to which city infrastructure gross receipts tax revenue is pledged; or,

- (f) funds donated by private entities to be used for defraying the cost of a project.
- 5.3 The City shall create an economic development fund into which revenues generated for economic development projects to which the limits of Subsection 5.2 do not apply shall be deposited. The economic development fund and income from the economic development fund shall be deposited as provided by law. Money in the economic development fund may be expended only as provided in the Local Economic Development Act or the Statewide Economic Development Finance Act.
- In order to expend money from an economic development fund for arts and cultural district purposes, cultural facilities or retail businesses, the governing body of a city that has imposed a municipal or city local option infrastructure gross receipts tax for furthering or implementing economic development plans and projects, as defined in the Local Economic Development Act, or projects, as defined in the Statewide Economic Development Finance Act, by referendum of the majority of the voters voting on the question approving the ordinance imposing the municipal or city infrastructure gross receipts tax before July 1, 2013 shall be required to adopt a resolution. The resolution shall call for an election to approve arts and cultural districts as a qualifying purpose and cultural facilities or retail businesses as a qualifying entity before any revenue generated by the municipal or city local option gross receipts tax for furthering or implementing economic development plans and projects, as defined in the Local Economic Development Act, or projects, as defined in the Statewide Economic Development Finance Act, can be expended from the economic development fund for arts and cultural district purposes, cultural facilities or retail businesses.
- 5.5 The governing body shall adopt a resolution calling for an election within seventy-five days of the date the ordinance is adopted on the question of approving arts and cultural districts as a qualifying purpose and cultural facilities or retail businesses as a qualifying entity eligible to utilize revenue generated by the Municipal Local Option Gross Receipts and Compensating Taxes Act or the City Local Option Gross Receipts and Compensating Taxes Act for furthering or implementing economic development plans and providing public support for and projects as defined in the Local Economic Development Act or projects as defined in the Statewide Economic Development Finance Act.
- 5.6 The question shall be submitted to the voters of the municipality or city as a separate question at a regular municipal or city election or at a special election called for that purpose by the governing body. A special municipal election shall be called, conducted and canvassed as provided in substantially the same manner as provided by law for general elections.
- 5.7 If a majority of the voters voting on the question approves the ordinance adding arts and cultural districts and cultural facilities or retail businesses as an approved use of the local option municipal or city economic development infrastructure gross receipts tax fund, the ordinance shall become effective on July 1 or January 1, whichever date occurs first after the expiration of three months from the date of the adopted ordinance. The ordinance shall include the effective date.

Article 6. ECONOMIC DEVELOPMENT PLAN

- 6.1 The City shall adopt an economic development plan or a comprehensive plan that includes an economic development component. An economic development plan or comprehensive plan may include an analysis of the role of arts and cultural activities in economic development. The plan may be specific to a single economic development goal or strategy or may include several goals or strategies, including any goals or strategies relating to economic development through arts and cultural activities. Any plan or plan amendment shall be adopted by ordinance.
- 6.2 The economic development plan or the ordinance adopting the plan may:
 - (a) Describe the City of Rio Communities' economic development and community goals, including any economic development goals with an arts and cultural component, and assign priority to and strategies for achieving those goals.
 - (b) Describe the types of qualifying entities and economic activities that will qualify for public support.
 - (c) Describe the criteria to be used to determine eligibility for public support and a qualifying entity to participate in an economic development project.
 - (d) Describe the way a qualifying entity may submit an application for public support pursuant including the type of information required from the qualifying entity sufficient to ensure its solvency and ability to perform its contractual obligations, its commitment to remain in the community and its commitment to the stated economic development goals of the City.
 - (e) Describe the process the City will use to verify the information submitted on an application for public support.
 - (f) If an economic development project is determined to be unsuccessful or if a qualifying entity seeks to leave the area, describe the methods the City will use to terminate its public support and recoup its investment.
 - (g) Identify revenue sources, including those of the City, that will be used to provide public support for economic development projects.
 - (h) Identify other resources the City is prepared to offer qualifying entities, including specific land or buildings it is willing to lease, sell or grant a qualifying entity; community infrastructure it is willing to build, extend or expand, including roads, water, sewers or other utilities; and professional services contracts necessary to provide these resources.
 - (i) Detail the minimum benefit the City requires from a qualifying entity, including the number and types of jobs to be created; the proposed payroll; repayment of loans, if any; purchase by the qualifying entity of City provided land, buildings or

- infrastructure; the public to private investment ratio; and direct local tax base expansion.
- (j) Describe the safeguards of public resources that will be ensured, including specific ways the City can recover any costs, land buildings or other thing of value if a qualifying entity ceases operation, relocates, or otherwise defaults or reneges on its contractual or implied obligations to the City.
- 6.3 The economic development plan shall be printed and made available to the residents within the City.

Article 7. PROJECT EVALUATION

- 7.1 The City via the City Manager or his or her designee shall review each application for public support and any public support shall be approved by ordinance.
- 7.2 The City's evaluation of an application shall be based on the provisions of the economic development plan, the financial and management stability of the qualifying entity, the demonstrated commitment of the qualifying entity to the community, as cost benefit analysis of the project and any other information the City believes is necessary for a full review of the economic development project application.
- 7.3 The City may negotiate with a qualifying entity on the type or amount of public support to be provided or on the scope of the economic development project.

Article 8. PROJECT PARTICIPATION AGREEMENT

- 8.1 Upon opting to provide public support for an economic development project, the City and the qualifying entity shall enter into a project participation agreement.
- 8.2 The City shall require a substantive contribution from the qualifying entity for each economic development project. Public support provided for an economic development project shall be in exchange for a substantive contribution from the qualifying entity. The contribution shall be of value and may be paid in money, in-kind services, jobs, expanded tax base, property or other thing or service of value for the expansion of the economy.
- 8.3 The qualifying entity shall provide security to the City for an economic development project. The security shall secure the qualifying entity's obligations based on terms stated in the project participation agreement and shall reflect the amount of public support provided to the qualifying entity and the substantive contribution expected from the qualifying entity.
- 8.4 The project participation agreement at a minimum shall set out:
 - (a) The contributions to be made by each party to the participation agreement;
 - (b) The security provided to the City for an economic development project by the qualifying entity in the form of a lien, mortgage or other indenture and the pledge of

the qualifying business's financial or material participation and cooperation to guarantee the qualifying entity's performance pursuant to the project participation agreement;

- (c) A schedule for project development and completion, including measurable goals and time limits for those goals; and,
- (d) Provisions for performance review and actions to be taken upon a determination that project performance is unsatisfactory.

Article 9. PROJECT REVENUES

- 9.1 City revenues dedicated or pledged for public support for economic development projects shall be deposited in a separate account. Separate accounts shall be established for each separate project. Money in the special account shall be expended only for economic development project purposes, which may include the payment of necessary professional services contract costs.
- 9.2 The City shall provide for an annual independent audit in accordance with the Audit Act of each special fund and project account. The audit shall be submitted to the City and is a public record.

Article 10. PLAN AND PROJECT TERMINATION

- 10.1 At any time after approval of an economic development plan, the governing body may enact an ordinance terminating the economic development plan and dissolving or terminating any or all public support for economic development projects. An ordinance repealing an economic development plan shall not be effective unless the ordinance provides for satisfying existing contracts and the rights of the parties arising from those contracts.
- 10.2 Any unexpended and unencumbered balances remaining in any project fund or account upon repeal of a plan and termination of public support for or dissolution of a project may be transferred to the general fund of the City.
