RIO DELL CITY COUNCIL REGULAR MEETING MINUTES NOVEMBER 19, 2024

Mayor Garnes called the regular meeting of the Rio Dell City Council to order at 6:00 p.m.

ROLL CALL: Present: Mayor Garnes, Mayor Pro Tem Carter, Councilmembers Orr,

PUBLIC PRESENTATIONS

Mayor Garnes invited public comment on non-agenda matters. No public comment was received.

CONSENT CALENDAR

Mayor Garnes asked if any councilmember, staff, or member of the public would like to remove any item from the consent calendar for a separate discussion. No items were removed.

A motion was made by Carter/Woodall to approve the consent calendar including the following items:

- 1) Minutes of the November 5, 2024 Regular meeting;
- 2) Proposal for one-time extension and training for the Rio Dell Bio-Scru by BCR Environmental for \$14,759.00;
- 3) Proposed American Rescue Plan (ARPA) State and Local Fiscal Recovery Funds (SLWSF) Program Funds Allocation;
- 4) Authorizing the City Manager to execute an agreement with Regional Government Services Authority in coordination with the City Attorney for an amount not to exceed \$60,000; and
- 5) Receive and File the Check Register for October.

Motion carried 5-0.

REPORTS/STAFF COMMUNICATIONS

City Manager/Staff Update

City Manager Knopp provided highlights of the staff update and provided a brief storm update. He said that the Eel River at Scotia was expected to rise to 42' with possible

flooding in the low-lying areas of Ferndale. Likely local impacts would be related to power, internet, and traffic conditions due to downed trees.

He reported that the Wastewater Collection System camera inspections (CCTV) were completed with some immediate and easily correctable Inflow & Infiltration (I & I) sources identified.

Staff met with regulators from the State Water Resources Control Board related to the City's National Pollutant Discharge Elimination System (NPDES) permit and ongoing I & I concerns.

He announced that there would be a Nuisance Advisory Committee meeting tomorrow at 3:00 p.m., followed by a Traffic Committee meeting on December 4, 2024 at 4:00 p.m.

He then reported that at the request of CalTrans, staff is doing research regarding the S. Sequoia Ave./Grayland Heights bridge as part of the State's effort to evaluate local bridges for seismic safety. He said that it is not clear whether the bridge was dedicated to the City as part of the annexation and subdivision of Grayland Heights or if it is privately owned.

Councilmember Wilson asked if the City is responsible for the maintenance of the bridge.

City Manager Knopp indicated that ownership of the bridge is unclear and it could be privately owned however, if there were a catastrophic failure, those residents would likely turn to the City for a solution. He noted that staff is still researching the history of the bridge and if there was an official dedication of the bridge to the City, there would be a recorded Offer of Acceptance filed with the County.

Councilmember Wilson referred to the City's Solid Waste Agreement and said that the City's waiver on SB 1383 compliance would be slated to expire in 2025 and asked if the City received an extension.

City Manager Knopp said that staff met today with the Franchise holder (Recology Eel River) and the consultant working with the City on the new Franchise Agreement and was told that the agreement would expire on December 31, 2026. He explained that the goal is to come back to the Council in January or February 2025 and outline some of the City's options. One option would be to maintain the baseline services with some minor modifications or possibly move to Universal Collection although there would likely be a cost increase, possibly as much as 50% because of the cost of new equipment and supplies. He said that the first step is to gather information so the Council can make an informed decision.

Mayor Garnes asked staff if the foundation on the house at 4 Painter St. was a continuous perimeter foundation.

Community Development Director Caldwell explained that it is a continuous perimeter foundation and that the builder is actually installing a block foundation with #5 rebar instead of #4 rebar so it is actually being over-built. He indicated that they are doing a great job with the rebuild and was glad to see the house being repaired after the earthquake instead of being demolished.

SPECIAL CALL ITEMS/COMMUNITY AFFAIRS/PUBLIC HEARINGS

Appointment of Two (2) Council Members (Carter and Woodall) to Serve on a Rio Dell School District/Davis St. Park Ad Hoc

City Manager Knopp provided a staff report and said that Mayor Pro Tem Carter and Councilmember Woodall have recently been attending Rio Dell School Board meetings where the topic of a new plan for Davis St. Park has gained attention. He noted that the Davis St. Park is currently owned by the School District who may be interested in the surplus or selling of the property for future development by the City as a more formal public park facility. The appointment of the Ad Hoc will formalize the City representatives to work with the District on the subject.

A motion was made by Orr/Carter to approve the appointment of Mayor Pro Tem Carter and Councilmember Woodall to an Ad Hoc Committee on the subject of the Davis Street Park and Rio Dell School District. Motion carried 5-0.

Ratify the Selection of the Artist for the Eel River Trail Community Art Installation

City Manager Knopp provided a staff report and said that on Saturday, November 9^{th,} and Tuesday, November 12th, community voting sessions were held at City Hall for the selection of the artist for the Eel River Trail community art installation. There was a total of 13 artist submissions with local area artist Blake Reagan being the overall pick from 38 total voters. Following closely behind Blake Reagan were artists Laci Dane and Kim Reid. He commented that Blake is known as a prolific mural artist locally and recently painted the owl mural on the corner of Monument Rd. and Wildwood Ave.

His vision for the art depicted native species including a Blue Herron with the Eel River Valley in the background with the Redwood Forest skyline and Marbled Murrelets tucked into a nearby redwood tree. The art would be focused on the river and the surrounding forest, being the habitat for many species. He would also work with the school kids with the art tiles on each side of the center art piece depicting a chosen animal on one side and native plants on the other side.

City Manager Knopp extended special thanks to Mayor Garnes, Mayor Pro Tem Carter and Councilmember Woodall for volunteering to staff the vote submission sessions.

Mayor Garnes thanked the community for coming out to vote on the artist and to Councilmember Wilson and his wife for participating in the process.

A motion was made by Woodall/Carter to ratify the selection of artist Blake Reagan for the community art installation. Motion carried 5-0.

City Manager Knopp provided a brief staff report and said that more often than not, the second City Council meeting in December is canceled unless there is urgent business to come before the Council. He said at this time there is no urgent business pending however, should something urgent come up, a special meeting could be called.

A motion was made by Woodall/Carter to approve the cancellation of the December 17, 2024, regular City Council meeting. Motion carried 5-0.

Mayor Garnes opened a public hearing to receive public comment on the proposed text amendment. There being no public comment, the public hearing was closed.

A motion was made by Woodall/Carter to approve the second reading (by title only) and Adoption of Ordinance No. 409-2024 amending Section 17.30.360(4) of the Rio Dell Municipal Code (RDMC) Vacation Dwelling Unit Regulations appeal period to be consistent with Section 17.35.060 of the RDMC. Motion carried 5-0.

COUNCIL REPORTS/COMMUNICATIONS

Mayor Pro Tem Carter reported on upcoming meetings and events and said that she would be attending a RREDC meeting in Arcata on Monday and announced that there would be a pet vaccine clinic held at the Rio Dell Fire Hall on Monday, November 25, 2024, from 11:00 a.m. to 1:00 p.m. In addition to vaccines, there will be flea, tick and worm medicine available and micro-chipping for anyone interested in having their animal chipped.

She also extended special thanks to the Chamber of Commerce, the Community Resource Center, the Rio Dell Fire Department, California Conservation Corp (CCC), and any other volunteers for their participation in putting up the Christmas decorations.

She requested the Parks Community Survey results be placed on the next agenda. The Council concurred. She then wished everyone a Happy Thanksgiving.

RECOMMENDATION

Approve the execution of a MOU with Critters Without Litters by the Chief of Police.

BACKGROUND AND DISCUSSION

The Rio Dell Police Department (RDPD) encounters situations in which stray, injured, or neglected animals require timely veterinary care, humane euthanasia, or basic wellness services such as vaccinations. Currently, the City has no formal agreement in place to ensure access to affordable, reliable veterinary services during business hours. This Memorandum of Understanding (MOU) with Critters Without Litters, a local nonprofit veterinary clinic directed by Kari Crockett, will establish a cooperative relationship to provide necessary animal care during their regular hours of operation (Monday through Thursday, 8:00 a.m. to 4:00 p.m.). Services covered include emergency treatment, rabies vaccinations, wellness exams (by appointment), and euthanasia when warranted. The MOU clarifies that the City will be responsible for transporting animals to and from the clinic, and includes provisions to limit the City's liability once animals are in CWOL's care. This agreement will help streamline animal-related responses, improve humane treatment standards, and create a consistent point of contact for routine and emergent veterinary needs during regular business hours.

MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF RIO DELL AND CRITTERS WITHOUT LITTERS

This Memorandum of Understanding ("MOU") is made and entered into this day of, 2025, by and between the City of Rio Dell, a municipal corporation ("City"), acting through its Police Department ("RDPD"), and Critters Without Litters, a California nonprofit veterinary clinic ("CWOL"), directed by Kari Crockett.		
1. Purpose		
The purpose of this MOU is to establish a mutual understanding between the City and CWOL to facilitate access to veterinary care for animals under the temporary custody or responsibility of the Rio Dell Police Department.		

2. Scope of Services

CWOL agrees to provide the following services to RDPD, subject to availability and the clinic's capabilities:

- Emergency veterinary care during regular business hours: Monday-Thursday, 8:00 a.m. to 4:00 p.m.
 - o If a treatment is beyond CWOL's capabilities, CWOL will refer the City to an appropriate full-service veterinary clinic at no charge.
- **Humane euthanasia** during business hours when necessary due to injury, illness, or public safety concerns.
- Rabies vaccinations and other basic vaccinations as appropriate.
- Wellness examinations, provided appointments are scheduled in advance. CWOL will
 make all reasonable efforts to accommodate such appointments, as soon as practical, to
 avoid unnecessary disruption of the Rio Dell Police Department.

3. Animal Transport Responsibilities

The **City shall be solely responsible** for the transport of animals to and from CWOL's clinic located in Humboldt County. CWOL will not be responsible for pickup or delivery of animals unless otherwise agreed to in writing.

4. Point of Contact

All coordination, including scheduling and treatment discussions, will go through CWOL's designated point of contact:

5. Liability and Indemnification

Once an animal is delivered to CWOL by the City for treatment, CWOL shall assume temporary custody and responsibility for the care and handling of the animal to the extent required by the treatment authorized by RDPD.

CWOL agrees to perform services in a reasonable and professional manner. The City shall not be liable for any injuries to staff, volunteers, or other animals sustained during the treatment process, nor for outcomes resulting from treatment decisions made in good faith by CWOL.

CWOL agrees to indemnify, defend, and hold harmless the City of Rio Dell, its officers, employees, and agents from and against any and all claims, damages, or liabilities arising from the acts or omissions of CWOL in connection with the treatment or care of animals under this MOU, except where such liability arises from the sole negligence or willful misconduct of the City.

6. Compensation and Billing

CWOL will invoice the City at its standard service rates. The City agrees to remit payment in accordance with its established vendor payment procedures, generally within 30 days of receipt of invoice.

7. After-Hours Emergencies

This MOU does not obligate CWOL to provide services outside of its normal business hours. In the event of an after-hours emergency, the City may contact and use any available emergency veterinary provider.

8. Term and Termination
This MOU will remain in effect unless modified in writing or terminated by either party upon thirty (30) days' written notice.
9. Non-Binding Understanding
This MOU is intended as a good faith agreement between the parties and does not create any legally enforceable obligations or agency relationship.

IT IS RECOMMENDED THAT THE CITY COUNCIL:

BACKGROUND AND DISCUSSION

This legislation enables enforcement of local ordinances related to short-term rentals, including the collection and remittance of transient occupancy taxes (TOT) by providing cities with the physical address of each short-term rental listed on the facilitator's website and full audit authority of TOT dollars. This bill ensures that the correct amount of TOT is being collected and remitted and allows for more effective enforcement against unlicensed units.

Why this is Important to Cal Cities Members:

- Short-term rentals are regulated exclusively at the local level through ordinances that often include regulations on permitting, tax compliance, noise, parking, and occupancy, among other provisions. But the enforcement of short-term rental ordinances and the collection and remittance of TOT from short-term rentals can be hindered by the lack of full transparency on the part of short-term rental facilitators.
- Cities often lack access to property addresses or other property-related information when it comes to code enforcement or when TOT is collected by the short-term rental facilitator. This results in cities not knowing where businesses are operating in their communities and whether the correct amount of TOT is being collected and remitted.
- Short-term rental facilitators, such as Airbnb and VRBO, have full knowledge of these properties' locations and resist disclosing this information.

The current system creates and uneven playing field and incentivizes bad actors to bypass
paying their fair share in the communities they operate in — even though short-term
rental properties place additional demands on local services.

Dear Assembly Member Ash Kalra,

The City of Rio Dell **supports** SB 346, which would better equip cities to enforce local ordinances related short-term rentals, including the collection and remittance of transient occupancy taxes (TOT).

Short-term rentals are regulated exclusively at the local level via the adoption of an ordinance that often includes regulations on permitting, tax compliance, noise, parking, occupancy, as well as other responsibilities for hosts and short-term rental facilitators. In some instances, ordinances limit the number of short-term rentals allowed to operate lawfully, other ordinances ban short-term rentals entirely.

Short-term rentals can present numerous challenges to neighborhoods and adjacent property owners. They may create additional noise, traffic, parking, and public safety issues, decrease available housing stock, and in some cases turn residential neighborhoods into de-facto hotel rows, collectively creating additional demands on local public service providers.

Unfortunately, the enforcement of TOT ordinances and the collection and remittance of these taxes from short-term rentals can be inconsistent, even when voluntary collection agreements are in place with a short-term rental facilitator. Cities lack access to property addresses or other property-related information, even under these agreements, resulting in a difficult choice to either accept tax payments without any way to verify their accuracy and legality or attempt to collect taxes directly from property owners—a costly and time-consuming process. Meanwhile, short-term rental facilitators have full knowledge of these properties' locations and resist disclosing this information. Cities can only compel short-term rental facilitators to disclose this critical information through certain legal action, such as subpoenas. This is not how oversight of public dollars should work.

SB 346 would address the above issues by providing cities with the physical address of each short-term rental listed on the facilitator's website and full audit authority of TOT



dollars. These changes would ensure the correct amount of TOT is being collected and remitted and would allow for more efficient enforcement against unlicensed units.

For these reasons, the City of Rio Dell supports SB 346.

BACKGROUND AND DISCUSSION

On July 25, PG&E filed its Surrender Application and Decommissioning Plan for the Potter Valley Project with the Federal Energy Regulatory Commission (FERC). The application includes the removal of the Scott Dam.

The Potter Valley Project is located in the Upper Eel River in Lake and Mendocino counties. The main storage reservoir for the Project, Lake Pillsbury, is formed behind Scott Dam, which is located on the Eel River. Water captured and stored in Lake Pillsbury is released into the Eel River and then captured again in Van Arsdale Reservoir, an approximately 65-acre reservoir formed behind Cape Horn Dam. Water captured in Van Arsdale Reservoir is diverted and conveyed to the Potter Valley Powerhouse, which is located just north of a predominately agricultural area known as the Potter Valley.

In summary, the letter recognizes that there are benefits to the dam removal but also some possible negative side effects. Those potential considerations are (1) release of stored sediment behind the dam, (2) possible mercury contamination in those soils, (3) water rights equity considerations and (4) economic considerations.

RE: PG&E Surrender Application and Decommissioning Plan for Potter Valley Project

Dear,

The City of Rio Dell has been actively monitoring the developments related to the Scott Dam since 2018, when PG&E announced its intent to divest the century-old hydroelectric facility known as the Potter Valley Project. As documented in our City Council meetings of November 6, 2018, and September 17, 2019, this project directly affects our community's water security and long-term sustainability. The proposed removal of Scott Dam, while offering significant ecological benefits to the Eel River watershed, presents both opportunities and challenges for Rio Dell's water security, systems, sustainability and overall water quality management.

Background and Stakeholder Context

The Potter Valley Project, constructed beginning in 1905, represents a complex water management system that diverts Eel River water to the Russian River watershed through Scott Dam (creating Lake Pillsbury) and Cape Horn Dam. Historical diversions averaged 152,600 acre-feet annually until 1979, subsequently reduced to 64,400 acre-feet by 2007-2016. This massive out-of-basin transfer supports agricultural development in Potter Valley and provides water supply to Mendocino and Sonoma Counties.

Following PG&E's 2018 announcement, a Coalition formed to pursue a "Two-Basin Solution" with co-equal goals: improving fish passage and habitat on the Eel River while minimizing adverse impacts to water supply reliability in both river basins.

Rio Dell's position in this complex stakeholder landscape is unique. Unlike downstream counties that benefit from the water diversions, our community depends directly on Eel River flows for municipal water supply. The 2014 state water curtailment, which restricted our residents to 50 gallons per person per day until we could demonstrate adequate river flows, underscores our vulnerability to water supply disruptions.



Direct River Interface with the City

The Eel River flows for approximately four (4) miles through Rio Dell. The river provides tremendous recreation opportunities for residents of the City and region. Fishing, camping, swimming, boating and all other typical river related recreation occurs mostly in the summer months. The City has recently built a ½ mile non-motorized riparian trail with environmental education components. As one of the largest draws for outside visitors, the river is a major driver of economic activity for Rio Dell.

Additionally, the City's main source of water is an infiltration gallery located along the west bank of the river. Due to budget constraints at the time of construction, the gallery does not extend across the river. This design leaves the gallery vulnerable to changes in flow location during the summer months as there is potential for the flow to move towards the east and away from the gallery. This problem would be compounded by increases in sedimentation in the river, not to mention potential increases in localized flooding from additional sedimentation.

Possible Impacts on Rio Dell

Scott Dam currently regulates Eel River flows, providing some consistency in water availability particularly in the late summer and early fall season. Dam removal will restore natural flow patterns, characterized by higher winter/spring flows and potentially lower summer/fall flows. Our water infiltration system, which relies on consistent rivergroundwater interaction, may require operational adaptations during periods of reduced natural flow.

Sediment, Clay & Gravel

The removal process will release approximately 40 million cubic yards of accumulated sediment, presenting both immediate and long-term considerations:

Possible Impacts:

- Changes in flow channelization, diverting water away from the City's main water intake, the Infiltration Gallery.
- Significant increases in river turbidity during initial dam removal phases
- Fisheries impact from summer deep pools being filled from new wave of sedimentation.
- Potential clogging or blocking of infiltration galleries and wells due to fine sediment loads
- Temporary disruption to water treatment processes requiring enhanced filtration capacity



 Need for increased monitoring and potential municipal system shutdowns during peak sediment release periods

Possible Mercury Contamination

Our understanding is that recent studies analyzing sediments in Lake Pillsbury provide encouraging results. Laboratory analysis indicates that sediment contamination levels generally do not require manual removal prior to dark removal. However, several concerns remain:

- Temporary Exposure Risk: Initial sediment flushing may create localized spikes in suspended particles potentially carrying bound mercury
- Methylation Potential: Newly exposed organic-rich sediments under anaerobic conditions could enhance mercury methylation, converting inorganic mercury to more toxic methylmercury
- Bioaccumulation Monitoring: Enhanced surveillance of mercury levels in both water supplies and local food webs will be essential

Water Rights Equity

Rio Dell possesses only junior water rights to the main stem of the Eel River, which is the city's primary water source. This is a critical vulnerability for the community. In times of shortage, the most recent ("junior") right holder must be the first to discontinue such use

The implications of Rio Dell's junior status became clear during the 2014 drought:

- The State Water Resources Control Board issued a June 30 curtailment notice, saying Rio Dell no longer had legal rights to draw water out of the Eel River
- This imposed a 50 gallon per person per day limitation on residents, with stateimposed fines for failure to achieve conservation objectives
- Rio Dell residents reduced water use by 56 percent toward the end of July
- The curtailment was eventually rescinded, but only after the city demonstrated there were no registered senior water rights holders being affected by its use

The city remains vulnerable because:

- 1. Primary Source Dependency: The Eel River is Rio Dell's primary water source
- 2. Junior Priority Status: During shortages, Rio Dell must cease diversions before senior rights holders
- 3. Climate Variability: Future droughts could trigger similar curtailments
- 4. Potter Valley Project Impact: Changes to upstream water management could affect downstream flows



The removal of the Scott Dam adds complexity to Rio Dell's water rights position:

- The current "Potter Valley" project diverts water from the Eel River to the Russian River watershed
- While dam removal might improve natural flows, it could also create short-term disruptions
- Rio Dell's junior status means the community has limited leverage in negotiations about project modifications

Rio Dell's water security depends heavily on maintaining adequate Eel River flows, but our junior status leaves us vulnerable during any water shortage periods. This vulnerability may increase as a result of dam removal.

Economic Considerations

Rio Dell's economic situation reflects broader challenges facing small rural communities in Northern California's former timber regions. The community's dependence on the Eel River with junior rights status compounds its economic vulnerabilities, as demonstrated during the 2014 drought when residents faced severe water restrictions.

The combination of below-average incomes, higher-than-national poverty rates, aging infrastructure, and limited economic diversity positions Rio Dell as a community facing significant socioeconomic challenges compared to both state averages and urban California communities.

This economic profile helps explain why issues like the Scott Dam removal are so critical for Rio Dell - the community has limited financial resources to adapt to major infrastructure changes or invest in alternative water sources, making reliable access to Eel River water essential for both residential needs and any potential economic development.

Rio Dell's economic situation shows concerning disparities compared to state averages:

- 2023 Median Household Income: \$46,055
- Per Capita Income: \$24,427

State Comparison:

- California's median household income is \$96,334
- Rio Dell's income is approximately 48% of the state average
- Median household income below state average and median house value below state average



Potential Solutions and Mitigating Factors

Projects such as the decommissioning of the Scott Dam often create divides where both detractors and supporters can become absolute in their positions. While I believe Rio Dell is generally supportive of the decommissioning of the dam, there are potential negative consequences as listed above. We also believe there are some solutions to these problems that can be implemented to either solve or mitigate these issues.

<u>Sediment, Clay & Gravel:</u>

- 1. Fund the design and construction of an extension to the Rio Dell infiltration Gallery to cross the span between both west and east banks.
- 2. Fund the design and construction of a flocculation / sedimentation basin at the water treatment facility to reduce turbidity and improve the preprocessing of water into the main water filters.
- 3. Fund the design and construction of an enhanced water backup well system, currently located at Metropolitan.

Possible Mercury Contamination:

- 4. Conduct a comprehensive study of Mercury in lakebed soils.
- 5. Fund ongoing and continuing mercury monitoring along the Eel River, both during the deconstruction phase and for an appropriate period of years or decades following decommissioning. Include monitoring for other hazardous materials that may exist in the lakebed.

Water Rights Equity:

6. With expected changes to water draws that result from the decommissioning of Scott Dam, where possible a reasonable portion of existing senior water rights should be expropriated to the City of Rio Dell in anticipated of the increase of variability in seasonal water flows.

Economic Considerations:

7. By enacting the above factors, Rio Dell feels confident that negative impacts from the decommissioning of the dam will have been reasonably mitigated and in some circumstances, potentially solved.



Conclusion

The Potter Valley Project's transformation represents both significant opportunity and considerable risk for Rio Dell. While Scott Dam removal promises substantial long-term ecological and water quality benefits for the Eel River watershed, the transition period will require careful planning, enhanced monitoring, and potential infrastructure modifications to protect our community's water security.

Our city's experience during the 2014 drought demonstrates both our vulnerability to water supply disruptions and our community's capacity for conservation and adaptation. By working on these issues we can help ensure that the ecological restoration of the Eel River supports rather than compromises our long-term water sustainability.

The success of the Two-Basin Solution depends on meaningful inclusion of all watershed communities, including those like Rio Dell that rely directly on the river's natural flows. Our continued participation in this process is essential not only for protecting our immediate interests but for contributing to a genuinely sustainable regional water management framework.







Background and Discussion

On December 7, 2021 and December 8, 2021, an abatement warrant was executed at 520 First Avenue for excessive solid waste and junk vehicles. On July 7, 2023, the violations on the Property were determined to be excessive for an additional time. The City and multiple allied agencies made attempts to work with the occupants in clearing the violations however, were unsuccessful. Due to no compliance received in clearing the violations, an abatement warrant was executed on March 18, 2025 and March 19, 2025. The City's costs for the abatements were determined to be \$8,977.22. This cost assessment was sent via certified mail to the property owner and occupants on May 5, 2025. There has not been any attempts to pay or make a plan with the City for this debt.

Section O, Item 1.

Rio Dell Municipal Code (RDMC) Sections 8.10.310 through 8.10.330 cover the cost red process. RDMC Section 8.10.330 references the California Government Code Section 38773.5 which spells out the process for establishing taxes and assessments. This process requires two meetings, a public meeting followed by a public hearing.

On August 5, 2025, the Rio Dell City Council convened a hearing under Rio Dell Municipal Code Section 8.10.320 for the assessment of costs related to nuisance abatement activities at the subject premises recited above.

At said hearing the Council considered the evidence presented to it concerning the subject premises, including relevant documents, writings, codes, ordinances, as well as oral testimony at the hearing, and now, therefore, it makes the following:

FINDINGS:

- The property located at 520 First Avenue, Rio Dell, California is located in an Urban Residential zone within the City of Rio Dell, Humboldt County, California and is referred to as Assessor's Parcel Number 053-095-015; and
- 2. The Rio Dell Police Department received a complaint concerning the existence of violations on the property, to wit: Property use in violation of Rio Dell Municipal Code Section 8.10.020(a)(1), improper disposal of solid waste; and Section 8.10.020(c), junk vehicles; and
- 3. The property owner and/or occupants, were served with a Notice of Violation dated November 25, 2020, pursuant to Rio Dell Municipal Code Section 8.10.230, describing the violations and ordering abatement of those conditions; and
- 4. The property owner and occupants had significant and reasonable time to correct all violations and refused and/or failed to meet the deadlines prescribed by the Notice of Violation; and
- 5. The property owner and/or occupants were served with a Notice of Nuisance and Order to Abate dated March 25, 2021 pursuant to Rio Dell Municipal Code Section 8.10.260, giving the property owner and occupants additional, significant, and reasonable amount of time to correct the violations; and

- 6. The property owner did not contest the imposition of the Notice of Violation and Order to Abate; and
- 7. The property owner refused and/or failed to meet the deadlines imposed by the Notice of Violation and Order to Abate; and
- 8. On March 18, 2025 and March 19, 2025, the City of Rio Dell did, in fact, abate said nuisance; and
- 9. The City of Rio Dell maintained an accurate and itemized account of the cost of the abatement, pursuant to Rio Dell Municipal Code Section 8.10.310; and
- 10. The property owner was served with a Cost Recovery Assessment outlining the costs incurred by the City and requesting that payment be made within thirty days; and
- 11. The property owner has refused and/or failed to make payment to the City for the cost of the abatement within the time allotted; and
- 12. The property owner was served with a Notice of Assessment, pursuant to Rio Dell Municipal Code Section 8.10.320, specifying the work done; an itemized account of the cost and receipts of preforming the abatement; the amount of the assessment proposed to be levied against the property, the time and place where the Rio Dell Police Department would submit the account to the Rio Dell City Council for confirmation; and a statement that the City Council would hear and consider objections and protests to said account and proposed assessment; and
- 13. The costs of the abatement as set forth in the Notice of Assessment were necessarily incurred and are reasonable.

Following the said meeting and hearing, the City Council for the City of Rio Dell does hereby ordain and declare as follows:


ORDER:

- 1. That the account and proposed assessment of \$8,977.22 be, and is hereby, confirmed in full; and
- 2. That the Rio Dell Police Department shall cause to be prepared and recorded in the Office of the County Recorder, a Notice of Lien, which shall contain the identity of the property, a description of the proceedings under which the assessment was made (including this Order Confirming Assessment), the amount of the assessment, and a claim of lien on the described premises.

taxes; and shall be subject to the same penalties, interest, under the same procedure for foreclosure and the sale in the case of delinquency as is provided for in ordinary County taxes.

Notice is further given that at public hearing on June 17, 2025 the City Council will hear and consider any objections and protests to the assessment. You may appear with an attorney or other representative, call and cross-examine witnesses, and present evidence on your behalf. Should the assessment be levied, the property may be sold after three years by the tax collector for unpaid delinquent assessments in accord with Rio Dell Municipal Code Section 8.10.330 and California Government Code Section 38773.5.
