Is this going to cause flooding? Engineer designs are required.

Do we want to have the land regulated by the Town or allow it to be developed under the County? What can be done in town is more restrictive than in the county.

If the property is annexed into the Town, the next step would be for the owners to present a Plat to the Planning Commission. The Planning Commission will review ordinances and make recommendations for changes.






