## **Meeting Minutes**

# **Public Hearings:**

1. 6:15 PM: Request to Submit an FY22/23 CDBG Grant Application

Council President Alexopoulos opened the public hearing on this matter. The Town Council Clerk read the legal notices that were published in the Patriot Ledger on December 20, 2023 and December 27, 2023.

Planning Director, Michelle Tyler, gave a presentation on the CDBG Grant Application.

Council President Alexopoulos opened the public comments portion of the public hearing.

Joe Burke, Hills Street - Regarding the administrator that will get \$104k, what happens when the grant runs- who pays this person? Ms. Tyler: Those funds were appropriated in the last grant to pay for those services. If we do not have the grant, the program ends and we would close out the cases we have. That information is also listed in the contract.

There were no more public comments. Council President Alexopoulos closed the public comments portion of the public hearing.

Councillor Huff-Larmond: If we don't get this grant again, then the program will close because we don't have the funding. This is a program that's significant to our community and we should be dedicated to putting money towards this program if we don't receive this grant. There are a number of residents having financial hardship. If we could get a heads up, if possible, on what the situation is because I hope we can get the funding through other means.

Councillor Gordon: My understanding of how this grant worked last year is that we hired an outside consultant and that process was successful. Did we do that this year? Ms. Tyler: Our contract with the grant administrator included a provision that they provide the application for subsequent years. They are and, following this vote, they will follow the process for submitting the application to CDBG. While it is a highly competitive process, the fact that we were so successful the first time around, I would be shocked, though it's always possible that we would not be awarded a second grant. Councillor Gordon: The \$104k is for a grant administrator- is that one full time person? Ms. Tyler: There is the grant administrator which is Bailey and Boyd who handles child care subsidies, review of applications, reporting, hiring specialists which usually consists of three people and then there are others involved

such as lead specialists, and contractors, etc. At minimum there are five people working to ensure that the funds are appropriately allocated.

Councillor Brewer: Is it a team of people that reviews and approves the applications? Ms. Tyler: Yes, that is correct. They are not from town; all the documents are private and no one in town has access to those documents.

Motion made by Councillor Brewer to vote to submit the FY22/23 CDBG Grant Application for housing rehabilitation and childcare subsidies and to authorize the Town Manager to sign the grant application and associated forms, seconded by Councillor Gordon.

Roll Call Vote: 8-0-0 (Absent: Egan)

Motion Passes.

#### **Public Comments:**

- 1. Joe Burke, Hills Street On the corner of Pond Street and North Main Street, there is a store that seems to be a problem with parking and when you try to get by at night you can't get by because of all the cars parked in the area. The Fire Dept. were called and they even had a problem getting in. Council President: We'll have the safety officer look at it and advise us on next steps.
- 2. Sandy Cohen, Bittersweet Lane I'm wondering what you're seeing in terms of the Covid increase. Town Manager Howard: We're seeing increases like everyone else in the state. Hospitalizations are not the same issue as they were in the past. Reminder to all residents: We have vaccines, boosters, covid testing, and test kits at the Covid Site. You can pick up test kits at the Covid Site, RICC, and here at Town Hall. Ms. Cohen: What are they building on the Corner of North Street and Liberty Street, right across from the Sunoco? Council President: It's a convenience store.

## **Town Manager's Report:**

1. I just wanted to thank everyone who put together the Holiday Celebrations in Town- Liz Larosee and Robyn Rinehart over at the Randolph Intergenerational Community Center, and the Turner Free Library. The Community Band joined us, Police, Fire. Santa, who is friends with Councillor O'Connell. The events were a great turnout and it continues to build community.

#### **New Business:**

1. Council Order 2023-001: Prior Fiscal Year Unpaid Bills

Council President Alexopoulos read Council Order 2023-001. Town Manager Howard gave a brief explanation on the Prior Fiscal Year Unpaid Bills.

Councillor Burgess: A few meetings back we talked about setting up a meeting regarding unpaid bills and encumbrances, and how that impacts our free cash number. Are there any unpaid bills for the fiscal year prior to the one in this council order that we haven't dealt with yet? Town Manager Howard: The only unpaid bill I can think of that would be for a prior fiscal year prior to last year would be for Zoom reimbursement. The Finance Director, Ms. Smith, also wanted to send a friendly reminder that "free cash" is not certified yet. So we can't use it as a funding source at this time. With that being said, as soon as it is certified, then we can talk about sitting with the Council to talk specifically about her analysis, which indicates that we'll certify less free cash than we had hoped to, based on some school related deficits. Councillor Burgess: It's important to maybe invite the School Committee Members here for that discussion.

Council President: Other questions for the Town Manager?

Councillor Burgess: Is there any update related to the traffic study? We had discussed getting an update on the status of prior Council Orders relating to the phased traffic study and the Council's votes on those proposals. We need to complete phase 4 of the traffic study. Town Manager Howard: I will speak to BETA on phase four and we'll get back to you.

Council President: Is there a motion on this Council Order?

Motion to approve the Council Order 2023-001 as presented made by Council Vice President Brewer, seconded by Councillor C. Alexopoulos.

Roll Call Vote: 8-0-0 (Absent: Egan)

Motion Passes.

2. Council Order 2023-002: ARPA Budget Transfer

Council President Alexopoulos read Council Order 2023-002. Town Manager Howard gave a brief explanation on the ARPA Budget Transfer.

Councillor Burgess: Are we expecting to throw more into the budget for Utilities? Town Manager Howard: It's tough to predict. We think we're in good shape, but there is no guarantee based on the current market.

Motion to approve Council Order 2023-002 as presented made by Councillor C. Alexopoulos, seconded by Councillor Brewer.

## **Open Council Comments:**

- 1. Councillor Burgess: Thank you to the Congregational Church, they have a new sign up front and the placement is great. They worked with the community and fixed the lights so they're not as bright. Regarding the Zoning Ordinance for the Union Crossing Transit District: In the packet it says they met with Town Officials prior to them submitting the application materials and in the packet, it references that this is a modified set of plans. Is there another set of plans that was presented to the Town Manager, or to other members of the Council or Public Officials? Council Vice President Brewer: there may have been modifications based on the recommendations of the PRA when they initially met. We have not received those modified plans yet.
- 2. Councillor O'Connell: The Police Department is selling T-Shirts and the money raised is for charity events. Just wanted to let everyone know that they can stop by the Police Department to pick up shirts if they're interested.
- 3. Councillor Gordon: 1. On New Year's Day I participated in a lovely group hike at Blue Hills organized by the State Dept. of Conservation and Natural Resources. 2. At this time last year, I brought up that we should purchase more Holiday lights. I think we've come to an agreement with the Town Manager regarding more Holiday lights. 3. The residents of Rosemont held a meeting right before the holidays. They are requesting a traffic light on High and Chestnut West because it is extremely difficult to make a left. 4. We were happy to see the ballots in Vietnamese and I was curious to see why we didn't see them in Haitian-Creole, which a majority of our residents speak. I was advised that a Home Rule Legislation is necessary and it's our goal to make this possible. We will discuss this with the DEI to see how we can make this possible.
- 4. Councillor Huff-Larmond: 1. Regarding the MLK event, please register if you plan on attending. 2. Thank you all for participating in the baby drive. We're collecting books for kids in the NICU so if you have any books to donate there is a box at the RICC. We will be going to the NICU at South Shore Hospital and Brockton Hospital. 3.
