Bradshaw: I'll bring it up b/c I am the one that (inaudible) about it last year. We can go this route I don't have a problem with this, I think my request last year was to just get the board involved as much as possible b/c I'll even say I didn't know about Freedom Fest until we got to the last month's meeting and the paper was laying on the table. So, I am not against us having kid's activities I have been told that it's been said the reason we did not have kid activities is because of me. I will say I am all for kid activities as long as we do it safely and correctly and again, we can go this route I don't have a problem with this, or we can just make sure we have some members...we would rather be involved.

Clint: We want the involvement, I hope you will, you got to think Freedom fest, Harvest Fest these are the kind of things that went, I am glad it catches fire, I have had nothing but positive feedback for July 4th, but it is a great stress on the staff. Alot of things, 4th of July particularly we use money we save throughout the year, we really don't know until we close the books how long our fireworks will be. I am all for it, that's just a sample ordinance, our ordinances are pretty clear with it, the committee of whoever that is proposed by laws will propose a budget and those come to the board for approval individually. I mean the committee needs to be very flexible with the time. I'll definitely entertain it, that and if the committee does it, I can't have commissioners running all the employees that's not the way the manager council format works.

Bradshaw: I don't think anyone wants to run employees, but you know we all live here, and we all would like to have a part of planning and helping. We are all married we would all be welcome to help. If we are going to help, we would also like to be involved in the planning. That's not running people. And you and I talked last year after I had the situation with my granddaughter, just the more people we have helping sometimes...let's play devil's advocate let's think about this..let's mark these things off the list b/c honestly everybody has different weaknesses ..I mean strengths excuse me. Everybody has weaknesses too, but everyone has their different strengths they bring to the table. It's not a matter of us running anybody.

Clint: I'm just saying I think you are going down like legimately manager-council government b/c that's been brought up when we were doing our research that a board member says I'm going to be a committee chair and give me all your labor and we can't do that, but I'm saying if you have your committee then you plan that's fine. I have no problem with that. I am a master trained planner, we do it we go thru the checklist, the checking the blocks all the way from First Aid station we do it with the resources we have but if it's just more involvement and it's just that then we can just start a little sooner. And again, I don't know if it's broke til we don't fix it, I mean we had a couple 100 last year and it was great and I'm pretty sure when you add in Branson Circle, we had over 1000 this year. I think it's great, but I mean the bigger it gets the more help we

need. But with the town employees we had two planning sessions and final conditions checked that Monday and the white board is right there in Town Hall its posted. I got Power points for all the employees that were involved, I don't want to mitigate ya'lls time to make you feel like you have to work an event b/c you're the commissioners you should be out there shaking hands and kissing babies and I was very happy with the one commissioner identified a very easy safety thing and boom we took care of it. I like it but if it's just more being involved in the planning we can start sooner and be involved and get more feedback back and forth especially with Freedom Fest, the biggest thing is just the cost and timing. But I have no problem I just I don't have an opposition, I'm cool with it if you don't have to have a committee you just want to have a little more feedback and interaction.

Bradshaw: Well, that's all I've asked for is that we be a part of it b/c like I said we all live here. We don't mind helping, I'll be honest I don't mind watching a station or a ride or whatever it is we have. We were all in the dunking booth last year and nobody complained about that, but if we don't know we can't help.

Clint: Town Hall is right there, I have a phone you can just call.

Bradshaw: If I don't know what's going on I don't know to offer my help. So that's what I'm saying if we could just be included in the planning then that's all that matters.

Phillips: I don't think we need a formal committee, I get the idea, I get the proposal to find 5 people to appoint but one all the time for a planning board to set up um and two if you get 5 people to appoint then you get 5 different personalities to spend this and this and this, I think the way we are doing it now is pretty good just a little more notification.

Clint: Again, I want the feedback, we don't have all the answers we're just trying to do events b/c every time we do an event they ask where are more events and then ya'll come to me and say where are more events? Alot of it is cost driven.

Dockery: I was asked why can't you do that every month in the summer? Well, it costs a lot of money, I get that..um so we are talking about right now the Farmers Day that's a whole different beast we are not involved in that? The Town is really not involved in that?

Clint: So, to speak, but we have inserted ourselves more for the safety planning again.

Dockery: Planning what? What are we planning?

Clint: Planning and operations is like my thing, and I get really weary if we don't have see a plan. The Fire Assoc has been very gracious to include us so we know like I'll have a product for yall in the next week that will show what the road closures are; the safety procedures are, what the size is, that part I think yall were definitely left in the dark, if it's a town event we have an overarching responsibility. We have not impeded on the association only wanting to show support for it b/c we are attached to it. Little things like traffic barriers, we need them for the town so we bought them and use them for event. We bought the water barriers for safety for the events.

Dockery: So basically, its Farmers Day, Freedom Fest, and October Fest that's the three events?

Clint: And Christmas Parade and you'll see on your packet the Greenspace is rented for an event for the next 3 Saturdays.

Kevin: I'm ok as long as they stay active.

Clint: it's rented every week, stellar scoops doing a movie night and no cost to us and it's the cultural center of the town.

Dockery: Commissioners what action do you want to take on this if any this evening? Are we saying we just want to be a little more involved on the planning earlier on? Or you wanna form a committee? I'm asking you guys.

Bradshaw: I think we just need to be more involved earlier on b/c we struggle to get committee members for other things too so

Phillips: Same and I worry the committee will get limited funds.

Kevin: I don't have a problem with the committee, as long as they stay active, I know three years ago we established the beautification committee they might have met once, they just won't stay active.

Dockery: So I guess for now what we are saying is as a board we will forego a committee process and be a little more involved on the front end of events, is that what we're saying?

All nod- Ok

Logistical Update: Add to agenda (C)

Mack brought up to the board if we could pass resolution added by Wooten Engineers regarding DWI piggyback NCWRA grant for our Capital Project Ordinance. Resolution for a different department therefore needing Board Approval this evening.

A. June 2023 Managers Report

Updates Very busy month

Closing out Low Water Crossing received a check for \$179,000 from FEMA this week Happy to get a Final Closeout and take it off the agenda.

Working on the FY24 books

Viola is working on the Tracy Brown Tank, there aren't just people playing on the tank. Met with Sandhills Boys and Girls Club it was a very good meeting, very positive. The main outtake was they wanted to include us in their strategic plan to be briefed on the 23rd of August. It was relayed to them that we are entertaining it. We have a public building that may suit their needs. Next step would require a public bid for just the asbestos removal. Their timeline is Summer 2024.Those contracts take time. Structure would be similar to Hope Academy, long term lease

Bradshaw: so are they looking at starting their work on the building Summer 24?

Mack: They want to occupy by then.

Bradshaw: What was the 8/23 date?

Mack: It's their big board meeting.

Dockery: So if I remember correctly, it was a submission, we said at the last meeting it was around \$200,000 for abatement roughly with repurpose that building and have the boys/girls club in there to me that's a win-win. I mean weren't we gonna pay nearly that to have it demolished?

Mack: Essentially it was \$225K for asbestos and then \$70-\$80K to demolish.

Dockery: With the programs, It would be great thing for the town.

Mack: Very positive feature and with the resources they bring are unmatched.

Dockery: Next step is to meet with them and see if they want to take it to the next level basically.

Mack: Correct, timeline stands and they can move forward if we do XYZ.

Mack: Sidewalk Proposal-hold off and present a full proposal. This company gave us a great quote to repair the 127 falling hazards in the main downtown district. Just the tripping hazard will be beneficial. To add to the Fire Dept last minute at end of budget transmission went out \$6800 and we had that in capital outlay, Timmy picked it up this morning and they are doing the labor his self.

Bradshaw: The audit that's coming next month is that the new audit company?

Mack: Yes

Bradshaw: They will come here and do it like we used to have it?

Mack: Yes-Horner paving got a dozen potholes patched and they are gonna come back in August; Daniel Gray passed his certification for water distribution B which is great so he got a raise and that was what Davis Reynolds would do for us. Update pictures in your packet 3 major busts.

Couple staff meetings to have everyone on the same page and remind people of the manager council form of government, I am true believer in this form of government b/c it works. Ya'll represent the people in their needs and wants and we go find it, it's so successful. We got a lot of great things coming up on the docket. You know next month is going to be a great month, I just want us to keep going in a positive direction and if there are any problem with performances just let me know it's not a big deal. Day to Day operations I got that. Not everyone is perfect, but I love our staff I think they are great. Anything that's going on is always settled and I'm very confident the team we have now is the team that's going to bring us into the future. Very positive in the way we are going. I'm not going anywhere I'm too boneheaded to get run off so if its broke let me know. If it's a problem with an employee let me know, I probably already know about it. Very optimistic about future. I always say we, us, team. Very productive month and really appreciate the support and that's all I have for my report.

Kevin: Can you give us an update on some of the larger code enforcement projects?

Mack: Yeah we are up to about 27 right now. I can send you the spreadsheet. We have had some good feedback and we have only had to collect one fine so far. Other than the sewer issue. They fix them and we inspect them and go street to street. I think people realize and we are addressing the property owners.

Dockery: The one in my neighborhood is a whole lot better.

Mack: Its unfortunate that all that had to happen. Its a process. We are motivated. Its right there in our ordinances.

Dockery: The texaco station

Mack: They have gotten warnings-communication breakdown and excuses Showing progress

Stewart: Salisbury Street

Mack: Move the cars and doing legal research and we have been working on this due to zoning. Everyone is hours and hours of research to issue warnings. Got to do it right.

Bradshaw: Can you give us an update on H?

Mack: I know they put out a work session to announce and talk about the Opioid Crisis

Water and Sewer the last thing I went to was County UDO meeting I went to they steered into a Water Sewer conversation that County was gonna get another million gallons from Harnett County per day, so they don't suspect any big water deals with anybody this year.

Dockery: that's disappointing

Stewart: they are shooting themselves in the foot by saying this.

Mack: I maintain the same thing I've said for a couple months, we are in the green our water system is profitable. Rates are sustained again 2 years in row. We just carry on like it is. It's really helping our bottom line to help our capital reserve. It's making money to provide better services which fine by me.

Dockery: I just say in a public meeting. I would be open to doing another deal with Montgomery county. Rather than Moore. I don't mean to buy more water I mean for our infrastructure here. We seem to be being snubbed at by the other end of the county. Maybe Montgomery County won't be so snobby. Forgive me for saying that.

Mack: Well as far as infrastructure-Regionalization is County lines are arbitrary, there again we aren't going to get the money for water treatment plant because we have that source. I have talked with Mike their public works director and told him we are going to meet soon and talk about that. The biggest thing for me is like contact maintenance, when we blow a line in the middle of the night, they have 24-hour maintenance crew. How hard would it be to add us to assist us.

Dockery: We were really wanting to do a deal with Moore County but would there be anything legally prohibitive of us being able to deal with another county as a municipality? To go outside of our county, b/c our county is going outside of our county. As a municipality, Robbins, is there anything illegal about us going into negotiations outside of our county?

Mack: You talking about to own our water system?

Dockery: yes

Al Bensoff(town attorney): If DEQ was ok with it, its theoretically possible Mayor. But DEQ monitors and licenses the water system and in theory its possible and DEQ likes water systems, sewer systems to be combined. They like regionalization.

Dockery: I wonder if it would be advantageous to have a conversation cause someone might get an idea they are serious about doing something with someone. I'm just very disappointed how this thing has fludged out so far personally.

Mack: We have had meetings with Frankie, he likes us even now with our reduced usage. We are still a viable customer. Under the context that we have economic growth would we have that possibility.

Dockery: The chairman of the board of commissioners from county said in our company out by our reservoir, this would be a great backup for our drought. It seems to be the county is not interested in that now, maybe Montgomery County would be interested in using that resource. I think it would be advantageous to have a public meeting and discussion, so some folks know we are serious about it. That's just my opinion. I'm not speaking for the board at all that's just my opinion.

Bradshaw: The last time I asked we had not got our insurance rates in. Did we have a big increase, or I know we didn't have a decrease, I'm sure.

Mack: That was one that was 7.8% that was an estimate they gave us ahead of time, so we budgeted for it.

Bradshaw: Thats just medical?

Mack: Thats medical, and dental didn't change. The town liability insurance was significant. No one had any real complaints. Good moral, our new provider very accessible.

Bradshaw: BCBS he is just the middle guy.

Stewart: I have one thing remember the library contacted me. The Karl Robbins Foundation they have supported teh library for years. Their budget from the town we have not increased it in 3 years, they have a lady that cleans the library weekly and currently she gets \$200 a month, they would like to have an increase to \$2600 to cover 52 weeks bring that before the board to find \$2600 to cover that, they are facing decrease funds from the other sources.

Mack: I do owe them a meeting and I talked to her a couple weeks ago.

Dockery: do we need to discuss about teh library

Mack: I asked the committee for their assistance and they found somebody.

Stewart: I think the \$2600 was out of foundation.

Mack: I'm not sure I think it was in a line item, this is just a cleaning lady. We have had no trouble. I can bring it up for vote next month.

Dockery: Any other questions. With no questions this will be our opportunity for commissioners comments.

#### XI. COMMISSIONER'S COMMENTS

Phillips: Thank everyone from the Town for all the good work they did for Freedom Fest, glad to see we had a good turnout, I've got nothing but positive feedback, it's good to see when people come to Robbins the town be alive and not look like a ghost town. Without Freedom Fest I noticed, a few years ago you drive down Middleton St not a car or business nothing going on and now it's something all the time its busy. It's what I like to see.

Stewart: I would like to say the same thing, thanks to the town and staff for putting on the Freedom Fest, it was very good and heard feedback from it and it was positive, appreciate the hard work.

Dockery: I would just say that I bet I had 50-75 comments in town and the only negative comment was this, people wanna buy the shirts we were wearing. They say how do we get the shirts?

Mack: It really came down to cost, we can recoup.

Dockery: I think they will buy a lot of these shirts.

Bradshaw: nothing

Stewart: Do you have a comment on this?

Mack: if you remember a citizen, Charlie Smoak asked if we could do that, and Jessica did all the leg work, and it was approved by the State and we ordered a sign. We sent those invitations to all the VIPs (state reps, county commissioners) and Chief Brown has been accommodating and that week is purple heart day near Farmers Day. So, after the parade when they usually do the opening ceremonies. It will fit in with the patriotic opening of Farmers Day. We have purple heart recipients to sit front and center. Very simple but symbolic. I will give the history of the purple heart. Kick off great american event. The CZO requires conference for zoning certification.

Bradshaw: What is CZO?

Mack: Certified Zoning Official

Bradshaw: I've asked him to not use so many acronyms.

Mack: On stop shop for minor subdivisions, I can check the plat's and do a one stop shop plat review as long as I keep the certification. Surveyors can come in and leave the plat, review it within 24 hours and pay \$75, it pays for itself.

Dockery: Is there no reason for closed session this evening?

#### IX. COMMISSIONER'S COMMENTS

Asked to move Commissioner Comments up to accommodate work schedule.

Stewart: I wanted to jump the gun and get on this early, Farmers Day was an absolute success, I'll thank Clint and his staff for the work they did, awesome job. Roger and his rangers they cleaned up the town and kept things going, they did an awesome job; Police Chief and the Sheriff's Dept, thank you very much, kept everything orderly and safe, really appreciate that. I always saw somebody's presence all night long, your guys were out there taking care of things, I really do appreciate it. The fire dept, Fire Chief, Timmy, it's a year-round deal for those guys. I mean even at Farmers Day they are already talking about what to do next year. It never quits, it's all year long and I really appreciate all the fire members and their families. Their families come out and they participate and help out too. I really really do appreciate them a lot. Purple Heart Ceremony was awesome thank you once again Clint and staff for setting that up. Thank you, Charlie, for helping me get that going. I knew I could count on you to get that rolling and do a good job for us. I noticed something this weekend, young firefighters, Timmy's done an exceptional job of recruiting keeping young people, junior firefighters, young college kids wanting to get into fire and rescue. That keeps the fire department healthy. I do a lot of traveling and a lot of rural fire departments have signs Help needed, volunteers wanted, we don't have that problem, we are a very well-staffed bunch of young people here eager to learn, have good talent and I am very pleased to see that and very happy with the recruiting Timmy has done. Thank you.

English: First thing I want to thank Ben for bringing my pocketbook back, I lost it at Farmers Day. That ain't nothing I lost it the next morning. But also, I want to thank Clint, I want to tell ya, like they said a while ago, I was here before you came, and I want you to know you are hard to replace and I hope a lot of people in this town understand that. But I know money talks and BS walks. That ceremony I know some military guys too and they said it really blessed them. To me, that's what counts. A lot of people don't realize that the only reason we can sit here tonight is because people like him and him, I don't want to say me b/c I didn't do anything, but I really do think you're doing a great job. I will you this, now I got a complaint. I had a lady about 90 years old call me last night and I've known her all my life, but she was complaining that someone across the street from her house was burning trash and stuff and it was burning her eyes. And I'm pretty sure that chief knows about it. I don't know what happened. But I asked her to come up and speak to the board and then let everybody hear it, so I'm not telling it to be telling it. But I know the chief knows about it and Clint may know about it. We need to try to do something. That lady is 90 years old. If they are burning chemicals someone needs to stop them and I can I'll call the EPA. It doesn't matter to me.

Clint: Is this what happened, was it yesterday? I think we took care of it; it got called as a fire.

English: I know the person they rent this place from. I know who owns it, I could go to them. But I don't want to do that. And she wasn't upset with ya'll. They want action now not tomorrow. I told her she had to understand that. I said it be better if you come stand at the podium, other than that. The sewer line, I was with Ted at the car show I asked him to come say something about it here. I feel like they need to be involved by coming. Ted has grown up here, so he knows where I'm coming from, and his mama has lived here all her life. I'm glad they fixed that b/c sewer it would be running in the streets. Other than that Clint, you got me 100% for anything you want me to help you do.

Bradshaw: I want to say how appreciative we are to everyone that worked Farmers Day, I didn't get out very much, the few times I did get out everything was smooth and the only thing we could've changed would've been a little better weather. I will say Sunday morning I came thru town, and it looked like we had had nothing and that's the way it has been it seems like every farmer's day that I can remember. They do such a great job, and I didn't hear any complaints so thank you everyone that was involved, and I guess I'm hoping we are looking forward to the next year. Timmy's not here for us to grill so I'm just going to say I hope that we're looking forward to next year.

Clint: He's at the County Fireman Meeting.

English: I got one more thing The railroad crossing have you gotten any calls?

Clint: Nope, we were able to keep it. We had no complaints.

Dockery: The one by Growler he's talking about

English: I'm talking about the railroad crossing over by Growlers (inaudible others talking) its going through hell and half of Georgia. I called a man who's in charge of fixing railroad crossings, especially on state roads, Green St is a state road. So I called him, I called railroad first, and he gave me the guy's name again, his name is Tim Woods and I do have his number is you need it. But I called and he's trying to get money allocated to fix that crossing, he said he should get a new budget first of September, but I am going to unless you tell me otherwise; call him back. I got that way to go to church and even tho I jump railroad tracks I still think that track needs to be fixed.

Britt: Farmer's Day was great, lots of compliments not too many complaints. Everyone was talking about the new banners we have in town and they like those, The only complaint I got on those was "You all do know there are two entrances into Robbins". I said," Yeah we are working on that." Other than that I appreciate everyone's hard work.

Phillips: All town staff did great in every department Farmers Day ran excellently and smoothly which is hard for a small town like this to really put together something like that with the crowd that we had. I was uptown and had my little commissioner's name tag on. I had at least two different people stop me and compliment the work of the town. One of the couples was from out of town, they enjoyed Farmer's Day so much that they possibly could find a house here and move here.

Dockery: My only comment here is that it was an awesome experience I got no complaints and a lot of compliments and one suggestion. The one suggestion made by a few people was why can't we move this to October it's just too hot. I hear that every year so I'm just sharing that with you.

Kevin: Say that again

Dockery: Why can't we move this to October its too hot in August.

Stewart: I remember years ago when the original wagon master was asked that question, he had been out in tobacco fields in September and seen hotter days than he saw in August, he said it's tradition and that's what he's gonna stick with. That comes from the original wagon master.

Clint: I was told that would be the one thing that would get me fired.

I don't anticipate any big changes in what you're proposing is fine, I'll be sure the board and town staff have that in plenty of time.

#### A. Approve ARPA Spending Plan Budget Amendments 1, 2, 3

The budget amendments, there are 3 actual that coincide with the ledger entries that are required. We have approximately \$99,000 left in ARPA we have until Spring to spend it. We have basically spent a little each year, we did premium pay, \$200,00 for capital purchases, the major one was the Dump Truck last year. This year we have some capital expenses that we didn't put in the budget because we knew we had this and other FEMA money coming. Some of it is a couple thousand dollars. I met with the library committee, and they are in need of bathroom repairs, a baby changing table, some brickwork, a supplemental salary to pay not every month but every two weeks for the cleaning lady and their software kiosk subscription is running out for the year. And that's a foundation money thing, I have really not had to focus on the library, the committee there has taken charge and they let us know what they need. The public works line, like the chlorinator, has about a 10-year life cycle, it went out just a few

weeks ago. We were supplementing it by hand but it's basically a chlorinator that feeds the chlorine into the plant. It's time-consuming if you do it by hand. The roof we have a leak in the corner, the roof of the lab which has to be temperature controlled because of the samples, we burned out one window unit trying to maintain it with just a tarp. I was waiting for this to see if we could get this approved. Our 2007 truck, the alternator went out and the starter was stuttering the (inaudible) dropped off while Logan was driving it last week, so we are down to 2 public works trucks. The plan we had last year for the municipal maintenance program is null and void anymore. There is such a high demand for vehicles right now for high prices there not making money on leasing. So we worked with and got a municipal contract for \$37,000 not including tax, tag, and registration that we will do here and toolbox but that will bring us up to three workable plus the dump truck; and public work vehicles. Our guys need it, we couldn't find a truck like an F-150 for under \$57K if we use the maintenance trucks for the maintenance and use the Ford Ranger for meter checking, like work hauls, Roger said he could make that work for the time being. (Refer to manager report/public works employment)

#### B. Interbasin and Subbasin Transfers

I have a minor in environmental engineering now. Basically, this came about because the County approved it, and they wrote a resolution there are very strict restrictions on. This is how DEQ gives up your river basin, basically, the major surface river buys the water in North Carolina. For environmental considerations what they do is they break it up to where there are limits on how much water you can pull from one surface source and dispose of it in another surface source. This is a problem for us right now b/c we get ours from Montgomery County/Yadkin Pee Dee and dump it into Cape Fear Basin essentially Deep River. But we only use 100,000 gallons of wastewater a day. The current limit is 2 and 1/2 million. I didn't see the big importance of this to us however; had another meeting with LKC with Wayne and Adam and just went through a lot of the technical stuff. Basically, I was right it doesn't really affect us, however, if you look there are only two wastewater treatment plants in Moore County. Ours up here that dumps into Deep River and Ador in Aberdeen which dumps in Lumber River. Moore County is in one of the unfortunate spots that has within its county we are right there we have three different river basins. It really complicates things. My question was how does this affect us? Basically, it affects the 100,000 gallons/day that we use b/c basically we sell to High Falls, our average usage is 120,000,000/day that's not a very high demand. If they were to use our reservoir, if we're to come to an agreement with the reservoir and Deep River they would essentially need it for the rest of the County. Well if it goes past the traffic circle it's going to have to be dumped somewhere which is gonna have to be the Lumber River. That most likely would exceed the 2 1/2 million gallons. The only way around this is with the inter-basin transfer certificate and it takes years maybe even decades if it even gets approved. It's very political and very specific and the engineers don't think that it even would get approved; so, they have gone the other route of saying let's just try to get a law changed. Everything in that actual law that went up to do a bunch of other stuff passed both the House and Senate but the

actual Inter basin clause was taken out last minute in Senate. In the Moore County BOC meeting last month, to further define that meeting, we basically said, "what is the deal, b/c my main concern is Robbins well, if we are gonna take water and use it all around here what's the big deal you just have to pump it back to me and we can work both water and sewer." There's not enough demand for them to do that. Again, if they're going to build, we're looking at a 1 million gallon plant it might be a \$15 million; a County plant is going to be a 5 million gallon/day plant or a 3 million gal/day plant that's about \$27 million. They are not gonna spend \$27 million for that if it's only for a couple of 100,000 gallons. My advice to you is to think about this as a county-wide thing, we are basically supporting them to say this water we eventually need the option of a County-wide water source. (Reference to slide show) That's the gist of it.

## AN ORDINANCE APPROVING TEXT AMENDMENTS TO THE TOWN OF ROBBINS UNIFIED DEVELOPMENT ORDINANCE

**THAT WHEREAS**, the Town of Robbins has enacted a set of development regulations that control land development and construction within the Town's incorporated and extraterritorial jurisdiction areas; and

WHEREAS, in order to promote the public health, safety and general welfare and to promote the best interests of the Town and community, it is necessary from time to time for the Planning Board and Town of Commissioners to consider appropriate revisions, modifications and updates to the Town's Regulations; and

**WHEREAS**, the Town staff identified a need to amend *Section 152.103 C2 Permissible* uses and specific exclusions; Section 152.100 Accessory Structures; Section 152.101; and

WHEREAS, the Planning Board has recommended adoption of the Unified Development Ordinance text amendment described herein. The Planning Board made its recommendation because the amendments further purpose of the Town's 2014 Land Use Plan (Land Use Plan 2014-2030), which states that, "The area has the potential to attract first time homeowners and small businesses, horse farms and passive recreational enthusiasts. Town of Robbins planned housing and downtown restoration initiatives can provide a short-term stimulus for local construction and remodeling jobs."; and

**WHEREAS**, pursuant to N.C. General Statutes and Town ordinances, a public hearing, properly noticed, was held on September 14, 2023, where public comment was heard and considered by the Robbins Board of Commissioners on the proposed amendments; and

**WHEREAS**, the Commissioners for the Town of Robbins hereby find that proposed Unified Development Ordinance text amendments are (i) consistent with the Town's 2014 Land Use Plan, and (ii) are reasonable and in the public's interest because it will advance the public health, safety, and/or welfare of the Town of Robbins through updated statutory procedures and requirements for development within the Town's planning jurisdiction.

**NOW, THEREFORE, BE IT ORDAINED** by the Commissioners of the Town of Robbins that:

Section 1. Unified Development Ordinance § 152.004 is amended as follows:

#### § 152.004 AUTHORITY.

(A) This chapter is adopted pursuant to the authority vested in the town by its Charter and by G.S. Ch. 160A, Art. 19, Part 3.

(A) This ordinance is adopted pursuant to authority granted by Part 6, Article 21 of Chapter 143; Chapter 160A; and Chapter 160D of the North Carolina General Statutes, and other applicable laws.

(B) Whenever any provision of this chapter refers to or cites a section of the state statutes and that section is later amended or superseded, this chapter shall be deemed amended to refer to the amended section or the section that most nearly corresponds to the superseded section.

**Section 2.** Unified Development Ordinance § 152.100, "Definitions," is amended as it pertains to the definition of "accessory structure" as follows:

ACCESSORY STRUCTURE. A subordinate structure detached from but located on the same lot as the principal structure, the use of which is incidental and accessory to that of the principal structure.

ACCESSORY STRUCTURE. A subordinate structure detached from but located on the same lot as the principal structure, the use of which is incidental and accessory to that of the principal structure. that comprises not more than 25 percent of the gross floor area of the building or unit that comprises not more than 25 percent of the gross floor area of the building nor more than a total of 750 square feet.

Section 3. Unified Development Ordinance § 152.103 is amended as follows:

#### § 152.103 PERMISSIBLE USES AND SPECIFIC EXCLUSIONS.

(A) The presumption established by this chapter is that all legitimate uses of land are permissible within at least one zoning district in the town's planning jurisdiction. Therefore, because the list of permissible uses set forth in the Table of Permissible Uses, which is available for inspection in the office of the Town Clerk, cannot be all inclusive, those uses that are listed shall be interpreted liberally to include other uses that have similar impacts to the listed uses.

(B) Notwithstanding division (A) above, all uses that are not listed in the Table of Permissible Uses, which is available for inspection in the office of the Town Clerk, even given the liberal interpretation mandated by division (A) above, are prohibited. Nor shall the Table of Permissible Uses be interpreted to allow a use in one zoning district when the use in question is more closely related to another specified use that is permissible in other zoning districts.

(C) Without limiting the generality of the foregoing provisions, the following uses are specifically prohibited in all districts:

(1) Any use that involves the manufacture, handling, sale, distribution or storage of any highly combustible or explosive materials in violation of the town's Fire Prevention Code;

### (2) Stockyards, slaughterhouses, rendering plants;

#### (2) Stockyards;

(3) Slaughterhouse and rendering operations are limited to the slaughtering, harvesting or butchering of cattle and processing of animal products fit for human consumption as outlined by the United States Department of Agriculture ("USDA"). Further processing of animal renderings is prohibited within the Town limits.

(3) (4) Use of a travel trailer as a temporary or permanent residence (Situations that do not comply with this subdivision on the effective date of this chapter are required to conform within one year.); and

(4) (5) Use of a motor vehicle parked on a lot as a structure in which, out of which, or from which any goods are sold or stored, any services are performed, or other business is conducted. (Situation that do not comply with this subdivision on the effective date of this chapter are required to conform within 30 days).

**Section 4.** Unified Development Ordinance § 152.109, "Table of Permissible Uses," is amended so that uses permitted of right ("P"), by a special use permit ("S"), or a conditional use permit ("C") in the Heavy Industrial ("H-I") zoning district are authorized on the same bases as uses in the Light Industrial ("L-I") zoning district. The Table of Permissible Uses, as amended, is shown in the attached Attachment A

**Section 5.** All provisions of any town ordinance or resolution in conflict with this ordinance are repealed.

**Section 6.** If any section, part of a section, paragraph, sentence, clause, phrase, or word of this Ordinance is for any reason held or declared to be unconstitutional, inoperative or void, such holdings shall not affect the remaining portion of this Ordinance and it shall be construed to have been the legislative intent to pass the Ordinance without such unconstitutional, invalid or inoperative part therein, and the remainder of this Ordinance after the exclusion of such part or parts shall be deemed to be held valid as if such part or parts had not been included therein, or if this Ordinance or any of the provisions thereof shall be held inapplicable to any person, group of persons, property, kind of property, circumstances, or set of circumstances, such holdings shall not affect the applicability thereof to any other person, property or circumstances

**Section 7.** This ordinance shall become effective upon adoption.
