### **CONSENT AGENDA**

2. Discussion and possible action on the minutes from the September 3, 2025 Planning and Zoning Commission meeting

**Jerry Fleming moved to approve the meeting minutes. Jan van Bavel seconded the motion. The motion carried with 4 in favor and 0 against.**

Chair Dave Bench thanked Brian Nash for his service on the Planning and Zoning Commission.

### **REGULAR AGENDA**

3. Discussion and possible action to elect a Chair of the Planning and Zoning Commission

Members of the Planning and Zoning Commission spoke in support of Dave Bench to continue serving as Chair.

**Jay van Bavel moved to elect Dave Bench as Chair for the Planning and Zoning Commission. Genie Nyer seconded the motion. The motion carried with 4 in favor and 0 against.**

4. Discussion on an ordinance amending Chapter 107, Section 107-3 and adding Section 107-85 of the Rollingwood Code of Ordinances related to Playhouses and Playscapes

*Tony Stein joined the meeting at 6:05 p.m.*

Chair Dave Bench discussed that he would like to get feedback from the Commission on whether they would like to continue reviewing the playhouse and playscape draft ordinance as City Council voted to not take action on Commission's recommendation at their previous meeting. Mr. Bench gave an overview of the Commission's work on the draft ordinance.

Development Services Manager Nikki Stautzenberger stated that additional amendments will require the draft ordinance to go through the notice procedure again.

City Planner Amanda Padilla further explained that because City Council voted to not take action at their last meeting, Legal recommends that the draft ordinance go through the notice procedure again in order for City Council or the Planning and Zoning Commission to take additional action.

Council Member Brook Brown and the Planning and Zoning Commission discussed the draft ordinance and Legal's recommendation.

City Administrator Alun Thomas explained the notice procedure and associated cost.

The Planning and Zoning Commission discussed the draft ordinance and interest from City Council regarding playhouses and playscapes. City Administrator Alun Thomas explained that there was no appetite from City Council to take action and expressed concern regarding taking action on the draft ordinance without notice to the community. The Commission continued discussion on their recommendations to the draft ordinance, possibly forming an advisory board for playhouses and playscapes, and notice requirements.

Members of the Planning and Zoning Commission continued discussion on their interest in continuing to review playhouses and playscapes.

**Agenda Item:**

Discussion and possible action regarding inconsistencies within Chapter 107 of the Rollingwood Code of Ordinances related to residential fences

**Description:**

At the March 19, 2025, City Council meeting, Section 107-81 was approved to add regulations for residential fence height to the Rollingwood Code of Ordinances. It was later discovered that the Code of Ordinances already contains fence-related regulations in Section 107-34. The existing fence provisions are located in Section 107-34 under Division I, *Generally*, while the newly adopted Section 107-81 is located in Division II, *Residential Zoning District (R)*.

Because fence regulations now appear in multiple sections, both must be referenced to obtain complete information. Guidance is needed on how best to address and resolve these inconsistencies.

**Action Requested:**

Discuss the inconsistencies within Chapter 107 of the Rollingwood Code of Ordinances related to residential fences and provide options for addressing them.
