CALL COMPREHENSIVE RESIDENTIAL CODE REVIEW COMMITTEE MEETING AND PUBLIC WORKSHOP TO ORDER

1. Roll Call

Chair Dave Bench called the meeting to order at 5:02 p.m.

Present Members: Jeff Marx, Alex Robinette, Dave Bench, and Duke Garwood.

PUBLIC COMMENTS

There were no public comments.

2. Discussion and possible action on the minutes from the June 27, 2023 CRCRC meeting

Duke Garwood moved to approve the Consent Agenda. Alex Robinette seconded the motion. The motion carried with 4 in favor and 0 against.

3. Discussion and possible action on emails and letters to the CRCRC from June 23, 2023 to July 27, 2023

Chair Dave Bench mentioned that this item will be a standing item on the agenda. Alex Robinette will update the spreadsheet for the Document Center.

4. Update on City Council action regarding the CRCRC

Chair Dave Bench discussed decisions made by City Council regarding the CRCRC:

- Dave Bench was appointed Chair of the CRCRC,
- City Council will make appointments of members to the CRCRC,
- The CRCRC will make recommendations to City Council for new members, and
- Membership of the CRCRC will increase to seven members.

Mr. Bench asked City Council to suspend some of the Open Meetings Act for the CRCRC to continue to work in subcommittees but be able to work in ad hoc groups as well. City Council will discuss this as an agenda item at their next meeting.

5. Discussion and possible action on number of members of the CRCRC

Alex Robinette moved that the CRCRC membership number increase to seven (7). Duke Garwood seconded the motion. The motion carried with 4 in favor and 0 against.

6. Discussion and possible action on CRCRC membership recommendation to City Council

Chair Dave Bench discussed finding a list of names for CRCRC membership and then tabled this item.

7. Discussion and possible action on the CRCRC survey

Chair Dave Bench began to discuss the survey in its most recent version.

Alex Robinette discussed adding a note that estimates how long the survey takes to complete. She also suggested making a paper version available.

Alex Robinette asked if the survey is anonymous or public and if there is one survey per household or one survey per adult.

Jeff Marx suggested having an administration subcommittee for the survey.

The CRCRC discussed the anonymity of the survey and decided to make it optional for survey participants to provide name.

Jeff Marx suggested tracking the number of survey respondents per household. He asked questions about the administration of the survey to determine options.

The CRCRC discussed eliminating as many "I don't know" and "Need more information" responses as possible.

The CRCRC went through each question of the survey and discussed the timing and administration of the survey.

Alex Robinette agreed to take the edits and create the next draft of the survey.

Amy Pattillo, 3 Rock Way Cove, discussed that Thom Farrell ensured that every resident was handed a postcard regarding the survey.

The CRCRC discussed the logistics and cost of postcards.

Amy Pattillo, 3 Rock Way Cove, requested Question 15 amendments or an additional question regarding a classification of heritage trees, based on diameter, that can't be removed. She also discussed the use of the word "protected" for trees and a possible fund referred to within the ordinance regarding the moving and replanting of trees.

The CRCRC discussed the possibility of allowing survey respondents to rank the issues in terms of importance.

Duke Garwood left the meeting at 6:46 p.m. The CRCRC no longer had quorum, and the meeting was adjourned at 6:48 p.m.

Dear Mayor Massingill and Honorable City Council Members:


I am writing this letter with great sadness. I believe the City of Rollingwood has completely failed in its responsibility to protect my rights as a property owner.

My husband and I built our home in 1978 and we have enjoyed living in this community for 45 years. Our children grew up playing in our front yard and in our neighbors' yards where they were all watched and protected by a community of engaged parents. I honestly cherished our small, protected hometown located inside and adjacent to the mighty metropolis of Austin. Never in all the years we have lived here, did I ever imagine that someone would construct a 3-story building with lots of windows looking down on us effectively destroying our privacy and our property values. I sincerely doubt anyone now would want to purchase our home with this monster structure looming over us. This new building has a tiny front yard, virtually no side yards and no trees. In no way does this structure project the image of a neighborhood home. I won't even begin to address the impact this structure will have on downstream drainage issues. As you should remember, I actually spoke to you in support of the terracing of our neighbors' back yard. I certainly regret that action now; however, I was confident the City of Rollingwood would be providing the oversight required to ensure an appropriate home would be built. How did this happen?

When I served on this city council (from 1987 to 1995) our building codes protected adjacent property owners. Why and when were these setbacks and building heights changed? I have never felt so violated.

Consideration for CRCRC Member Participation

From BUIE Response to RFQ

We recommend moving forward with the (Survey Monkey) Advantage Annual plan, which is \$468 billed annuallyand offers the ability to meet all of the following CRCRC requirements:

- Distribute a survey in digital form that can be pulled from a website or pushed via email.
- Determine how many surveys are received from a single household i.e. an audit trail.
- Support for all of the descriptive information and graphics included in the draft survey.

• Collect respondent data into a common file system, so that an individual's responses stay together and a complete set of answers to the 25 questions can be attributed to a single respondent.

- Manually add information from paper surveys.
- Create basic reporting of the results.

In addition to securing the survey service, Buie & Co. would also perform the following activities:

- Survey review, editing and drafting additional demographic questions 5 hr/\$
- Uploading survey into SurveyMonkey 5 hr/\$
- Project Management 5 hrs/\$ per month (we anticipate 2-3 months for the project)
