Tuesday, May 13, 2025

The Park Commission of the City of Rollingwood, Texas held a meeting, open to the public, in the Municipal Building at 403 Nixon Drive in Rollingwood, Texas on May 13, 2025. Members of the public and the Park Commission were able to participate in the meeting virtually, as long as a quorum of the Park Commission and the presiding officer were physically present at the Municipal Building, in accordance with the Texas Open Meetings Act. A video recording of the meeting was made and will be posted to the City's website and available to the public in accordance with the Texas Public Information Act upon written request.

CALL PARK COMMISSION MEETING TO ORDER

1. Roll Call

Chair Melissa Morrow called the meeting to order at 12:00 p.m.

CONSENT AGENDA

2. Discussion and possible action on the minutes from the April 8, 2025 Park Commission meeting

Mary Elizabeth Cofer moved to approve the meeting minutes. Don Hudson seconded the motion. The motion carried with 5 in favor and 0 against.

REGULAR AGENDA

3. Update and discussion on an Eagle Scout Project

Weston Bain, resident at 400 Vale Street, shared the progress of his eagle scout project to improve the walking trail in Rollingwood Park. He continued to thanked the Park Commission and the Public Works Department for their guidance and assistance. Mr. Bain explained that he raised money throughout his project for supplies and stated that he wishes to donate the excess amount to the park.

The Park Commission complimented Mr. Bain's work and thanked him for his efforts.

4. Update from Western Hills Little League and Western Hills Girls Softball

Steve Franke of Western Hills Little League shared that the softball season will be completed by the end of May as well as requested to be in the discussion for possible improvements to the fieldhouse.

Chair Melissa Morrow moved to item 8.

Discussion and possible action on potential improvements to the parking lot

Chair Melissa Morrow displayed concepts created by Alex Robinette to improve the parking lot and stated that the objective would be to improve safety and create parking spaces while maintaining green spaces. She continued to explain the need for a survey of the park to assist with this effort.

The Park Commission discussed the use of a survey and deliberated areas in the park that should be surveyed.

Alex Robinette discussed the possible use of a landscape architecture plan or architect's plan.

Laurie Mills moved to request City Council to get a survey of the upper park. Victoria Johnson seconded the motion.

City Administrator Alun Thomas confirmed that the City has a civil engineer and that it would likely be more cost efficient to get a surveyor to conduct the survey rather than an engineer.

The Park Commission and continued discussion of areas in the park that should be surveyed.

The motion carried with 5 in favor and 0 against.

6. Update, discussion, and possible action on the Friends of Rollingwood Park Donation Opportunity

The Park Commission asked questions regarding the status of the donation opportunity and previous park donation efforts.

Don Hudson explained the progress made with the donation opportunity and the Park Commission discussed possible ways residents could donate and the Friends of Rollingwood Park verbiage.

7. Discussion and possible action on next steps for the Rollingwood Park Tree Planting Project

This item was not discussed.

8. Discussion and possible action on a recommendation on proposals received for the alternative plan to the retaining wall project

Chair Melissa Morrow gave an overview of the alternative plan to the retaining wall and reviewed the proposals received. The Park Commission provided feedback and inquired about the scope of work outlined in the submitted proposals.

Alex Robinette, resident at 2500 Hatley Drive, explained that she met with Maas Verde Landscape restoration and Gomez Construction Service LLC to allow them to get a full understanding of the project's scope of work. She continued to say that a resident donated boulders for the project and that Gomez Construction Service LLC will use the materials for the project.

Mary Elizabeth Cofer discussed the pricing differences amongst the proposals. Alex Robinette stated that Gomez Construction Service LLC was aware of the boulder donation and removed some of the cost of the materials from the proposal submitted.

City Administrator Alun Thomas expressed concerns about the donated rocks to Gomez Construction LLC and improperly awarding the project due of inconsistencies proposals received.

The Park Commission continued discussion on the donated boulders and Alex Robinette stated that the boulders were not donated to Gomez Construction Service LLC.

Laurie Mills moved to award the bid to Gomez Construction Service LLC. Victoria Johnson seconded the motion.

Mary Elizabeth Cofer expressed concerns about potential preferential treatment related to the donated boulders. Alex Robinette explained that she informed Maas Verde Landscape Restoration as well as Gomez Construction Service LLC about the donated boulders.

The motion carried with 5 in favor and 0 against.

Chair Melissa Morrow moved to item 5.

My Gold Award aims to address this issue:

My Gold Award project will address the issue of decreasing native bat populations in Austin and around the country.

According to the National Parks Service (nps,gov) bats face a variety of different threats in many areas across the country. The devastating disease called white-nose syndrome, windmill turbines, habitat loss, and climate change have caused large numbers of bats to die. The number of safe places for bats to live and forage for food is decreasing.

What can we do? Improving bat habitats is essential for their survival. My Gold Award partner, Bat Conservation International suggests there are many steps people can take to help improve bat habitats:

build appropriate bat houses for roosting, preserve natural habitats, reduce light pollution, avoid pesticides, plant native plants to encourage insects to breed (which is a vital food source for many bat species) and lastly educate the community.

For my Gold project, I've decided to focus on the issue to improving the rapidly decreasing food sources available to bats which causes the decrease of bat populations.

The reason I selected my issue are:

Bats are an integral part of the Austin ecological landscape.

Through research, I have learned that bats need abundant food sources to survive and re-populate.

I've been interested in learning more about bats after living in Austin my whole life.

Root Cause

The root cause of my issue is:

As mentioned before, according to the National Parks Service (nps.gov) bats face a variety of different threats such as the devastating white-nose syndrome disease, windmill turbines, habitat loss and climate change all of which lead to declining bat populations across the world.

Specifically in Austin, the issue of urbanization makes it harder for bats to find shelter and food and as a result their numbers are declining. As our city grows the opportunity to feed in safe green spaces that are attractive to bugs that bats eat decline. Bats mainly eat winged bugs, which not all garden plants attract, so its important for us to build safe green spaces and plant the right plant varieties to help improve the food supply thus helping the bat population to increase.

Declining bat populations are a significant corner, yet community awareness about this issue often falls short. Educating the community about the importance of having a reliable food source for bats can help inspire people to build their own bat garden.

The overall goal of this project is to improve the environment for bats and the Austin Community who I need to reach to improve their knowledge and attitudes surrounding bats and what they can do to help our community.

I will address the root cause by:

First, I plan on developing educational campaigns that will increase my communities awareness of the

struggles bats face in our area due to decreasing food supplies and offer information about how they can help.

- 1. At Rollingwood community events such as the yearly Rollingwood 5k, Easter Egg Hunt and 4th of July park celebrations (and more) I will host a table and provide information regarding how bat gardens can help bats survive as well as how they benefit our environment. I'll point them to where the garden is or will be planted and encourage them to take a look or request their help in volunteering to help support the Rollingwood Education Garden.
- 2. The Rollingwood Educational Garden has agreed to provide funding for signage around the bat garden. The signage will include a QR code that takes visitors to a survey and feedback form. Over time the number of completed surveys can give insights into visitor counts. The survey can also direct visitors to Bat Conservation International's web page about importance of bat gardens and how to build bat gardens in their own back yard.
- 3. I will create an Instagram and NextDoor page that will promote the bat garden to members of the community as well as educate how people could potentially plant their own bat garden in their backyard. Links to Bat Conservation International's website for their newsletters and community events will also be made available. The Rollingwood Facebook page will be updated to include similar posts to reach the Rollingwood audience.
- 4. A bat patch program will be utilized to encourage younger scouts to learn more about native bats in Austin and what they can do to help the bats.

garden (or go on their own) and learn about the positive impact of bats living in our environment The goal is to teach people why we should be concerned about the decreasing bat population and what it means to our community to increase our bat population.

I know that my audience has gained the desired skills and knowledge because I will include a survey during community garden tours to assist with the measurement of their understanding as well as for program improvement. During community events, we will survey those who join the garden tour. We will include a QR code on signage that visitors can use to access more information and stop them with a link to a survey .

Lastly, I will announce the garden on Instagram and Next Door providing information about both the garden as well as links to Bat Conversation International's web page for educational purposes. There too can be a survey "tell us what you think" plus a counter of likes and comments.

Proposed Impact-National and/or Global Link

My Gold Awards's national and/or global link is:

According to Bat Conservation International's web site, bats are an unlikely hero with global impact. With over 1,400 species, bats are the 2nd largest order of mammals and are widely dispersed across 6 continents. Globally, bats provide vital ecosystem services in the form of insect pest consumption, plant pollination and seed dispersal, making them essential to the health of the global ecosystems.

I believe if we all do a small act like building a bat garden, together we can contribute to maintaining healthy ecosystems, which will have a ripple effect on a larger scale.

- 1. To ensure a safe and reliable food source for the Austin bat community through the build of a bat garden to the recommended specifications provided by Bat Conservation International. Once the Rollingwood Community Garden has approved my garden I will be complete with that portion of the project **Completion Date April 15, 2026**
- 2. Community education Events. I plan on participating in City of Rollingwood community events where citizens can join me to observe the bat garden and discuss the purpose of the garden and how they to can start their own garden or volunteer to maintain mine. I will provide hard copy surveys to participants and also ask them to sign up to volunteer - completion date between May 2025 - June 2026
- 3. Community education Social Media. I will introduce / announce to my community the opening of the new bat garden in Rollingwood Park inviting them to come and admire and learn more about the benefits of gardening for bats. I will measure interest through the interactions (likes & comments) left by community members. I will partner with Rollingwood Education Garden to ensure their Facebook page includes information about the new garden, how to build a similar garden and upcoming events promoting the garden. I will also develop both Next Door and Instagram posts that introduce the community to the project and continually post updates, share pictures & videos as well as educational articles regarding bats. - 4. Implementation of a bat patch program for young Girl Scouts. I will provide the Westlake Service Unit the programming and initial patches along with a fun survey girls can fill out at the end of the patch program. **Completion Date May 2026**

Sustaining the Educational Programs

- -Rollingwood Events I will provide the Rollingwood Education Garden with brochures, photos, bat garden instructions and signage (also available through QR codes) to share at all community events to help spread the idea of bat conservation.
- -Bat garden signage Implement a permanent sign in the garden containing a QR code leading visitors to Bat Conservation International's Web pages about bats and the benefit of inviting bats to your yard and gardens.
- -Social media I will turn-over the social media plans to Rollingwood Education Garden so they can continue to promote the bat garden to our communities.
- -Girl Scout patch program will be sustainable through the work of the Westlake Service Unit's Outdoor Quartermaster who will provide the bat patch program ongoing for all young scouts for years to come.

Sustaining The Garden

My plan for maintaining the bat garden and education programs after implementation involves a partnership with the City of Rollingwood's Community Education Garden. The Rollingwood Community Garden has been place for over 10 years and provides resources, tools, water and volunteers who maintain and care several garden plots. My bat garden will be added to this Community Garden in the coming months.

It also requires me to share several key practices involved in bat garden maintenance. These practices are recommended by Bat Conservation International, my advisor, and they are below:

- 1. Regular Monitoring: Inspect the garden periodically. Check for signs of wear, damage, or overgrowth.
- 2. **Monitor** bat activity—observe roosting, feeding, and flight patterns.
- 3. Habitat Maintenance: **Prune** plants as needed to maintain roosting spaces and clear flight paths.
- 4. Replace dead or diseased plants promptly.
- 5. Water Sources: Ensure consistent water availability for both plants and bats.
- 6. Clean and refill water source.
- 7. Insect-Friendly Plants: **Plant native species**that attract insects. Bats rely on these insects for food. **Avoid pesti**


