A RESOLUTION CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE GENERAL ELECTION HELD NOVEMBER 5, 2024, FOR THE PURPOSE OF ELECTING ONE (1) MAYOR AND TWO (2) COUNCIL MEMBERS TO THE CITY COUNCIL OF THE CITY OF ROLLINGWOOD, TEXAS

WHEREAS, under and by virtue of Ordinance No. 2024-07-17-17, duly passed by the City Council of the City of Rollingwood, Texas on July 17, 2024, and thereafter published in accordance with the law, an election (the “General Election”) was held in the City of Rollingwood on November 5, 2024, for the purpose of electing one (1) Mayor and two (2) Council Members; and

WHEREAS, there came to be considered the returns of a general election held on the 5th day of November 2024 for the purpose of electing one (1) Mayor and two (2) Council Members; and

WHEREAS, a copy of the election returns provided by the Travis County Election Clerk for the general election are attached hereto as Exhibit A and incorporated by reference.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF ROLLINGWOOD, TEXAS, SITTING AS THE GOVERNING BODY OF SAID CITY, THAT:

SECTION 1: That the General Election of the City of Rollingwood, Texas held November 5, 2024 was duly called, that notice of such election was given, and that such election was held in accordance with law.

SECTION 2: That the tabulation of votes cast to elect one (1) Mayor and two (2) Council Members in the General Election held on November 5, 2024, made and certified to by the City Secretary of the City of Rollingwood, Texas, be and the same is hereby adopted as the official tabulation filed and recorded in the official records of the City of Rollingwood as the official canvass of said General Election. 92 true and are adopted as findings of fact.

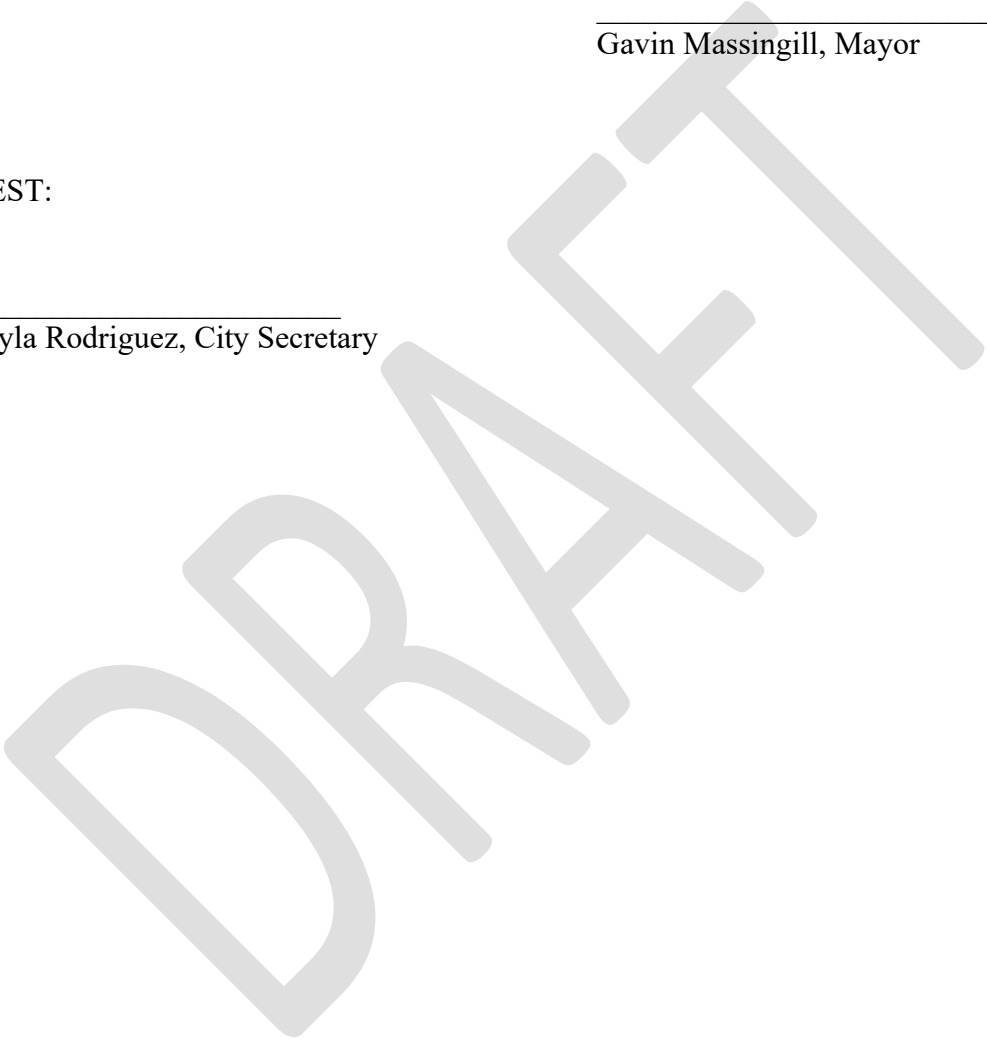
