Nancy Holten, Chicory Ridge Subdivision; stated she started the Chicory Ridge Sales back in 2007, and

she understands the concerns with costs and police presence. Ms. Holten feels the issues is not with the

residents but those that come in to shop the sales. Ms. Holten feels that more tickets should be issued for

those who violate parking and not penalize the residents who are just trying to live their lives and getting

rid of stuff they no longer need. Why can't the police issue more tickets to generate the income?

Heather Lopez, Chicory Ridge Subdivision; Has been a resident for over five years and has never heard

of needing a permit for garage sale. She understands the cost needed for police presence, but can there

be a volunteer instead? The other concern was about the insurance, and most carriers can not write that

kind of policy. Homeowners insurance covers any accidents on private property. This is a fun event with

the neighbors, and not sure why this is an issue. She would appreciate an explanation of why a permit is

needed.

Justin Bieber, Chicory Ridge Subdivision; Mr. Bieber has been resident for over 15 years, he is asking

the board to not charge the residents this cost. He appreciates his neighbors and there are only two

events that bring the neighbors together, the garage sales and Halloween. He has never seen any issues

with traffic or issues with emergency vehicles getting thru during these events. Mr. Bieber would like

the board to reconsider as this event brings many people into the area and helps generate income as well.

PRESIDENT'S REPORT

President Gustafson called on Alan Harbut to provide Police Pension Annual Report.

Annual Report of the **Police Pension Fund**

[Presented by: Alan Harbut]

Alan Harbut provided a brief overview of the Police Pension Fund:

Mr. Harbut provided the board with the annual review of the Police Pension Fund. The fund as

of December 31, 2023, is at \$6,582,018.70 and doing well and stable. Mr. Harbut provide the

board an overview of the fund. President Gustafson acknowledged the ask of contribution of

\$463,429.00 from Mr. Harbut. The meeting was held to discuss the operations of the Roscoe

Police Pension Fund, which was established under Article 3 of the Illinois pension code. The

board consists of two elected police officers, one elected retired police officer, and two civilian

trustees. The board handles various matters including disability claims, retirement requests,

administrative issues, and financial investments. The fund was consolidated into the Illinois police officers Pension Investment Fund in December 2019. The board also discussed funding levels, potential changes, and the possibility of legal action against municipalities that fail to fulfill their fiduciary responsibilities. The training requirements for new trustees joining the Pension Board were also discussed, with a 32-hour training course and a class on the Open Meetings Act being necessary.

3. Appointment and Confirmation of **Roger Needham** to the **Police Pension Board** for the Village of Roscoe, Illinois for a full 2-year term.(Full Term: May 2024 – May 2026).
