

## **Overview/Background Information**

Pietro's applied for and was issued a Class D (on premise beer and wine only) license on January 16, 2024. They are now requesting a change in license classification to Class F (on premise full liquor.)

## **Key Issues**

There are currently 6 Class F licenses.

Jim Shell (Jimez Sports Bar) has surrendered their Class F license as of June 10, 2024. There is no requirement to update the number of Class F licenses unless you do not approve this class change, then the number of Class F licenses should be reduced to 5.

## **Fiscal Note/Budget Impact**

Fee for licenses after July 1<sup>st</sup> are ½ price so the fee for the Class F for the remainder of 2024 would be \$1,500.
