MINUTES

CALL TO ORDER

David Called the meeting was called to order.

INVOCATION

David offered a prayer.

ROLL CALL

Mayor Guy, Commissioners Goode & Steppe, Manager Hanaway.

AGENDA ADOPTION

William made a motion to adopt the agenda as presented. Nick seconded the motion. Passes unanimously.

COMMUNITY FORUM

Gilbert Carmona has two questions regarding activities in Ruthridge. The first is a canine issue with dogs running loose, attacking felines, destroying furniture & cushions. He asks what do we do? Who do they call? What are the best practices or protocols in these situations? Some of these dogs they know where they live, others they do not. Gilbert also asked about trimming of trees at the entrance (left side) of Ruthridge. William shared lack of leash laws in Ruth, he instructed to contact the counties animal control unit. Regarding entrance of Ruthridge, William communicated our landscaper does not handle this overgrowth, it would be the landowner's responsibility. William suggested he contact the property owner and come to a friendly agreement between them. Amie communicated it was Odean Keever's property and she will look on the GIS to see how much was claimed by DOT. Amie shared we will all dig into this issue and get back with him.

Lastly Amie shared for her comfort she would like to start disseminating articles of finance via adobe sign so they can sign off on them.
