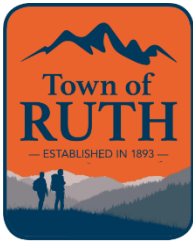

6. Closed Session-David has requested a closed meeting.

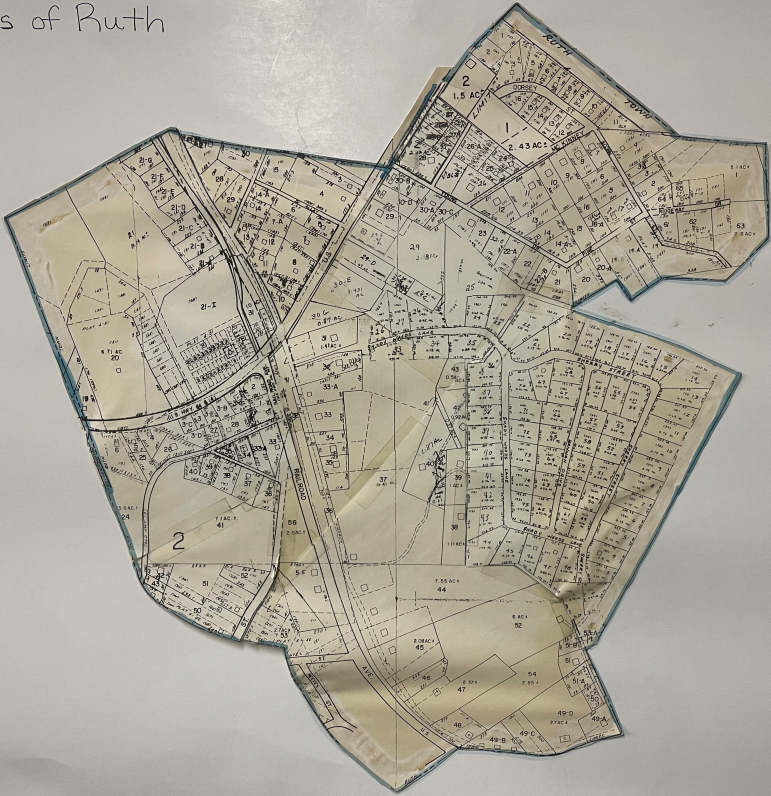
We entered into Closed Session.

Exited Closed session. Nick made a motion to adjourn, Jenny seconded, passes unanimously.

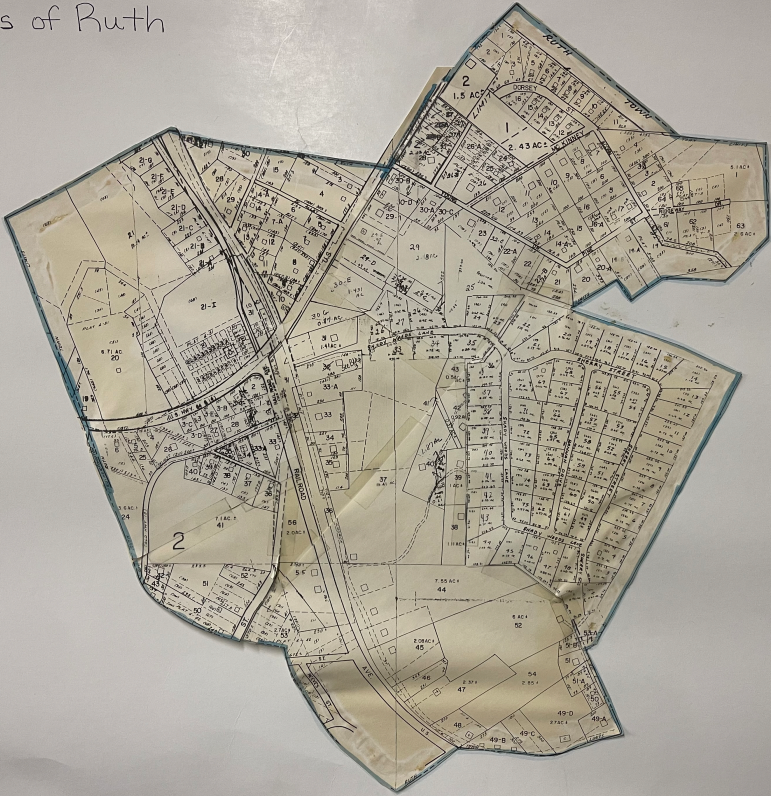
