Resolution 2024-64: A resolution summarizing revenues and expenditures for each fund and adopting a budget for the 2025 calendar year.

BACKGROUND

City Council reviewed a proposed budget at their September 3 worksession and direction was received and updates to the budget were presented at the September 16 worksession. The availability of the budget for public inspection was duly noticed and has been available online and in the finance office since September 3. A public hearing was held on October 1, 2024 and was continued to this October 15, 2024 regular meeting. After the hearing, council will be asked to adopt the 2025 budget and appropriations.

A few final updates have been made to the budget:

- Purchase of land for a LIHTC senior housing project originally planned for 2024 will likely not occur
 until 2025 so funds need to be in the Housing Fund budget for this purpose (\$1.1 million for the land
 and associated professional service work offset with \$750K in grant dollars).
- \$440,000 2024 parks and open space fees-in-lieu funds collected on development projects need to be rolled into the 2025 budget for parks, trails or open space work. Council will be updated on the usage of these funds once a project is identified.
- Various small line-item changes were made as cost changes were identified.

FISCAL NOTE

When this resolution is adopted, it will establish a spending limit of \$38,839,883 out of 9 funds in 2025.

RECOMMENDATION

After holding a budget hearing and giving due consideration to citizen comments, it is recommended that the public hearing be closed, and that Council approve the motion.

MOTION

A City Councilmember should state "I move to approve Resolution # 2024-64 summarizing revenues and expenditures for each fund and adopting a budget for the calendar year beginning on the first day of January 2025 and ending on the last day of December 2025", followed by a second and a roll call vote.

CITY OF SALIDA, COLORADO ORDINANCE NO. 19 (Series of 2024)

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SALIDA, COLORADO AMENDING SECTION 2-8-30 OF THE SALIDA MUNICIPAL CODE CONCERNING THE PLANNING COMMISSION – MEMBERSHIP AND ORGANIZATION

WHEREAS, C.R.S. § 31-15-103 authorizes the City Council of the City of Salida ("Council") to adopt ordinances necessary to provide for the health, safety, and welfare of the City; and

WHEREAS, Chapter 2 of the Salida Municipal Code ("Code") addresses Administration and Personnel, Article 8 addresses the Planning Commission, and Section 30 addresses Membership and Organization; and

WHEREAS, the Planning Commission held a work session on July 22, 2024 and determined that clarification of its attendance policy will benefit the health, safety, and welfare in the City of Salida by establishing clear expectations that a Planning Commissioner is required to attend at least 9 out of 12 regular meetings in a calendar year so matters before it can proceed in a timely manner.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SALIDA, COLORADO, THAT:

- 1) The foregoing recitals are incorporated herein as conclusions, facts, determinations, and findings by Council.
- 2) Section 2-8-30 of the Salida Municipal Code is amended to read in its entirety as follows:
 - (a) The Planning Commission shall consist of seven (7) members and two (2) alternates, each of whom shall maintain his or her primary residency within the City. No person shall be a member of the Planning Commission who is also the Mayor, an active member of the City Council or a full-time employee of the City as defined in the City personnel manual, or who holds any other municipal office.
 - (b) Alternate members to the Planning Commission may attend any Planning Commission meeting and shall have the right to participate in any matter before the Planning Commission, but shall not have the right to vote except as otherwise provided herein. An alternate member of the Planning Commission may be designated to vote on any matter before the Planning Commission in which such alternate member has participated, such designation to be made by the Chairman of the Planning Commission. Such designation of an alternate member to vote may occur only on the

absence or other nonparticipation by a regular member of the Planning Commission. Such designation of an alternate member to vote shall be made on a case-by-case basis and shall not continue beyond those cases for which the designation has been made.

- (c) A person shall take office as a member of the Planning Commission by indicating his or her assent to the appointment in a public fashion. An oath is not necessary, and attending a meeting and voting at the meeting is sufficient to indicate acceptance of the office.
- (d) A quorum for the Planning Commission to transact business shall consist of four (4) members.
- (e) A member of the Planning Commission shall have no more than three (3) absences from regular Planning Commission meetings in a twelve (12) month period.
- 3) Severability. The provisions of this Ordinance are severable and the invalidity of any section, phrase, clause, or portion of this Ordinance as determined by a Court of competent jurisdiction shall not affect the validity or effectiveness of the remainder of the Ordinance.

INTRODUCED ON FIRST READING, on the 1st day of October, 2024, ADOPTED and ORDERED PUBLISHED IN FULL in a newspaper of general circulation in the City of Salida by the City Council on the 1st day of October, 2024, and set for second reading and public hearing on the 15th day of October, 2024.

Administration and Human Resources

- The City Administrator attended the Chaffee County Economic Development Council meeting on October 2. CCEDC is beginning their search for a new Executive Director.
- The City received the final \$75,000 allocation from the Boettcher Foundation for the predevelopment work associated with the Space to Create Workforce Housing Project at 1st and D Streets. The City has received a total of \$250,000 from the Boettcher Foundation.
- Staff continue to finalize the IGA with the Chaffee Housing Authority. Per the Council's direction, the delegate option is included.
- CIRSA completed their on-site audit and inventory on September 19th. The City of Salida has \$470.00 in Loss
 Control Audit credits on the PC Contribution Quotation by ensuring all training and safety protocols are properly
 documented.

Arts and Culture

- SteamPlant As the "busy season" begins to wind down and prior to fall/winter weather, Arts & Culture and Facilities staff assessing facility maintenance needs, such as roof issues and exterior marquee sign. Roof is being addressed immediately, while marquee is decommissioned (lighting and letter "rails" are no longer operational) until budget approvals can provide options to upgrade/replace.
- Events and Engagement Month of September registered the highest number of total events and groups using the venues year-to-date 78 total events (3,712 attendees), 43 groups, 29 free events (978 attendees). Both SteamPlant Theater and Scout Hut used as venues for groups to experience workshops and live theater as part of the Salida Theater Festival. Planning for the upcoming Salida Art Walk (October 10-13) is ongoing with weekend-long schedule of events and programs. New programs added to the annual event strengthening the idea of "art walk," includes F Street closure to accommodate artists and businesses to expand their footprints and a "people-powered" Parade of Arts which will culminate in celebration in Riverside Park.
- **Public Art** Public Art Sculpture "Early Morning Walk" is slated to get installed in October pending local concrete vendors availability. Initial public relations plan being finalized once schedule is confirmed.

City Clerk

- Processed 4 CORA requests. We have processed 68 CORA requests so far in 2024.
- Processed several amplified sound permits for a total of 174 permits issued this year.
- Processing one new liquor licenses, two liquor license transfers, and several Liquor License renewals.
- Processing a transfer of ownership for 1 retail marijuana business and processing one Marijuana license renewal.
- The October Municipal Court has 62 cases.
- Attended the Special Event committee meeting to review the upcoming October and November special events.
- I will be attending the Colorado Municipal Clerks Association (CMCA) conference in Ft. Collins the week of October 22nd

Community Development

• **Building Permits**: Building permits continue to be slightly slower relative to recent years—very likely related to existing higher interest rates but also expectations of interest rates falling in the near future—which has us gearing up for an influx towards the end of the year/beginning of next. Thus far through 10/9/24, we have seen

107 total building permits, including 152 new residential units. At this time in 2023, we had seen 202 total building permits, inc. 132 new residential units. In 2022, we had seen 155 total building permits, inc. 100 new residential units. In 2021, we had seen 202 total building permits, inc. 152 new residential units.

- 1st and D Apartments Project: Artspace has chosen MW Golden, out of Castle Rock, to be the general contractor on the project. MWG will assist with final designs, coordinate cost estimating, and eventually commence construction (estimated early 2025). MWG is currently finalizing a relatively similar affordable workforce housing project (22 rental units) in Frisco called Granite Park.
- CHFA Landbanking Grant: Negotiations continue with property owners to help acquire land on the east side of town for future lower-income senior living apartments and an adjacent public park using \$750K from Prop 123 and CHFA. Additional funds for the acquisition will come from the housing fund and potentially open space fees. Council will hopefully see contracts on the property in the coming weeks.
- APA Colorado 2024 Conference: Bill and Kristen attended the conference held Oct. 2-4 in Loveland. Bill also
 presented a very-well attended session on the South Ark Neighborhood Master Plan process, along with the
 consultants from Studio Seed, as an example of a large project with a multitude of interests and the sausagemaking of consensus and concessions.
- Planning Commission Vacancies: Ads for the 2 Planning Commission vacancies have been inserted into the
 paper, advertised on social media, and posted on flyers around town. The extended announcement closed on
 October 7th and it is expected that interviews will happen sometime in late October with recommendations brought
 to Council in early November.
- New Year's Eve Downtown Celebration: Plans are in the works for a fun downtown New Year's Eve event with a Salida-style "ball drop" this year. Details forthcoming, but we will be encouraging downtown businesses to remain open late that night and perhaps to even host events that will complement the countdown and help ring in the New Year right.

Finance

- Staff and UMB have completed a great financial management tool that will help keep the long term in focus for decision making purposes. Council will review the Financial Management Plan (FMP) at their October 14 work session meeting
- Work on a water and wastewater rate study guided by Ehlers, Inc. is coming to completion and will be brought to council at their November 4 work session
- Typically, a budget amendment is needed by year end to allow for final spending approval on any spending changes made during the year. If one is necessary, council will consider approval at their November 12 regular meeting, amendments require notice and a public hearing.

Fire

- **Fire Department Staffing Update-**Fire Department staffing continues to be a focus for improvement. This year, we've seen two firefighters leave for higher-paying positions, which highlights the ongoing challenge of firefighter retention. To address this, we will soon be conducting interviews for a full-time firefighter position. Additionally, Chief Jonke has implemented changes to the Reserve Firefighter Program aimed at building a stronger pipeline of talent and preparing the next generation of firefighters. This fall, the department is also managing staffing with three firefighters out on injury, further emphasizing the importance of maintaining a robust and well-supported team.
- Driver Operator Training-All of our firefighters recently completed driver operator training and are working
 toward certification through the Colorado Division of Fire Prevention and Control. This training ensures we provide
 the safest and most skilled drivers to serve our community. Half of the training costs were covered through a
 grant, allowing us to enhance our team's abilities while being fiscally responsible. We are committed to
 maintaining the highest standards for safe and effective emergency response.









• New Salida Firehouse Update-Firefighters are extremely grateful for the progress being made on the new firehouse, which will serve as a vital hub for fire safety in our community. Construction is on track, with much of the focus now on finalizing interior details. One of the last major tasks will be pouring the apparatus bay floor, which is scheduled to go last to prevent any potential damage during construction.

In addition to serving as our operational base, the new firehouse will offer training capabilities we haven't had in

the past, further enhancing our ability to develop our skills and improve fire safety across Salida. We look forward to moving into this state-of-the-art facility, which will strengthen our service to the community.











• Collaboration and Mitigation Efforts-The Salida Fire Department is embracing collaboration to address the city's wildfire mitigation needs. We are working closely with Colorado Firecamp, the only school in the United States that exclusively trains wildfire firefighters. Through this partnership, we will be trading housing for Firecamp crews during the first four months of 2025. In return, these crews will be actively mitigating city property, a critical step toward reducing wildfire risk.

This initiative is made possible through our strong relationship with the South Arkansas Fire Protection District, who is also pursuing a grant to support a significant mitigation push in the neighborhoods surrounding Salida. Wildfire has been identified as the most significant risk to Chaffee County, and these efforts will greatly enhance our community's preparedness and resilience.

Wildfire Deployments and Local Fire Risk-Crews from the South Arkansas Fire Protection District have been
actively deployed throughout the summer, rotating in and out to assist with wildfires in several different states.
These wildfire efforts are part of a nationally coordinated response, and we are proud to contribute to protecting
communities across the country, including helping in states effected by the hurricanes.

Closer to home, we are entering the fall dry-up, which significantly increases the risk of wildfires in our own backyard. The dry conditions make fire behavior more extreme, and we strongly advise everyone to exercise extreme caution during this time. Protecting our community starts with awareness and prevention.
