Regarding F Street Plaza Survey Results and Future F Street Uses

BACKGROUND

In 2020, in response to the COVID-19 pandemic, the City of Salida closed F Street, from Sackett to 2nd Street to allow for restaurants and other retail establishments to move some operations outdoors. F Street was closed from approximately Memorial to Labor Day Weekends. In 2021 the street closure was then extended to a half block of F Street between 2nd and 3rd. During the closure, minor improvements to the area were made, including more substantial barricades at the end of each block (painted and some with flowers), additional covered seating in various parking areas, the placement of a community stage in front of Natural Grocers, to name a few.

In early November, a survey was released, which asked a number of questions regarding the amenities available during the closure, the effectiveness of the closure and how often residents and visitors traveled downtown. The responses show a wide cross-section of opinions about the closure. The survey results are attached.

Points for the Council to consider during discussion -


- During the closure, access to downtown buildings by fire or other public safety officers is severely limited. The downtown is the highest risk area for the fire department.
- A full implementation of a permanent pedestrian plaza would cost in the multi-millions of dollars. Currently, the improvement is not reflected in the City's Long Term Financial Management Plan.
- ADA improvements at the corners of F Street and 2nd Street and F Street and 3rd Street are currently in the
 design phase, with completion planned for 2025. Those improvements include expansion of the sidewalks on
 those corners, which could include additional pedestrian space or other amenities meant to slow traffic and
 create a greater sense of safety.
- The community stage can be relocated to Alpine or Marvin Park and be programmed by event organizers in other locations.
- The option for businesses to expand into the parking spots in front of their buildings still exists. These permits are available through the Clerk's Office.
- The City is currently working to improve the wayfinding signage throughout the community, including in the downtown core. This includes additional information about available parking, location to other businesses and access to trails and parks.

Questions before the Council -

- Do you want to continue with the closure of F Street to vehicles during the summer months?
- Are there particular improvements the Council would like to see in the future?


F Street Pedestrian Area User Survey








Primary Residence






Age Breakdown






Gender Breakdown






Downtown Visit Frequency





Top Reasons to Visit Downtown














Dislikes about F Street Closure








Air Quality Affects

Regarding the implementation of a parking program in downtown Salida

BACKGROUND

In 2019, the City hired Walker Consultants to complete a Downtown Parking Study. Key findings included:

- Shortages of parking spots in the concentrated downtown area, attributed to lack of turnover, lack of signage and a general lack of incentive for parkers to find more appropriate parking.
- An unsustainable inventory of off-street parking options, including lots with short-term leases.
- The need for new parking inventory.
- Limited long-term parking options for those who live and work downtown. Currently these users are competing with customers who need parking for shorter durations.

The report recommended the following:

- Sustainable, gradually expanded inventory to accommodate growth by 2025 increase the number of parking spaces to 1,200 (from 820 in 2019 and 964 in 2023)
- Curb management- clarify existing curb markings to identify opportunities to add formal on-street parking in areas where it is stripped for no-parking.
- Paid Parking Define parameters and rate-setting for paid parking in high demand areas.
- Enforcement Enforce parking parameters were appropriate.
- Permit Program Develop and implement a permit program for residents and downtown employees.
- Special Event Planning Develop a suite of mobility options for event organizers to utilize.
- Funding At the time of the study roughly \$200,000 was being spent annually on parking system upkeep, maintenance, lease costs and administration through the General Fund. Currently, lease payments total \$134,817.

Since 2019, several conditions have changed in Salida. COVID-19 led to the closure of F Street to provide a safer outdoor space for residents and visitors (decreasing the number of parking spots downtown by 50+); sales tax increased by 43% between 2019 and 2022, an indication of the increased visitors to our community; and population has increased by 10% over the last five years.

Enforcing the two-hour parking limit in the downtown area has been increasingly difficult to prioritize and less consistent. Community services officers are handling more substantial and complex issues and generally do not have the opportunity to monitor parking downtown. Identifying a solution to meeting these needs is necessary for maintaining consistent parking management.

Currently, several communities in Colorado utilize the private sector for parking management. Interstate Parking (IP) is one company that provides onsite parking management services. Discussions with IP have identified their ability to regulate parking through geofencing an area and using license plate reading technology to regulate and enforce time

management policies. Newer technologies and apps are available to more efficiently offer flexibility with paid parking areas.

Park and Effect Video

IP has identified that parking goals need to be established by a community for an effective program. These goals typically involve establishing capacity of parking areas and the maximum desired time for turning over parking spots. Common goals of other communities have been achieving 90% capacity during peak times which allows for available parking spaces but near capacity. Other goals have included turning over the space approximately every 3 hours. Additional data collection may be necessary to identify data to support parking zone locations and existing capacity.

Implementation of a change in parking regulations would require the City to update signage. This work could be accomplished for a fairly minimal cost to the City. Additional technology related to paid parking would be installed by a third party such as IP.


Staff have begun to identify various parking areas, including paid, time limited and not paid, residential permit parameters, and employee focused. Parking management companies, like IP, have the ability to address the various needs of the community through these varying districts.

Staff is interested in understanding the Council's position on implementing a parking management program and what parameters the Council may wish to see in such a program.

Regarding Second Amendment Demonstrations in City Limits

BACKGROUND

Over the last few years, the Salida Police Department (SPD) has had various calls regarding people openly displaying firearms in our community. These calls have varied in type and have happened all over the City. SPD has been specifically dealing with an individual since early 2021. He and others have stood on the side of Hwy 50 and Hwy 291 most Sundays with an upside-down American Flag and a rifle. This location was utilized until late July of 2023. Towards the end on July, the location moved to 1st and F St., most Sundays from 2 PM - 4 PM with an upside-down American Flag and rifles. While they stand there, they get both positive and negative reactions from people passing by. Because of some of the reactions, they began recording while standing on the corner.

In September, several news articles were posted about one of the individuals downtown. Around that same time, SPD calls to the area began to increase. I put out a press release in early October, and since then, we have had two calls regarding the individuals being downtown.

This conduct, while potentially irritating and scary to some residents, is not criminal. The potential crime that continues to be referenced by the newspaper and residents is Disorderly Conduct pursuant to C.R.S. 18-9-106(1)(f). The crime of disorderly conduct as described in that subsection is, "[a] person commits disorderly conduct if he or she intentionally, knowingly, or recklessly: not being a peace officer, displays a real or simulated firearm, displays any article used or fashioned in a manner to cause a person to reasonably believe that the article is a firearm, or represents verbally or otherwise that he or she is armed with a firearm in a public place in a manner calculated to alarm and does alarm another person."

As was noted in earlier email correspondence about this issue, the mere possession of a firearm in public is not sufficient for SPD to act. While not the main charge litigated in the case, the Colorado Supreme Court recently addressed this issue in 2017 in People v. Naranjo. In that case, the defendant was charged with menacing, a felony offense, and wished to have the jury consider his conduct to be disorderly conduct under the same subsection residents want our police to consider. In reviewing the conduct in that case, the court ruled that there must be some action done with the firearm such as pointing it, brandishing it, or making some kind of threat. Without that conduct, disorderly conduct would "criminalize essentially every instance in which an individual merely handles a gun publicly in another's presence." Such is the case with the individuals currently standing at 1st and F.

Council requested information from the City Attorney as to what their legal options are to address the current situation. According to the City Attorney's Office, there are no immediate actions that can be taken without violating 1st and 2nd Amendment rights.

However, while Colorado is an open carry state, the legislature has also recognized that even though people do have the right to bear arms, there are times when regulation should be allowed. It also noted that officials of local governments are "uniquely equipped to make determinations as to regulations necessary in their local jurisdictions." To

that end, C.R.S. 29-11.7-103 allows local governments to enact ordinances or other laws governing or prohibiting the sale, purchase, transfer, or possession of a firearm within their limits so long as it does not conflict with state and federal law. There are several municipalities that have enacted ordinances that restrict the carrying, both open and concealed, of firearms within their boundaries. Denver, for example, has an ordinance that makes it unlawful for any person to conceal or openly wear, carry, or transport any weapon on or about their person or vehicle. There are exceptions to the ban that allow the ban to comply with state laws, however. Denver also has a specific ban on assault weapons in a separate ordinance. When Denver first passed these ordinances, they were sued, and the Colorado Supreme Court upheld the ban finding that the local interest in regulating firearms outweighed the state interest.

Other municipalities have also taken these steps to varying degrees. Glenwood Springs passed an ordinance that makes it unlawful for any person to possess a firearm in any public building or other public places where signs are posted prohibiting the open carrying of firearms. Similarly, Boulder has an ordinance that prohibits the possession of firearms in sensitive areas that applies to openly carried and concealed weapons. Silverthorne prohibits open carry of firearms, but places limitations on specific places in town where the ban applies. They also note in their ordinance that signs are to be posted notifying people of the prohibition. Silverthorne also allows the Chief of Police to grant permission for open carry in specific instances. Similarly, Crested Butte prohibits open carrying of firearms and lists within the ordinance the specific places to which the ordinance applies. Lafayette has a couple different prohibitions on carrying guns. There is one ordinance that prohibits open and concealed carrying of firearms on all city owned property, including outdoor areas, at all public parks and playgrounds, and on the outdoor premises of any city-owned/managed/operated rec center, community center, golf course, or aquatic center. They also created a general prohibition on the open carrying of firearms in public places.

The state statute gives the city a large amount of discretion to determine what is best for the residents and for the community as a whole. There is a wide range of restrictions that can be put in place.

Enforcement would be an issue. Per Salida Municipal Code only fines are allowed, and no imprisonment could be ordered. Currently, the Municipal judge is on the more lenient side so it would likely take many violations to have real penalty. Citizens and visitors must be on notice of the ban in order for it to be enforceable if the ordinance regulates specific places. SPD would have to determine how to prioritize enforcement of these ordinance, not an easy task given the variety of other calls they are responding to.

Outdoor Community Pool special subcommittee of the PROST guidance.

BACKGROUND
